## VI. Form of attestation of applicants of higher education

Forms of attestation of applicants of higher education	Attestation of applicants is carried out in the form of a public defense (demonstration) of qualifying work, an exam.
Requirements for qualifying work	Qualification work should involve solving a complex task or problem in the field of international economic relations, which requires research and/or innovation and is characterized by uncertainty of conditions and requirements. The qualifying work should not contain academic plagiarism, fabrication, or falsification. The qualification work must be published on the official website of the institution of higher education or its subdivision, or in the repository of the institution of higher education. Publication of qualification works containing information with limited access shall be carried out in accordance with the requirements of current legislation.

### VII. Requirements for the presence of an internal support system quality of higher education
