Rules for preparation of abstracts or reports:

1. The volume of the original articles, abstracts and short reports should be 1-5 pages.
2. A text must be submitted in the Microsoft Word format. The file name must match the surname of the first author. All material (text, figures, charts, diagrams, tables, etc.) must be submitted in one file.
3. Setup text margins at all sides 20 mm, font Times New Roman, size 14, spacing 1.5. References must be indicated in the text in square brackets according to appearance of sources.

Scheme of writing abstracts or reports:

- UDC (in the upper right corner);
- author (s) (first and last name, academic degree, academic title, place of employment, in the center of page);
- title (in the center of page, in capital letters, in bold);
- abstract language articles and working languages of the conference (up to 100 words);
- keywords language articles and working languages of the conference (3-10 words);
- problem definition and its relationship with important scientific and practical tasks;
- analysis of recent research and publications in the subject, the selection unsolved aspects of the problem, which is subject of article matter;
- purpose of the research;
- the main research material and explanation of scientific results;
- conclusions from the study and challenges in this research area;
- literature, according to requirements of JAMA citation style;
