#### ORDER ADMISSION TO THE INTERNATIONAL HUMANITARIAN UNIVERSITY IN 2022

#### I. Terms

Educational activities at the International Humanitarian University are carried out in accordance with the license of the Ministry of Education and Science of Ukraine (Order of the Ministry of Education and Culture dated 03.04.2021 No. 26-1 VO).

The admission procedure was developed by the Admissions Committee of the International Humanitarian University (hereinafter referred to as the Admissions Committee) in accordance with the Procedure for Admission to Higher Education Institutions in 2022 (hereinafter referred to as the Admission Procedure), approved by the Order of the Ministry of Education and Science of Ukraine on April 27, 2022 No. 392 (with changes introduced by the order of the Ministry of Education and Science of Ukraine dated May 2, 2022 No. 400)

In this Order, the terms are used in the following meanings:

targeted placement of budget places - providing the entrant with a recommendation for enrollment in places of study at the expense of the state or local budget (according to the state or regional order) based on his competitive score;

open competitive offer - a competitive offer for which the number of places for training under a state order is determined during the address placement of budget places within the limits between the minimum qualification and the maximum volume of the state order or is equal to zero in the case of the impossibility of forming the qualification minimum of the state order;

entrance test - assessment of the entrant's readiness to obtain higher education, conducted in the form of an entrance exam for foreigners, an individual oral interview, a master's comprehensive test, a master's test of educational competence, a national multi-subject test, a creative competition, a presentation of research proposals or achievements, a professional exam;

entrance exam for foreigners – a form of entrance test that involves assessing the knowledge, abilities and skills of the entrant in one or more competitive subjects, the results of which are included in the entrant's competitive score, or based on the results of which the entrant is not allowed to participate in the competitive selection or other entrance tests (grades are given

on a scale of 100-200(in increments of one point) or a decision is made on the applicant's negative assessment ("unsatisfactory"));

entrant - a person who has submitted an application(s) for admission to participate in the competitive selection for one (several) competitive offers;

an individual oral interview is a form of entrance examination, which involves an in-person assessment of the applicant's preparedness (assessment of knowledge, skills and abilities) in one, two or three subjects (components), based on the results of which grades are assigned for each subject (component) on a scale of 100-200 ( in increments of one point) or a decision is made on the entrant's negative assessment ("unsatisfactory");

qualification minimum of a state order - the minimum number of entrants that can be recommended for an open competitive offer during the targeted allocation of budget places for opening a recruitment for it (only for specialties that are included in the List of specialties that are provided with special support);

the quota for foreigners is a specified part of the volume of budget places, which is used to admit entrants from among:

foreigners who come to study in accordance with international treaties of Ukraine;

Ukrainians abroad, whose status is certified by a certificate of a foreign Ukrainian and who do not permanently reside in Ukraine;

quota-1 - a defined part of the maximum amount of budget places (for open tenders) or the total amount of budget places (for fixed tenders), which can be used for the admission of entrants on the basis of complete general secondary education, who have the right to enter on the basis of individual oral interview (except for persons entitled to quota-2), and orphans, children deprived of parental care, persons from among them,

quota-2 – a defined part of the maximum amount of budget places (for open competitive offers) or the total amount of budget places (for fixed competitive offers) in higher education institutions, which can be used to admit entrants on the basis of complete general secondary education, who have the right to admission in accordance with the Admission Procedure for obtaining higher, professional pre-higher and professional (vocational and technical) education of persons living in the temporarily occupied territory of the Autonomous Republic of Crimea and the city of Sevastopol, the temporarily occupied territory of certain districts of Donetsk and Luhansk regions, the territory of settlements on the contact line , approved by order No. 271 of the Ministry of Education and Science of Ukraine dated March 1, 2021, registered in the Ministry of Justice of Ukraine on April 15, 2021 under No. 505/36127 (hereinafter - order No. 271);

competitive proposal - the proposal of the International Humanitarian University regarding the number of places for admission to a certain level of higher education, educational program (educational programs), form of obtaining education, course, the list of competitive subjects and creative competitions, the term of study based on the obtained educational level or degree (educational and qualification level). There are open, fixed and non-budget tender offers. Open competitive offers are part of a broad competitive offer.

competitive mark - complex rating achievements entrant, which is calculated based on the results of entrance tests and other competitive indicators with an accuracy of 0.001 in accordance with the Procedure and these Admission Rules; competitive selection - the procedure for selecting entrants for competitive offers

on the basis of competitive points and (if they are used) priorities of applicants' applications and/or consideration of motivation letters in the cases established by this Procedure for obtaining higher education (on a competitive basis);

competitive subject - a subject (discipline), the level of academic achievements of which is taken into account during the competitive selection for study at a higher education institution;

master's complex test - a form of entrance test for admission to study for a master's degree on the basis of a bachelor's degree, a master's degree (educational and qualification level of a specialist), which involves assessing the level of preparation of the entrant in a foreign language and law, which is carried out by the Ukrainian Center for Quality Assessment education in accordance with legislation;

master's test of educational competence - a form of entrance test for admission to study for a master's degree on the basis of a higher bachelor's degree obtained, which provides for the assessment of the applicant's readiness to master the master's level educational program, which is carried out by the Ukrainian Center for the Assessment of the Quality of Education in accordance with the legislation;

the maximum volume of the state order - the maximum number of entrants to the open competitive offer that can be recommended for admission to the places of the state order;

letter of motivation - written by the entrant in an arbitrary form, information about his personal interest in entering a certain educational program (specialty, educational institution) and corresponding expectations, achievements in education and other types of activities, his own strengths and weaknesses, to which, if necessary, the entrant materials confirming the information contained in the letter may be added (including in electronic form);

national multi-subject test -a form of entrance test that provides for the evaluation of the results of studies in the Ukrainian language, mathematics and history of Ukraine, which is carried out by the Ukrainian Center for the Evaluation of the Quality of Education in accordance with the legislation;

non-budget tender offer - a tender offer for which study places are not provided at the expense of the state or local budget (by state or regional order); the right to enroll according to quotas - the right of an entrant to study at the International Humanitarian University according to quota-1, quota-2, quota for foreigners, implemented in accordance with this Procedure;

presentation of research proposals or achievements - a form of entrance test that can be prescribed during admission to obtain the educational degree of Doctor of Philosophy, which consists in listening and discussing the scientific report of the entrant;

priority - the sequence determined by the entrant during application submission (where

1 is the highest priority) their consideration in the case of targeted allocation of budget places; a higher education institution in the Admission Rules may provide for the establishment of local priorities for admission on the basis of a previously obtained educational degree or educational qualification level;

ranked list of entrants – a list of entrants in the order of admission to study for a competitive offer, which is formed in accordance with this Procedure and Admission Rules;

a creative competition is a form of entrance test for admission to the universitya junior bachelor's degree, a bachelor's degree based on a complete general secondary education, which provides for face-to-face or distance (if the applicant can choose) examination within one day and assessment, no later than the next day, of the applicant's creative and/or physical abilities (in particular, previously acquired specialized education), necessary for obtaining higher education in the specialties specified in Appendix 4 to this Procedure. According to the results of the creative competition, a positive assessment is given on a scale of 100-200 (in increments of one point) or a decision is made to assess the entrant's achievements negatively ("unsatisfactory");

technical error - an error made by an authorized person of the admissions commission for the acceptance and consideration of applications when entering information about the entrant or application to the Unified State Electronic Database on Education (hereinafter - EDEBO), which is confirmed by the act on the technical error;

professional exam - a form of entrance test for admission on the basis of the obtained (or such that is obtained) degree or educational qualification level of higher education, which provides face-to-face or remote (at the option of the entrant) verification of the ability to master an educational program of a certain level of higher education on the basis of the obtained before competences;

fixed competitive offer – a competitive offer with a pre-determined number of places for training at the expense of the state or local budget (by state or regional order);

broad competitive offer - a set of open competitive offers, which constitutes a joint offer by state institutions of higher education of the total amount (super-volume) of budget places for accepting entrants to study places with the funds of the state budget (by state order) for a certain branch, specialty (specialization) and form of acquisition

education An open competitive offer can be included in only one broad competitive offer.

The term "Ukrainians abroad" is used in the meaning given in the Law of Ukraine "On Ukrainians Abroad".

Other terms are used in the meanings given in the Law of Ukraine "On Higher Education".

#### II. Admission to study for higher education

1. To obtain higher education, the following are accepted:

persons who have completed general secondary education or the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor - for obtaining the degree of junior bachelor, bachelor, as well as master's degree in pharmaceutical and veterinary fields;

persons who have obtained a complete general secondary education or the educational qualification level of a junior specialist, an educational and professional junior bachelor's degree, a junior bachelor's educational degree in the relevant specialty of the medical field, for obtaining a master's degree in the medical field;

persons who have obtained a bachelor's degree, a master's degree (educational and qualification level of a specialist), - to obtain a master's degree;

persons who have obtained a master's degree (educational and qualification level of a specialist) - to obtain a doctor of philosophy degree.

The list of medical, pharmaceutical, and veterinary majors for which admission to a master's degree can be made on the basis of a complete general secondary education and the educational and qualification level of a junior specialist, educational and professional professional junior bachelor's degree, junior bachelor's educational degree is given in Appendix 1 to of this Order. The International Humanitarian University offers admissions for studies in specialties 226 "Pharmacy, industrial pharmacy":

entrants on the basis of complete general secondary education and the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor for obtaining the degrees of junior bachelor, bachelor (only in specialty 226 "Pharmacy, industrial pharmacy"), master's degree;

entrants on the basis of a bachelor's degree to obtain a master's degree.

To obtain a master's degree in the specialty 081 "Law", persons who obtained a bachelor's degree in the specialty 081 "Law" or 293

"International law", areas 6.030401 "Jurisprudence", 6.030202 "International law".

To obtain the degree of Doctor of Philosophy in the fields of knowledge 22 "Health care" accepts persons who have obtained a master's degree (educational and qualification level of a specialist) in the specialties of the relevant field of knowledge.

Persons who have previously obtained the same or a higher degree (level) of higher education or have been obtaining it for at least one year and who complete an individual educational plan are also accepted for obtaining a degree of higher education in another specialty. A condition for enrolling a student of higher education for simultaneous study in another specialty in the same or in another institution of higher education is the fulfillment of requirements similar to the fulfillment of requirements for entrants to the relevant educational programs. These requirements can be fulfilled during the first year of study.

2. Entrants are admitted to study for the first year. For persons who have obtained the educational and qualification level of a junior specialist, educational and professional degree of a professional junior bachelor, educational degree of a junior bachelor, a higher education institution can transfer ECTS credits, the maximum amount of which is determined by the standard of higher education of a bachelor (master of medical, pharmaceutical, veterinary fields) ( in the absence of a standard - no more than 120 ECTS credits). Such persons may be admitted to the second (senior) course(s) or to the first course (with a shortened period of study). In order to obtain a junior bachelor's degree, a bachelor's degree (master's degree in medicine, pharmacy or veterinary fields) in another specialty, individuals can be admitted to the first or senior courses (in particular, with a shortened period of study).

Applicants of higher education at the educational and qualification level of a specialist on the basis of complete general secondary education or the educational and qualification level of a junior specialist in medical, pharmaceutical or veterinary fields, who were withdrawn or interrupted their studies in connection with an academic leave, have the right to be reinstated to continue their studies for obtaining a master's degree on the basis of a complete general secondary education or the educational and qualification level of a junior specialist in the same or a related specialty within the field of knowledge in the same or in another institution of higher education.

3. Admission to study is carried out on competitive offers for specialties (specializations, subject specialties) in accordance with the List of fields of knowledge and specialties for which higher education candidates are trained, approved by Resolution No. 266 of the Cabinet of Ministers of Ukraine dated April 29, 2015, and for interdisciplinary educational (educational scientific)

programs that meet the Requirements for interdisciplinary educational (scientific) programs, approved by the order of the Ministry of Education and Science of Ukraine dated February 1, 2021 No. 128 "On approval of the Requirements for interdisciplinary educational (scientific) programs", registered in the Ministry of Justice of Ukraine on April 6, 2021. under No. 454/36076.

4. Peculiarities of admission to study for higher education of persons whose place of residence is temporarily occupied territory, the territory of settlements on the contact line or who moved from such territories after January 1, 2022, in terms of passing the annual assessment and state final certification, obtaining a state model document on complete general secondary education (if the person did not receive a document on education in accordance with the legislation), are determined in accordance withAdmission procedure for obtaining higher, professional pre-higher and professional (vocational and technical) education of persons, who live on temporarily occupied territory of the Autonomous Republic of Crimea and the city of Sevastopol, the temporarily occupied territory of certain districts Donetsk and Luhansk regions, territories of settlements on the line collision, approved by order No. 271 of the Ministry of Education and Science of Ukraine dated March 1, 2021, registered in the Ministry of Justice of Ukraine on April 15, 2021 under No. 505/36127 (hereinafter - order No. 271).

#### **III.** Sources of funding for higher education

1. Financing of training of higher education applicants is carried out:

at the expense of state budget expenditures at the International Humanitarian University (state order) and at the expense of local budget expenditures (regional order);

for the funds of individuals and/or legal entities (on the terms of the contract).

2. Citizens of Ukraine have the right to obtain higher education free of charge on a competitive basis in accordance with the standards of higher education, if a citizen obtains a certain degree of higher education for the first time with funds from the state or local budget, as well as through open competitive offers.

Persons who obtained the educational and qualification level of a specialist at the expense of the state or local budget (by state or regional order) may obtain a master's degree only at the expense of individuals and/or legal entities, except for the cases provided for in clause 5 of this section.

3. A person can apply for a master's degree on the basis of a bachelor's degree, a master's degree and the educational and qualification level of a specialist obtained in another specialty (field of training) (taking into account the requirements of paragraph nine, point 1 of section II of this Procedure), provided he successfully passes the entrance exams . Education is financed from state and local budgets (by state or regional order).

within the term of study according to the curriculum of the relevant educational program, which is determined on the basis of one academic year for 60 ECTS credits.

Persons applying for a bachelor's degree (master's degree in veterinary field) based on the educational and qualification level of a junior specialist, educational and professional degree of a professional junior bachelor, educational degree of a junior bachelor can enroll in the first course with a shortened term of study only by state (regional) order in the case of admission to the same or related specialty within the field of knowledge, as well as to the specialty specified in the List of specialties to which special support is provided (Appendix 2).

Persons entering for a degreebachelor's degree (master's degree in medicine, pharmacy or veterinary field) on the basis of the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor, can be enrolled at the expense of individuals and/or legal entities for the first year with a shortened period of study or for the second or senior courses with a standard period of study within the limits of the license volume or the maximum volume established for the competitive offer.

4. Citizens of Ukraine who have not completed their education at the expense of the state orof the local budget (by state or regional order) for a certain level of higher education, have the right to re-enroll for free higher education at the same level of education, subject to reimbursement to the state or local budget of the funds spent on paying for specialist training services, in accordance with the Procedure reimbursement of funds from the state or local budget spent on the payment of specialist training services, approved by the resolution of the Cabinet of Ministers of Ukraine dated August 26, 2015

No. 658. This requirement does not apply to combatants.

Admission to study for a master's degree in medical, pharmaceutical, or veterinary fields based on a complete general secondary education or the educational qualification level of a junior specialist, an educational-professional degree of a professional junior bachelor, an educational degree of a junior bachelor is considered admission simultaneously for obtaining a bachelor's and a master's degree in accordance with paragraph 1 of section II of this Procedure.

5. Citizens of Ukraine have the right to obtain a higher education free of charge in a second specialty:

if, due to their state of health, they have lost the opportunity to perform official or official duties according to the previously obtained qualification, which is confirmed by the conclusions of the medical and social expert commission, and in other cases provided for by law; if they have a referral for training issued by the state (regional) customer in accordance with the legislation.

6. Foreigners and stateless persons, in particular, Ukrainians living abroad permanently in Ukraine, persons recognized as refugees, and persons in need of additional protection have the right to obtain higher education on an equal basis with citizens of Ukraine, in particular at the expense of state or local budget funds.

7. Persons studying in institutions of higher education have the right to study at the same time in several educational programs, as well as in several institutions of higher education.

Simultaneous education in two or more specialties (specializations, subject specialties, educational programs, levels, degrees, forms of education) at the expense of state or local budgets is not allowed, except in cases of combining fields of knowledge, specialties, specializations (subject specialties) in one educational program, or obtaining a master's degree in medical, pharmaceutical or veterinary fields on the basis of a complete general secondary education (educational and qualification level of a junior specialist, educational and professional degree of a professional junior bachelor, educational degree of a junior bachelor), which is considered a simultaneous acquisition of bachelor's and master's degrees.

8. Entrants are admitted to competitive selection for state (regional) order positions and may be recommended or transferred to such positions if they have a competitive score of at least 125,000. The restriction on the transfer to vacant positions of the state (regional) order does not apply to the persons specified in Clause 7 of Chapter VIII of this Procedure.

9. Admission to study of entrants in specialties 081 "Law" and 293 "International law" by state or regional order for obtaining a junior bachelor's degree by all forms of education, as well as for obtaining bachelor's and master's degrees by correspondence form of education in 2022 is not conducted.

#### IV. ADMISSION VOLUMES AND STATE (REGIONAL) ORDER VOLUMES

1. Admission to training is carried out within the licensed volume for a certain level of higher education or for a certain educational program, which provides for the assignment of professional qualifications for professions for which additional regulation has been introduced.

Admission to study in interdisciplinary educational (educational and scientific) programs is carried out within the licensed volume for a certain level of higher education. Admission to study under a state (regional) order for interdisciplinary educational programs of the initial level (short cycle) of higher education in a group of two specialties belonging to one or two fields of knowledge is carried out in one of these specialties at the choice of the institution of higher education. Admission to study for non-budgetary competitive offers for other interdisciplinary educational programs of the initial level (short cycle) of higher education is carried out for one of their specialties (specialties of one of their fields of knowledge) at the choice of a higher education institution, for admission to which an entrance test is provided in the form of a national multi-subject test or creative competition (for one of the specialties chosen by the higher education institution, if the national multi-subject test or creative competition is provided for both specialties or not provided for any of them). Admission to study in interdisciplinary educational and scientific programs of the second (master's) level of higher education is carried out at the one of them, for admission to which an entrance test is provided in the form of a master's test of educational competence (for one of the specialties chosen by the institution of higher education, if the master's test of educational competence is provided for both specialties or not provided for any of them).

2. Admission to studies by state order (with funds from the state budget) is carried out in the specialty and forms of obtaining higher education, according to which it is formed by the Cabinet of Ministers of Ukraine. The Ministry of Education and Science of Ukraine, other state customers determine from individual specialties the lists of subject specialties and specializations, according to which the formation and placement of the state order are carried out, in accordance with the List of orders of state customers, which determine the subject specialties and specializations of individual specialties, according to which the formation and placement are carried out which the formation and placement are carried out state order (Appendix 3). Higher education institutions that have obtained a license to carry out educational activities at a certain level of higher education and/or according to a certain educational program, which provides for the assignment of professional qualifications in professions, can carry out admissions for studies at the expense of the state and local budgets (by state and regional order). for which additional regulation is introduced no later than December 31, 2021, at the expense of individuals and/or legal entities - no later than May 31, 2022.

In territorially separated structural subdivisions, there is no admission for training at the expense of the state budget (by state order) for the training of specialists:

at the second (master's) and third (educational-scientific/educational-creative) levels of higher education;

from specialties for which a state-owned higher education institution providing training in the same specialty operates in the same city or within a radius of 50 kilometers from it.

Admission to studies by regional order is carried out in specialties (subject specialties, specializations, interdisciplinary educational programs) and forms of obtaining higher education, according to which it is provided by the regional customer for each institution of higher education.

3. The scope of admission under a state order based on complete general secondary education is determined in general for all executors of the state order, except for higher military educational institutions, higher education institutions with specific learning conditions, military educational units of higher education institutions, separately by forms of education:

The distribution of the state order for the training of masters in institutions of higher education in the sphere of administration of the Ministry of Education and Science of Ukraine (except for specialties 081 "Law" and 293 "International law") is carried out using the Criteria for the competitive selection of executors of the state order for the training of masters in institutions of higher education, which belong to the sphere of management of the Ministry of Education and Science of Ukraine, approved by the order of the Ministry of Education and Science of Ukraine dated May 3, 2018 No. 445, registered in the Ministry of Justice of Ukraine on May 24, 2018 under No. 625/32077, taking into account the following features: for the integral criterion of the quality of personnel support , quality of education and international recognition, data published before January 1, 2022 are taken into account; the K4 coefficient for relevant institutions of higher education is equal to the regional coefficient provided for in this Order; the criterion for the number of foreign students is calculated as of December 1, 2021.

The distribution of the state order for the training of bachelors (masters in veterinary field) on the basis of the obtained educational and qualification level of a junior specialist, educational and professional degree of a professional junior bachelor, educational degree of a junior bachelor in institutions of higher education between competitive offers of institutions of higher education is carried out by means of targeted allocation of budgetary places.

In all other cases, the distribution of the volume of admission under state and regional orders between institutions of higher education is carried out by state (regional) customers by specialties (subject specialties, specializations) and forms of education, and its distribution between fixed competitive offers is carried out by institutions of higher education independently, unless otherwise not determined by the state (regional) customer.

4. Addressed placement of the state order is carried out according to a single tender from all state customers for forms of obtaining higher education in stateowned higher education institutions, regardless of the sphere of management (except for higher military educational institutions, higher education institutions with specific learning conditions, military educational units of higher education institutions) and private form of ownership to obtain:

a junior bachelor's degree based on a complete general secondary education;

bachelor's degree (master's degree in medical, pharmaceutical and veterinary fields) based on a complete general secondary education;

bachelor's degree (master's degree in veterinary field) based on the obtained educational and qualification level of junior specialist, educational and professional degree of specialized junior bachelor, educational degree of junior bachelor;

master's degree based on the obtained bachelor's degree in specialties 081 "Law" and 293 "International Law".

The volume of admission by state order on the basis of complete general secondary education in specializations 014.026 "Hungarian language and literature", 014.027 "Romanian/Moldavian language and literature", 014.028 "Polish language and literature" subject specialty 014.02 "Secondary education. "Architecture and construction" is determined by state customers for each higher education institution and each form of higher education, and higher education institutions carry out its distribution among fixed tender offers independently.

6. The volume of acceptance at the expense of individuals and/or legal entities for fixed and open competitive offers is determined by the institution of higher education within the limits of the difference between the licensed volume and the total volume of the state or regional order, if necessary, by the reserve provided for renewal in it or transfer to it from other institutions of higher education to obtain higher education of the corresponding level or according to the corresponding educational program. This volume can be adjusted taking into account the actually received state (regional) order and in cases of allocation of additional places of the state (regional) order, transfer to vacant places of the state (regional) order and redistribution of places between forms of education, but cannot be reduced for a competitive offer in the period between the start of accepting documents and applications and the formation of the first list of those recommended under this proposal.

The volume of acceptance for a non-budget tender offer is determined by the institution of higher education within the limits of the licensed volume for a certain level of higher education or

for certain educational programs, what provides appropriation

professional qualifications for professions for which additional regulation has been introduced.

7. The total amount of budget places for fixed competitive offers, the maximum amount of budget places and the qualifying minimum state order for open competitive offers, the amount of quota-1, quota-2, quotas for foreigners for fixed and open competitive offers, the amount of admission for the funds of individuals and/or legal entities for open and fixed competitive offers, the scope of acceptance for non-budget competitive offers are published on the official website of the higher education institution and are defined in the Admission Rules (after receiving the necessary information from the state (regional) customer).

8. In accordance with paragraph 30 of the Procedure for improving the qualifications of teaching and research-pedagogical workers, approved by Resolution No. 800 of the Cabinet of Ministers of Ukraine dated August 21, 2019, institutions of higher education that train candidates under state (regional) orders may provide referrals for studies under state ( regional) by order to pedagogical (scientific and pedagogical) employees of educational institutions and scientific and methodical institutions in the correspondence or evening form of obtaining education within the vacant places of the relevant specialty (specialization) and course (year of study), except for the first, in the event that there are no higher education graduates education, which are studied at the expense of natural (legal) persons and have the right to be transferred to places of state (regional) order in accordance with the legislation.

6. The procedure for registering applicants for the national multi-subject test, master's test of educational competence or master's comprehensive test, their organization and conduct is determined by the Ministry of Education and Science of Ukraine.

The test tasks of the national multi-subject test are compiled in accordance with the programs of external independent evaluation of the relevant subjects (in accordance with the program of external independent evaluation of the results of studies in Ukrainian language and literature obtained on the basis of full general secondary education, approved by the order of the Ministry of Education and Science of Ukraine dated June 26, 2018 No. 696 (part "Ukrainian language"), to the program of external independent evaluation of the results of studies in the history of Ukraine, obtained on the basis of full general secondary education, approved by order of the Ministry of Education and Science of Ukraine dated June 26, 2018 No. 696 (chapters 20–32: 1914 year - the beginning of the 21st century), mathematics (in accordance with the program of external independent assessment of the results of learning in mathematics, obtained on the basis of full general secondary education, approved by the order of the Ministry of Education and Science of Ukraine dated June 26, 2018 No. 696 (chapters 20–32: 1914 year - the beginning of the 21st century), mathematics (in accordance with the program of external independent assessment of the results of learning in mathematics, obtained on the basis of full general secondary education, approved by the order of the Ministry of Education and Science of Ukraine dated December 4, 2019 No. 1513);.

7. Enrollment for the funds of individuals and/or legal entities ends no later than November 30. Registration and the work of electronic offices of entrants ends on October 31.

## VI. The procedure for accepting applications and documents for participation in the competitive selection for obtaining higher education at the International Humanitarian

#### university

1. Entrants to study for higher education submit applications: only in electronic form, except for the cases specified in this paragraph; only in paper form:

to exercise the right to admission through an individual oral interview (in the event that the applicant does not have at least one of the 2019-2021 ZNO certificates or scores of the national multi-subject test) in accordance with this Procedure;

to exercise the right to repeated free education with budget funds in accordance with this Procedure;

in the event of discrepancies in the data of the entrant to EDEBO (surname, first name, patronymic (if available), date of birth, gender, citizenship, etc.) and in the relevant document on previously acquired education and in the database of participants of the national multi-subject test, formed on the basis of databases of participants of external independent evaluation, certificates of external independent evaluation;

in case of submission of a foreign document on education;

in case of submission of documents by foreigners and stateless persons;

in case of submission of a document on previously acquired education, issued before the introduction of photopolymer technologies for their production;

in the case of submitting an application after the end of the working hours of electronic offices;

to exercise the right to award additional points provided for by the eleventh paragraph of subparagraph 1 of item 9 of Chapter VII of this Procedure;

if it is impossible to register an electronic office or submit an application in electronic form for other reasons, which is confirmed by a certificate from the admissions committee of a higher education institution.

Entrants specified in the fourth paragraph of this item may submit applications in electronic form with the subsequent submission of documents confirming the right to enter through an individual oral interview, which must be submitted within the application deadline, in accordance with this Procedure.

In order to exercise the right to admission based on the results of an individual oral interview on competitive subjects at the International University of Humanities and/or quota-1 (provided that at least one certificate of foreign exchange is available), the entrant must personally submit the original document(s) before submitting the application in electronic form. confirming the entrant's right to special conditions for participation in the competitive selection, to the admissions committee of one of the selected institutions of higher education.

Entrants can submit up to five applications for state and regional procurement positions in fixed and open tenders, and up to twenty applications for non-budget tenders.

2. The application in electronic form is submitted by the applicant by filling out the electronic form online and is considered by the admissions committee of the International Humanitarian University in the manner determined by the law.

The Admissions Committee of the International Humanitarian University operates a consultation center to assist applicants when submitting applications in electronic form. Entrants can contact the consultation center for the purpose of creating an electronic office, submitting applications in electronic form.

3. The entrant submits the application in paper form in person to the admissions committeeInternational Humanitarian University. The information of each application is registered in paper form by an authorized person of the admissions commission in the EDEBO on the day of acceptance of the application.

4. In the application, entrants indicate the competitive proposal indicating the specialty (subject specialty, specialization, educational program(s)) and form of education.

When submitting applications for open and fixed competitive offers, entrants must specify one of the following options:

"I apply to participate in the competition for a place of state or regional order and to participate in the competition for places at the expense of individuals and/or legal entities in the event of not receiving a recommendation for this tender proposal at the expense of the state or local budget (at the expense of the state or regional order)";

"I apply to participate in the competition exclusively for places at the expense of individuals and/or legal entities, informed about the impossibility of transfer within the framework of the admission campaign to places of state or regional order."

When submitting applications for a non-budget tender proposal, entrants claim to participate in the competition exclusively for places at the expense of individuals and/or legal entities and are warned about the impossibility of transfer within the framework of the admission campaign to places of state or regional order, in the applications they indicate:

"I apply to participate in the competition exclusively for places at the expense of individuals and/or legal entities, informed about the impossibility of transfer within the framework of the admission campaign to places of state or regional order."

Entrants to obtain an educational degree of junior bachelor, bachelor (master of medical, pharmaceutical or veterinary

majors) on the basis of complete general secondary education, educational and qualification level of a junior specialist, educational and professional degree of a professional junior bachelor, educational degree of a junior bachelor and entrants to obtain a master's degree based on a bachelor's degree, master's (educational and qualification level of a specialist) by specialties 081 "Right" and

293 "International Law", applicants for places of state or regional order according to the full-time or part-time form of education, indicate its priority in each application; while the priority indicator 1 (one) means the highest priority.

The priority of applications specified by the entrant cannot be changed.

To participate in the competition for admission to various forms of education, entrants submit separate applications.

5. When submitting an application in paper form, the entrant personally presents the originals:

a document (one of the documents) certifying a person, provided for by the Law of Ukraine "On the Unified State Demographic Register and documents confirming the citizenship of Ukraine, certifying a person or his special status";

military registration document (for conscripts - a military ticket or temporary identity card of a conscript, and for conscripts

- certificate of enrollment at conscription stations);

a document (of the state model) about the previously obtained educational (educational and qualification) level, on the basis of which the admission is made, if the information about it is not stored in the Unified State Electronic Database for Education;

documents confirming the entrant's right to enrollment based on an individual oral interview, to participate in a competition based on the results of an individual oral interview and/or quota-1, quota-2 based on complete general secondary education, to participate in a competition based on an individual oral interview during admission to obtain a master's degree on the basis of a bachelor's degree, master's degree (educational and qualification level of a specialist) instead of a master's test of educational competence or a master's complex test.

Entrants who live in the temporarily occupied territory of Ukraine or moved from it after January 1, 2022, as well as entrants who live in territories where state authorities temporarily do not exercise their powers, submit documents taking into account the features provided for by Order No. 271.

If, for objective reasons, the document on the obtained educational (educational and qualification) level is not available, a certificate from the state enterprise "Inforesurs" on its acquisition can be submitted, in particular without submitting an appendix to the document on the obtained educational (educational and qualification) level.

6. To the application submitted in paper form, the entrant adds:

a copy of the document (one of the documents) certifying the person, provided for by the Law of Ukraine "On the Unified State Demographic Register and documents confirming the citizenship of Ukraine, certifying the person or his special status";

military registration document (for conscripts - a military ticket or temporary identity card of a conscript, and for conscripts

- certificate of enrollment at conscription stations);

a copy of the document (state model) about the previously obtained educational (educational and qualification) level, on the basis of which the admission is made, if the information about it is not stored in the Unified State Electronic Database for Education;

six color photo cards measuring  $3 \times 4$  cm.

To participate in an individual oral interview, a creative competition based on a complete general secondary education, in addition to the application for participation (in electronic or paper form in the form determined by the admissions committee of the International Humanitarian University), entrants submit a copy of an identity document; a photo card with a size of  $3 \times 4$  cm (1 MB for photo cards in electronic form); a certificate of the educational institution on completion of general secondary education in case of lack of information about the obtained document on complete general secondary education at the EDEBO, a copy of the document confirming the applicant's right to participate in an individual oral interview. Submission of other documents by entrants for participation in an individual oral interview, creative competition is not mandatory.

For entrants who have to undergo an individual oral interview or a creative competition, the admissions committee of the International Humanitarian University will carry out electronic registration for participation in them, provided that the entrant submits scanned copies (photocopies) of documents.

Entrants who pass individual oral interviews, professional exams, and creative contests are allowed to participate in them if they have an original identity document, an original document confirming the entrant's right to participate in an individual oral interview, and an examination sheet with a photo card.

The entrant submits other copies of documents, if this is caused by the special conditions of entry to the relevant tenders established by law, within the time limits specified for the acceptance of documents.

7. Copies of documents certifying the grounds for obtaining special conditions for enrollment based on an individual oral interview, for participation in the competition based on the results of an individual oral interview and/or quota-1, quota-2 based on complete general secondary education, special conditions for participation in the competition for the results of an individual oral interview during admission for obtaining a master's degree on the basis of a bachelor's degree, master's degree (educational and qualification level of a specialist), the entrant submits in person during the submission of documents in paper form in the terms determined by this Procedure or in accordance with it. Documents not submitted on time certifying the grounds for obtaining special conditions for enrollment after an interview, for participation in the competition based on the results of an individual oral interview and/or quota-1, quota-2 based on a complete general secondary education, make their implementation impossible.

8. Copies of documents certifying the grounds for obtaining special conditions by a person who is enrolled in studies at the expense of individuals and/or legal entities, for transfer to vacant places of the state (regional) order, the entrant submits in person at the same time as fulfilling the requirements for enrollment in places at the expense of individuals and /or legal entities.

Lately submitted documents certifying the grounds for obtaining special conditions for transfer to vacant positions of the state (regional) order are considered by the admission commissions and relevant state (regional) customers within the limits of the remaining budget positions.

9. Copies of documents, except the identity document and the military registration document, are certified by the admissions committee of the International Humanitarian University. Copies of documents without presenting the originals will not be accepted.

The Admissions Committee verifies the grounds for obtaining special conditions for enrollment based on an individual oral interview, for participation in the competition based on the results of an individual oral interview and/or quota-1, quota-2 based on complete general secondary education, special conditions for participation in the competition based on the results an individual oral interview during admission to a master's degree on the basis of the obtained bachelor's degree, master's degree (educational and qualification level of a specialist) and special conditions for persons who are enrolled in studies at the expense of individuals and/or legal entities to obtain a bachelor's educational degree (master's degree in medical , pharmaceutical or veterinary fields) on the basis of a complete general secondary education, a master's degree on the basis of an obtained bachelor's degree, master's degree (educational and qualification level of a specialist) for transfer to vacant positions of the state order.

11. The Admissions Committee reviews applications and documents of entrants and accepts thema decision on admission to participate in the competitive selection for admission to study at the International University of Humanities within three working days from the date of registration of the application at the EDEBO, but no later than the next day after completion acceptance of documents, in the case of taking entrance exams - no later than the next day after the end of entrance exams.

12. The fact that the entrant has familiarized himself with the Admission Rules, the existing license and the certificate of accreditation of the relevant educational program (specialty), as well as the fact of the presence/absence of grounds for participation in the competition based on the results of an individual oral interview, enrollment based on guota-1, quota -2 are recorded in the entrant's application and confirmed by his personal signature when submitting the application.

In the case of submitting documents for non-accredited educational programs (specialties), the fact that the entrant has familiarized himself with part six of Article 7 of the Law of Ukraine "On Higher Education" is recorded in a written notification about the lack of accreditation and is confirmed by his personal signature when submitting the application in paper form.

The entrant has the right to cancel the previously submitted application, registered and admitted to the competition in institutions of higher education, in his own electronic account before the end of the submission of electronic applications, without the right to submit a new application with the same priority.

A paper application registered in the EDEBO may be canceled by the international humanities university based on the decision of the admissions committee before the end of the acceptance of study documents for applications in paper form, provided that a technical error was made during the entry of relevant data into the EDEBO, which is confirmed by the act of a technical error , which is formed and printed from EDEB. The canceled application is considered not submitted, and the fact of such submission is canceled in the EDEBO. The institution of higher education notifies the entrant about the cancellation of the application by means of mobile or electronic communication on the day of its cancellation, after which the entrant can submit a new application with the same priority.

An electronic application registered in the EDEBO may be canceled by the Technical Administrator of the EDEBO on the basis of an official decision of the Administrator of the EDEBO no later than a day before the end of the submission of electronic applications, provided that a technical error is detected during the entry of relevant data into the EDEBO. The canceled application is considered not submitted, and the fact of such submission is canceled in the EDEBO.

The technical administrator by means of mobile or electronic communication informs the entrant about the cancellation of the application on the day of its cancellation, after which the entrant can submit a new application with the same priority.

13. At the time of admission to training, persons who submit a document on the acquired abroad, the degree (level) of education (hereinafter - the Document), the procedure for recognizing and establishing the equivalence of the Document is

mandatory, which is carried out in accordance with

to the order of the Ministry of Education and Science of Ukraine dated May 5, 2015 No. 504

"Some issues of recognition in Ukraine of foreign educational documents", registered in the Ministry of Justice of Ukraine on May 27, 2015 under No. 614/27059.

14. Documents on higher spiritual education are accepted in the case of persons obtaining it before September 1, 2018 and on the condition of submitting a certificate of state recognition of a document on higher spiritual education obtained by a person in accordance with the Procedure for State Recognition of Documents on Higher Spiritual Education, Scientific Degrees and Academic Titles, Issued by Institutions of higher spiritual education, approved by the resolution of the Cabinet of Ministers of Ukraine dated August 19, 2015

No. 652, or the decision of the Academic Council of the International Humanitarian University regarding the recognition of the corresponding document on higher spiritual education.

15. During the submission of applications and documents for obtaining a junior bachelor's degree, a bachelor's (master's degree in veterinary field) based on the educational and qualification level of a junior specialist can be accepted as documents about the educational and qualification level of a junior specialist, prepared in accordance with the resolution of the Cabinet of Ministers of Ukraine dated September 9, 2020 year No. 811

"On documents on higher education (scientific degrees)", as well as documents on the educational and qualification level of a junior specialist, prepared in accordance with the resolution of the Cabinet of Ministers of Ukraine of July 22, 2015 No. 645 "On documents on professional (vocational and technical) education of the state sample and their appendices".

#### VII. Competitive selection, its organization and conduct

1. Competitive selection for obtaining degrees of higher education is carried out based on the results of entrance tests or consideration of motivation letters in the cases provided for in this Procedure:

for admission to the first year of studies for the degree of junior bachelor, bachelor (master of medical, pharmaceutical or veterinary fields) on the basis of a complete general secondary education - in the form of a national multi-subject test or external independent assessment, creative competitions and review of motivation letters in the conditions provided for in this Procedure cases;

for admission to studies to obtain a bachelor's degree (master's degree in medicine, pharmacy, and veterinary fields) based on the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor - in the form of a national multi-subject test or an external independent

assessment, creative competition, review of motivational letters in the cases provided for in this Procedure;

for admission to study for a master's degree on the basis of the obtained degree of higher education in the specialties 081 "Law" and 293 "International law" - in the form of a master's comprehensive test, a single entrance exam in a foreign language, a single professional entrance test, consideration of motivation letters in the prescribed by this Procedure in cases;

for admission to study for a master's degree on the basis of the obtained degree of higher education in the fields of knowledge 05 "Social and behavioral sciences", 07 "Management and administration", 29 "International relations" (except for the specialty 293 "International law") - in the form master's test of educational competence, professional exam, review of motivation letters in the cases provided for in this Procedure;

for admission to study for obtaining a master's degree based on a bachelor's degree, master's (specialist) in other specialties - upon consideration of motivation letters in the cases provided for in this Procedure;

in other cases - in accordance with the Admission Rules from the list of forms specified in the fourth paragraph of Clause 5 of Section I of this Procedure.

2. Competitive selection is carried out on the basis of the competitive score (consideration of motivation letters), which is calculated in accordance with this Procedure and Admission Rules.

3. For the competitive selection of persons who, on the basis of a complete general secondary education, enter the first course to obtain a bachelor's degree (master's degree in medical, pharmaceutical or veterinary fields), are enrolled:

scores of the national multi-subject test in the Ukrainian language (first subject), mathematics (second subject) and history of Ukraine (third subject),

or external independent assessment scores of 2019-2021 from three competitive subjects (in any combination) provided for by the Rules of Admission to the International Humanitarian University in 2019 for the relevant majors (specialization, subject major, competitive proposal) and source of funding, and only from creative competition for the specialties for which it is held.

The results of the 2019-2021 external independent assessment of the Ukrainian language and literature/Ukrainian language, mathematics and/or history of Ukraine may, at the applicant's request, be counted instead of the relevant subjects of the national multi-subject test, if the difference in the scores of the national multi-subject test and the external independent assessment of the relevant subject does not exceed 15 points.
In the cases stipulated by this Procedure, the results of an individual oral interview on the same subjects are counted instead of the national multi-subject test.

For the competitive selection of persons for places at the expense of individuals or legal entities who, on the basis of a complete general secondary education, enter the first course to obtain a bachelor's degree (except for specialties in the fields of knowledge 05

"Social and Behavioral Sciences", 06 "Journalism", 07 "Management and Administration", 08 "Law", 12 "Information Technologies", 22 "Health Care", 24 "Service Sector", 28 "Public Management and Administration ", 29 "International relations", specialty 035 "Philology") and specialties for which a creative competition is planned (022 Design, 021 Audiovisual art and production, 025 Musical art), respectively, the results of only consideration of motivation letters can be used.

4. For the competitive selection of persons who, on the basis of a complete general secondary education, enter the first course to obtain a junior bachelor's degree, the following are considered:

scores of the national multi-subject test in the Ukrainian language (first subject) and another subject (second subject),

or external independent assessment scores of 2019-2021 from two competitive subjects (in any combination) provided for by the 2019 International Humanities University Admission Rules for the relevant specialty (specialization, subject specialty, competitive proposal) and source of funding.

The results of the 2019-2021 external independent assessment of the Ukrainian language and literature/Ukrainian language, mathematics or the history of Ukraine may, at the applicant's request, be counted instead of the corresponding subjects of the national multi-subject test.

In the cases stipulated by this Procedure, the results of an individual oral interview on the same subjects are counted instead of the national multi-subject test.

5. For the competitive selection of persons who, on the basis of the educational and qualification level of a junior specialist, educational and professional degree of a professional junior bachelor, educational degree of a junior bachelor, enter the second (third) course with a normative or the first course with a shortened period of study to obtain a bachelor's degree (master's medical, pharmaceutical fields), points are counted:

1) for admission to places of state (regional) order - national multi-subject test in the Ukrainian language or foreign

2019-2021 independent assessment of Ukrainian language and literature/Ukrainian language (first subject) and national multi-subject test in mathematics or external independent assessment of mathematics 2019-2021 (second subject);

2) for admission to places at the expense of individuals or legal entities determined by the Rules for the admission of one national subject multi-subject test or external independent assessment 2019-2021 years (first subject) and one subject of the national multi-subject test or external independent assessment of the 2019-2021 years for the entrant's choice (second subject) and the creation of a creative competition for specialties for which a creative competition is planned.

In the cases stipulated by this Procedure, the results of an individual oral interview on the same subjects are counted instead of the national multi-subject test.

6. For the competitive selection of persons who, on the basis of a bachelor's degree, a master's degree (educational and qualification level of a specialist), enroll in studies to obtain a master's degree, are enrolled:

1) for admission to specialties 081 "Law" and 293 "International Law": the results of the master's complex test,

or the results of the law test of the unified professional entrance test in law and the results of the unified foreign language entrance exam of 2019-2021 (in any combination).

The results of the single professional entrance test in law and the results of the single entrance exam in foreign language 2019-2021, at the request of the entrant, can be counted instead of the scores of the master's complex test in law and foreign language, respectively, if the difference in the scores of the single professional entrance test and the single entrance exam and the master's comprehensive test of the relevant components does not exceed 15 points.

In the cases stipulated by this Procedure, instead of the results of the master's comprehensive test, the results of an individual oral interview in a foreign language and law are used;

2) for admission to the specialty of fields of knowledge 05 "Social and behavioral sciences", 07 "Management and administration", 28 "Public management and administration", 29 "International relations" (except specialty 293 "International law"):

the results of the master's test of educational competence and the professional exam,

In the cases stipulated by this Procedure, instead of the results of the master's test of educational competence, the results of an individual oral interview in a foreign language are used;

3) for admission to other specialties:

the results of a professional exam when entering a state or regional order;

the results of consideration of motivation letters when applying for places at the expense of individuals or legal entities;

7. For the competitive selection of persons who, on the basis of a bachelor's degree, enroll in studies to obtain a bachelor's degree, motivational letters are considered when applying for places at the expense of individuals or legal entities;

8. For the competitive selection of persons who, on the basis of a master's degree (specialist), enter studies to obtain a master's degree, motivational letters are considered when applying for places at the expense of individuals or legal entities.

9. The competitive score is calculated:

1) for admission to the first course for obtaining a bachelor's degree (master's degree in medicine, pharmacy) on the basis of a complete general secondary education according to the following formula:

Competition score (KB) =  $K1 \times P1 + K2 \times P2 + K3 \times P3 + OU$  or KB = TC; for entry into the first year for a junior bachelor's degree at

on the basis of complete general secondary education according to the

following formula: Competitive score (KB) =  $0.5 \times P1 + 0.5 \times P2$ 

+ OU or KB = TC,

where

P1, P2, P3 – grades from the first, second and third subjects. The table of translation of test scores from the Ukrainian language, mathematics, history of Ukraine of the national multi-subject test to the 100-200 scale is provided in Appendix 6 to this Procedure;

TK – assessment of creative competition;

OU is a point for successfully completing the preparatory courses of the International Humanitarian University in the year of admission for admission to it on a scale from 0 to 10 points in the case of admission to the majors (specializations) specified in the List of majors that receive special support. If the entrant's competitive score exceeds 200, it is set equal to 200;

Integral weighting factors K1, K2, K3 for each specialty are defined in Appendix 4 to this Procedure.

Individuals who are members of national teams of Ukraine and participated in international Olympiads (in accordance with the orders of the Ministry of Education and Science of Ukraine), Olympic, Paralympic and De-Olympic Games at the request of the Ministry of Youth and Sports of Ukraine, are credited with scores of 200 points in two competitive subjects of their choice entrant

Finally, the competitive score is multiplied by the regional (RC) and industry (GC) coefficients by multiplying it by their product, and:

RC is equal to 1.04

GC is equal to 1.02 for submitted applications with priority 1 and 2 in the specialty (subject specialties, specializations), provided for in the List of specialties that receive special support; 1.00 - in other cases;

If, after multiplying by coefficients, the competitive score exceeds 200, it is set equal to 200;

2) for admission to study based on the educational and qualification level of a junior specialist, educational and professional degree of a professional junior bachelor, educational degree of a junior bachelor for the second (third) year with a normative or for the first year with a shortened period of study for obtaining a bachelor's degree (master's degree in medicine, pharmacy and veterinary directions) according to the following formula:

Competition score (KB) =  $0.5 \times P1 + 0.5 \times P2$  (TC),

where P1, P2 - grades from the first and second subjects (creative competition);

3) for admission to study for a master's degree in specialties 081 "Law" and 293 "International Law" according to the following formula:

Competition score (KB) =  $0.3 \times P1 + 0.7 \times$ 

P2, where

P1 - evaluation of the unit of the master's complex test (or individual oral interview in the cases provided for by this Procedure) in a foreign language or the single entrance exam in a foreign language 2019-2021 (on a scale from 100 to 200 points). The table of translation of test scores from a foreign language master's complex test to a scale of 100-200 is given in Appendix 6 to this Procedure;

P2 - assessment of the unit of the master's comprehensive test (or individual oral interview in the cases provided for by this Procedure) in law or the single professional entrance test of 2019-2021 (on a scale from 100 to 200 points), Table of transfer of test scores from the master's comprehensive test in law to the scale 100-200 is given in Appendix 6 to this Order;

4) for admission to study for obtaining a master's degree in specialties of fields of knowledge 05 "Social and behavioral sciences", 07 "Management and administration", 29 "International relations" (except specialty 293 "International law") according to the following

formula: Competition score (KB) =  $0.5 \times P1 +$ 

 $0.5 \times P2$ , where

P1 - assessment of the master's test of educational competence (or an individual oral interview in a foreign language in the cases provided for by this Procedure) (on a scale from 100 to 200 points), The table of transfer of test points of the master's test of educational competence to a scale of 100-200 is given in Appendix 6 hereto In order;

P2 - professional exam score (on a scale from 100 to 200 points);

5) for admission to study for a bachelor's degree (on the basis of a bachelor's diploma) and a master's degree (on the basis of a master's or specialist's degree) in other specialties according to the following formula:

Competition score (KB) = MT (motivational letter)

The principle of equality of rights of entrants must be observed for the different number of components in the competitive ball.

10. The minimum value of the number of points from the entrance tests (competition score) with which an entrant is allowed to participate in the competition for admission on the basis of a complete general secondary education, junior specialist diploma, professional junior bachelor's degree, bachelor's degree, master's degree cannot be less than 100 points.

The competitive score for admission on the basis of a complete general secondary education cannot be less than 140 points for specialties in the fields of knowledge 08 "Law", 28

"Public management and administration", 29 "International relations".

11.Individual oral interviews for entrants on the basis of complete general secondary education and for entrants on the basis of the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor, which they pass instead of external independent assessment, are conducted according to programs of external independent assessment . Individual oral interviews in a foreign language for entrants to obtain a master's degree are conducted according to the program of a single entrance exam in foreign languages for admission to study for a master's degree based on the obtained degree of higher education (educational and qualification level of a specialist), approved by the Ministry of Education and Science of Ukraine .

Creative contest programs, evaluation structure and evaluation procedure, programs of other entrance tests are developed and approved by the heads of the admissions committee of the International Humanitarian University.

The evaluation criteria of the motivational letter are published on the websitewww.mgu.edu.ua.

12. Persons who without valid reasons (recognized as such by the decision of the Admissions Committee) did not appear for the entrance tests at the time specified in the schedule, persons whose knowledge was assessed with scores below the minimum value established by the Admission Rules, as well as persons who collected documents after the end date acceptance of documents, participation in subsequent entrance tests and competitive selection are not allowed. Retaking entrance exams is not allowed.

13. Appeals on the results of the entrance tests conducted by the International Humanities University are considered by the appeal commission, the composition and procedure of which is approved by the order of the rector of the University.

14. Information about the results of entrance tests and other competitive indicators is entered into the record of the entrant in the EDEBO.

15. By the decision of the admissions committee, the results of the entrance exam in a competitive subject for admission to a certain competitive offer may be counted upon the applicant's application to participate in the competitive selection for another competitive offer at the International Humanities University.

16. The official announcement of the results of creative contests for places of state and regional order, including information about the achievement of the minimum passing score, is carried out by posting relevant information on the official website of the International Humanitarian University and is submitted to the EDEBO no later than the next day after they are held.

## VIII. Special conditions for participation in the competitive selection for higher education at the International Humanitarian University

1. The special conditions for participation in competitive selection during admission to higher education based on complete general secondary education are:

enrollment based on a positive assessment of an individual oral interview or a creative competition;

participation in the competitive selection based on the results of an individual oral interview instead of the national multi-subject test and/or quota-1, quota-2.

Special conditions regarding participation in the competitive selection during admission based on the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor are participation in competitive selection based on the results of an individual oral interview instead of a national multi-subject test.

Special conditions for participation in the competitive selection during admission based on the obtained bachelor's, master's degree (educational qualification level of a specialist) are participation in the competitive selection based on the results of an individual oral interview instead of the master's test of educational competence or the master's complex test.

Special conditions for obtaining higher education at the expense of the state or local budget (by state or regional order) on the basis of a complete general secondary education are:

enrollment based on the results of a positive assessment of an individual oral interview or a creative competition, quota-1, quota-2 for places of state or regional order;

transfer of persons to vacant positions of the state or regional order in the cases provided for by this Procedure, if they are enrolled in studies using other sources of funding for an open or fixed competitive offer.

Information about persons who have the right to special conditions for participation in competitive selection during admission is entered in the EDEBO (with the addition of scanned copies of documents confirming these rights).

2. Entrance tests are held in the form of an individual oral interview or a creative competition, and in the case of a positive evaluation, they are recommended for enrollment in higher education based on a complete general secondary education or the educational and qualification level of a junior specialist, educational and professional degree of a specialized junior bachelor, educational degree of a junior bachelor's degree at the expense of the state or local budget (by state or regional order) (unless the application states: "I am applying for participation in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility of transfer within the scope of the admission campaign to places of state or regional order"):

persons with disabilities due to war in accordance with Article 7 of the Law of Ukraine

"On the status of war veterans, guarantees of their social protection" (in particular, on the basis of the educational and qualification level of junior specialist, educational and professional degree professional younger bachelor, educational degree youngerbachelor's degree);

persons with disabilities who are unable to attend an educational institution (on the recommendation of public health and social protection authorities).

For these categories entrants individual oral interview mayto be conducted remotely by decision of the University.

3. Entrance tests can be taken in the form of an individual oral interview instead of a national multi-subject test, and if the number of points for each of the subjects is not less than the minimum level established by the University, they are allowed to participate in the competitive selection during admission to obtain a higher education on the basis of a complete general secondary education or educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor:

persons recognized as injured participants of the Revolution of Dignity, participants in hostilities in accordance with the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social Protection", in particular those of them who are undergoing military service (except conscripts) in the manner determined by the relevant provisions on the passage military service by citizens of Ukraine.

persons who, according to the decision of the regulatory commission at the regional center for the evaluation of the quality of education, were denied registration for participation in the external independent evaluation in 2022 due to the impossibility of creating special (special) conditions (on the condition that a copy of the medical report in the form of the primary accounting report is submitted to the admissions committee of the higher education institution documentation No. 086-3/o "Medical opinion on the creation of special (special) conditions for passing an external independent assessment", approved by the order of the Ministry of Education and Science of Ukraine, the Ministry of Health of Ukraine from

August 29, 2016 No. 1027/900 "Some issues of participation in external independent assessment and entrance exams of persons with certain diseases and/or pathological conditions, disabilities", registered with the Ministry of Justice of Ukraine on December 27, 2016 under No. 1707/29837, which certified by the signature of the secretary of the regulatory commission at the regional center for the assessment of the quality of education and the seal of the regional center for the assessment of the quality of education, and the corresponding extract from the minutes of the meeting of the regulatory commission at the regional center for the assessment of the quality of education, and the corresponding extract from the minutes of the quality of education);

persons who, upon request regarding the possibility of creating special conditions for passing the national multi-subject test, were refused by the Ukrainian Center for the Evaluation of the Quality of Education due to the lack of organizational and technological capabilities (on the condition that a medical report stating the need to be submitted to the admissions committee of the University

the creation of certain conditions for passing the national multi-subject test, and the corresponding confirmation of the Ukrainian Center for the Evaluation of the Quality of Education about the impossibility of their creation).

Individuals of these categories participate in the competitive selection based on the results of an individual oral interview or external independent assessment of 2019-2021 (in any combination of their choice), the national multi-subject test of 2022. If such persons are admitted to competitive selection for an open or fixed competitive offer on the basis of complete general secondary education, they participate in competitive selection within quota-1 for places of state or regional order (unless the application states: "I apply for participation in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility of transfer within the framework of the admission campaign to places of state or regional order").

Entrants from among persons with visual impairments who use Braille in the process of education and need to create a special (special) condition under code 0205 List of special (special) conditions created for persons with special educational needs at points of external independent assessment , approved by the order of the Ministry of Education and Science of Ukraine, the Ministry of Health of Ukraine dated August 29, 2016 No. 1027/900, registered with the Ministry of Justice of Ukraine on December 27, 2016 under No. 1708/29838, participate in the competitive selection based on the results of an individual oral interview or external independent assessment of 2019-2021 (in any combination of their choice).

4. Entrance tests can be taken in the form of an individual oral interview instead of a national multi-subject test, and if the number of points for each of the subjects is not less than the established minimum level, they are allowed to participate in the competitive selection during admission to obtain a higher education based on a complete general secondary education minimum level are allowed to participate in the competitive selection:

persons whose place of residence is the temporarily occupied territory, the territory of settlements on the contact line or who moved from it after January 1, 2022.

Such persons participate in the competitive selection based on the results of an individual oral interview or a national multi-subject test. If citizens of Ukraine from among such persons are admitted to competitive selection for an open or fixed competitive offer, they participate in competitive selection within quota-2 for places of state or regional order (unless the application states: "I apply to participate in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility of transfer within the scope of the introductory campaign to places of state or regional order").

5. Take part in competitive selection within quota-1 for places of state or regional order (unless the application states:

"I am applying to participate in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility of transfer within the scope of the admission campaign to places of state or regional order"):

orphans, children deprived of parental care, persons from among them.

6. Persons who use the special conditions for participation in the competitive selection for obtaining higher education under a state (regional) order based on complete general secondary education in accordance with clauses 2 - 5 of this section and were not enrolled in the places of the state (regional) order, have the right to participate in the competition on a general basis according to the competition score.

7. Subject to transfer to vacant positions of the state or regional order in accordance with the procedure provided for in this Procedure, if they are enrolled in studies using other sources of funding for an open or fixed competitive offer and did not receive a recommendation for positions of the state or regional order (unless the application states:

"I am applying to participate in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility of transfer within the scope of the admission campaign to places of state or regional order"):

1) children of dead (deceased) persons, defined in the first part of Article 101 of the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social Protection", persons from among them;

2) persons, one of whose parents died or died as a result of wounds, mutilation, contusion or other health damage received during participation in the Revolution of Dignity;

3) persons, one of whose parents is a participant in hostilities on the territory of other states, who was killed (missing) or died as a result of injury, contusion or mutilation received during hostilities and conflicts on the territory of other states, as well as as a result of a disease related to with a stay on the territory of other states during these actions and conflicts;

4) persons in whom one of the parents (adoptive parents) was a military serviceman who died or was recognized by the court as a missing person while performing his military service duties;

5) persons in whom one of the parents (adoptive parents) was a policeman who died or was recognized by the court as a missing person while performing his official duties, within three years after obtaining the appropriate general secondary education.

8. Can be transferred to vacant positions of the state or regional order in accordance with the procedure provided for in this Procedure, if they are enrolled in studies using other sources of funding for an open or fixed competitive offer and did not receive a recommendation for positions of the state or regional order:

personswith disabilities of I, II groups and children with disabilities under the age of 18, who are not contraindicated to study in the chosen specialty;

persons with disabilities from among participants in the liquidation of the consequences of the accident at the Chernobyl NPP and victims of the Chernobyl disaster, for whom a causal connection of disability with the Chernobyl disaster has been established, patients suffering from radiation sickness as a result of the Chernobyl disaster (category 1) and persons who permanently lived in the zone of unconditional (mandatory) resettlement from the moment of the accident to the adoption of the decision on resettlement (category 2);

children of persons (as well as persons from among them who obtained a full general secondary education in the year of admission), recognized as injured participants of the Revolution of Dignity, participants in hostilities, persons with disabilities as a result of the war, in accordance with the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social protection";

miners who have at least three years of underground work experience, as well as within three years of completing general secondary education, persons whose parents are miners and have at least 15 years of underground work experience, or who died as a result of an industrial accident or became persons with group I or II disability;

entrants who participated in the admissions campaign based on the results of a specially organized session of the national multi-subject test, the master's comprehensive test, the master's test of educational competence submit documents within the time limits set by the Ministry of Education and Science of Ukraine and receive a recommendation for enrollment in the event of obtaining a competitive score that was sufficient for admission to places of state (regional) order with address allocation of budget places;

persons who use the special conditions of participation in the competitive selection for obtaining higher education under the state (regional) order on the basis of complete general secondary education in accordance with clauses 2 - 5 of this section and were not enrolled in the places of the state (regional) order (unless in the relevant applications it is stated: "I am applying for participation in the competition exclusively for places at the expense of individuals and/or legal entities, informed about the impossibility of transfer within the framework of the admission campaign to places of state or regional order").

9. Can be transferred to vacant positions of the state or regional order in accordance with the procedure provided for in this Procedure, if they are enrolled in studies based on other sources of funding for an open or fixed competitive offer, if they are enrolled in studies at the expense of individuals and/or legal entities, and not received a recommendation for places of state or regional order (unless the relevant applications state: "I am applying for participation in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility of transfer within the scope of the admission campaign to places of state or regional order »):

persons who are internally displaced persons in accordance with the Law of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons";

children from large families (five or more children).

10. When applying for higher education at the expense of individuals and/or legal entities for competitive proposals, which, according to this Procedure, provide for the completion of a master's test of educational competence, entrants based on a master's degree (educational and qualification level of a specialist) can, at their choice, or submit the result a master's test of educational competence, or take an individual oral interview in a foreign language.

#### IX. Ranking lists of entrants and recommendations for enrollment

1. The ranked list of entrants is formed by category in the following sequence: entrants who have the right to be admitted based on the results of a positive assessment of an individual oral interview or a creative competition for places of state or regional order (on the basis of a complete general secondary education and on the basis of the educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree junior bachelor's degree);

entrants who have the right to enroll according to quotas (only on the basis of a complete general secondary education);

entrants who have the right to enroll on general terms.

2. Entrants who have the right to enroll based on the results of a positive assessment of an individual oral interview or a creative competition for places of state or regional order are arranged alphabetically.

Within the limits of other categories specified in clause 1 of this section, the ranked list of entrants is ordered:

according to the competitive score - from higher to lower;

according to the priority of the application from the first to the last; based on the results of consideration of motivational letters.

If the competition scores are the same, the priority of the applications from the first to the last (for places of state and regional order) is used to arrange the applicants, if the priorities are the same, the results of the review of motivation letters are used.

If the priority of applications is not used (admission to places at the expense of individuals or legal entities), then if the competition scores are the same, the results of consideration of motivational letters are used to rank the entrants.

If the construction of the ratingthe list is made without competitive points and priorities, then the entrants are ranked only on the basis of consideration of motivation letters by the admissions committee.

Motivational letters are reviewed by the Admissions Committee without assigning competitive points to them.

3. The ranked list of entrants includes:

degree of higher education, specialty, name of the competitive offer, form of education, sources of funding, educational level (degree) on the basis of which admission to the relevant competitive offer can be carried out;

surname, first name, patronymic (if available) of the entrant;

competitive score of the entrant (except those enrolled on the basis of a positive assessmentindividual oral interview or creative competition for state or regional order places);

the priority of the application specified by the entrant (only for tenders using priority);

a sign of the grounds for enrollment based on the results of the interview, quota-1, quota-2 (only on the basis of complete general secondary education);

Surnames of entrants whose place of residence is the temporarily occupied territory, the territory of settlements on the contact line (who are not registered as internally displaced persons) or who moved from it after January 1, 2022, are subject to encryption in all information systems.

4. Ranking lists (in particular, current ones) are formed by the admissions committee of the University with EDEBO and are published in full on the website <u>www.mgu.edu.ua</u>.

5. Lists of entrants recommended for enrollment at the expense of the state or local budget (by state or regional order) for each competitive proposal are received by the admissions committee based on the data of the EDEB, checked for the authenticity of the information provided by the entrants and compliance with the requirements stipulated in this Procedure

regarding the formation of lists, in particular the requirements of the Materials for the development of the technical task for the algorithm of the address placement of the state and regional order in 2022 (hereinafter - the Materials for the development of the technical task), listed in Appendix 6 to this Procedure, are approved by the decision of the admissions committee and made public by posting on the information stands of admission commissions and the website<u>www.mgu.edu.ua</u>. in accordance with the terms specified in section V of this Procedure.

The list of entrants recommended for enrollment shall contain the same data as in the ranked list of entrants in accordance with clause 3 of this section.

6. Address placement of budget places for admission of entrants to higher education bachelor's degree (master's degree in medicine, pharmacy or veterinary field) on the basis of complete general secondary education (full-time and part-time forms of education), educational and professional junior bachelor's degree, educational and qualification level of junior specialist, junior bachelor's degree according to competitive offers is formed in the EDEBO on the basis of competitive scores, priorities and arrangement of the ranked list of entrants taking into account the total, maximum volumes, qualification minimum of the state order. An entrant may be recommended for admission according to the highest priority among those indicated by him during the application submission, according to which the entrant is among those who can be recommended for admission to places financed by a state (regional) order, in accordance with his competitive score. The technical task for the implementation of the targeted allocation of budget places is formed in accordance with the Materials for the development of the technical task.

7. The decision of the admissions committee on the recommendation for enrollment is posted on the University's website, and is also displayed in the office of the entrant at the EDEBO (if available).

Entrants recommended for enrollment may be notified by electronic and mobile communications in accordance with the Admission Rules.

### X. Implementation of the right of entrants to choose a place of study

1. Persons who have submitted applications in paper or electronic form and are participating in the competitive selection for state and regional order places, after the acceptance committee has made a decision on recommendation for enrollment in accordance with the term specified in section V of this Procedure or in accordance with it, must must fulfill the requirements for admission to places

state and regional order: to personally submit the documents provided for in Chapter VI of the Procedure and the Admission Rules to the admissions committee of the International Humanitarian University, as well as conclude a study contract between the University and the applicant (with the participation of parents or legal representatives - for minor applicants).

Submission of the originals of the necessary documents for enrollment can be carried out in addition to personal submission by:

sending their scanned copies, with a qualified electronic signature of the entrant superimposed on the relevant files, to the email address of the Admissions Committee of the University, specified in the Register of subjects of educational activity of the EDEBO within the terms specified in section V of this Procedure or in accordance with it. If within twenty calendar days after the start of studies, the original documents are not received from the entrant (in person or by mail), then the enrollment order is canceled in terms of the enrollment of such a person.

The study contract (regardless of funding sources) between the University and the applicant (with the participation of parents or legal representatives - for minor applicants) is the basis for issuing an enrollment order. If the entrant fulfilled the requirements for enrollment without submitting documents in person, the enrollment order can be issued without concluding a contract. If the training contract is not concluded within twenty calendar days after the start of training (signed in person or with a qualified electronic signature), then this order is canceled in terms of the enrollment of such a person.

The submitted originals of documents are kept at the University for the entire period of study. An entrant whose last name, first name, patronymic (if available) has changed after receiving the educational document, on the basis of which admission is made, additionally personally presents to the admissions committee of the University a certificate of state registration of the act of civil status regarding the corresponding change and the issued based on the identity document, information about which is entered in the EDEBO. Persons who submitted applications in electronic form without applying a qualified electronic signature are also required to sign their own application printed by the admissions committee.

In the case of enrollment for studies at the expense of natural (legal) persons, an additional contract is concluded between the University and the natural (legal) person who orders a paid educational service for himself or another person, assuming financial obligations for its payment.

2. Persons who received a recommendation for places of state or regional order and within the established terms specified in section V of this Procedure or in accordance with it, did not fulfill the requirements for enrollment in places of state or regional order (except for the cases specified in section

XIII of this Order), lose the right in the current year to enroll (transfer) to study according to the state and regional order.

Persons who have received a recommendation for state or regional order places and have fulfilled the requirements for admission to state or regional order places within the established terms specified in section V of this Procedure or in accordance with it, are subject to enrollment.

3. The procedure for exercising the right of entrants to choose a place of study for moneyindividuals and/or legal entities is determined by the Admission Rules.

### XI. Adjustment of the list of recommended for enrollment

1. The Admissions Committee cancels previously provided recommendations to applicants who have not met the requirements for admission to the state or regional order places provided for in Clause 1 of Section X of this Procedure.

2. Lists of those recommended for admission are updated after the fulfillment/failure of applicants to obtain a master's degree based on the obtained bachelor's degree (educational and qualification level of a specialist) (except for majors 081 "Law" and 293 "International Law"), for obtaining a doctor of philosophy degree, the requirements for admission to studies in accordance with Section X of this Procedure, taking into account their priority in the ranked list of entrants.

3. Entrants recommended for study at the expense of individuals and/or legal entities are required to fulfill the requirements for enrollment in accordance with clause 1 of section X of these Procedures and Admission Rules.

In the case of enrollment for studies at the expense of natural (legal) persons within ten calendar days from the date of commencement of studies, an additional contract is concluded between the University and the natural (legal) person who orders a paid educational service for himself or another person, assuming financial obligations obligations regarding its payment. In case of refusal to enter into a contract within the term established in this paragraph, this order shall be canceled in terms of the enrollment of such a person. Tuition is paid in accordance with the contract between the University and a natural (legal) person who orders a paid educational service for himself or another person, assuming financial obligations for its payment.

## XII. Transfer to vacant positions of the state (regional) order of persons who are enrolled in training at the expense of individuals, legal entities

1. The International Humanities University independently provides recommendations for the targeted allocation of budget places to entrants within the limits of the places (except for non-budget competitive offers) for which recommendations were given for admission to this University based on the relevant competitive offer in the manner provided for in Clause 6 of Section IX of this Procedure, and subsequently canceled in accordance with Clause 1 of Chapter XI of this Order.

2. The right to transfer to vacant positions of the state (regional) order is used by persons who did not receive recommendations before enrolling in the positions of the state (regional) order.

3. The transfer to vacant positions of the state (regional) order of persons who are enrolled in studies at the expense of individuals and/or legal entities on the basis of a complete general secondary education is carried out in the following sequence:

persons specified in Clause 7 of Chapter VIII of this Procedure, regardless of the competitive score;

the persons specified in Clause 5 of Section VIII of this Procedure, if the competitive score is at least 125 points;

the persons specified in clause 8 of section VIII of this Procedure, if the competitive score they received is less than the passing score (the minimum score that made it possible to receive a recommendation for enrollment in state order places under this competitive proposal under a general competition in the manner provided for in clause 6 of section IX of this Order) by no more than 15 points (by 25 points for specialties specified in the List of specialties that receive special support);

persons specified in Clause 9 of Section VIII of this Procedure, if their competitive score is less than the passing score by no more than 15 points (only for specialties specified in the List of specialties that receive special support);

persons who did not receive a recommendation for admission to state (regional) order places in accordance with the procedure provided for in clause 6 of section IX of this Procedure (only for specialties specified in the List of specialties that are provided with special support), if their competitive score is not less than a special passing grade the competitive score set by the University's admissions committee the day after the announcement of the address allocation of budget places.

If persons who have not completed their education at the expense of the state or local budget (by state or regional order) at a certain degree of higher education and received a recommendation for admission to places of state (regional) order in accordance with the procedure provided for in Clause 6 of Section IX of this Procedure, but not began training due to the impossibility of reimbursement to the state or local budget of funds spent on the payment of specialist training services, in accordance with the Procedure for reimbursement of state or local budget funds spent on the payment of state or local budget funds spent on the payment of state or local budget funds spent on the payment of state or local budget funds spent on the payment of specialist training services, approved by the resolution of the Cabinet of Ministers of Ukraine dated 26 No. 658 of August 2015, the next-ranking persons who did not receive recommendations for enrollment in state-ordered positions as of the date of the transfer may be transferred to the vacant state-ordered positions vacated in this order (upon agreement with the state or regional customer).

The transfer to vacant positions of the state (regional) order of persons specified in paragraphs two to five of this clause is carried out in the absence of nontransferred persons of the previous category or in case of their officially recorded refusal to transfer and in the sequence from the highest to the lowest place in the rating list in within each of the specified categories.

4. In the absence of a sufficient number of places for transfer to vacant places of the state (regional) order, the institution of higher education uses for this purpose the vacant places of the state (regional) order from other specialties of this field (only for the persons specified in paragraphs two to five of clause 3 of this section), and in their absence - other fields of knowledge (only for persons specified in paragraphs two - four of clause 3 of this section) of this or another form of education (after transfer to vacant positions by state order of persons specified in clause 3 of this section for relevant specialty and form of education), which is immediately reported to the relevant state (regional) customer.

After that, unused places of the state (regional) order are considered to be not placed in this institution of higher education. The institution of higher education informs the state (regional) customer about their number in terms of specialties (specializations) and forms of education. In the event of a lack of a sufficient number of places for the transfer to vacant places of the state (regional) order of the persons specified in the third paragraph of point 3 of this section, the institution of higher education sends the state (regional) customer a request for the allocation of additional places of the state order at the expense of the returned ones. The decision on the use of these places is made by the tender commission of the state (regional) customer.

5. Persons who entered based on the results of only consideration of motivation letters can be transferred to state or regional positions

order only if the requirements for admission to such places, established by the Admission Rules of the current or subsequent years, are met.

## XIII. Enrollment order, additional competition

1. Enrollment orders are issued by the head of the International Humanitarian University based on the decision of the admissions committee. Enrollment orders with their annexes are formed in the EDEBO and published on the University's website in the form of a list of those enrolled within the terms established in section V of this Procedure or in accordance with it.

2. The admission commission's decision to enroll an entrant may be revoked by the admission commission in case of detection of violations by the entrant, provided for in Clause 5 of Chapter XVI of this Procedure.

Enrolled persons may be removed from the enrollment order (the enrollment order is revoked in the part relating to that person) to the University at their own request. To persons expelled from the University at their own will, the documents submitted by them will be returned no later than the next day after submitting the application for expulsion.

3. If a person, without valid reasons, does not start classes within 10 calendar days from the date of their start, the enrollment order is canceled in the part that concerns this person.

4. Additional competitive selection (in agreement with the state or regional customer) may be conducted for the position(s) vacated in accordance with the procedure provided for in clauses 2 and 3 of this section from among the persons who participated in the competition for this competitive proposal. Entrants who submitted an application for this competitive offer and were admitted to participate in the competitive score. In the additional competitive selection according to the competitive score. In the absence of such applicants for vacant places, it is allowed to enroll persons from the competitive offers of this institution of higher education, provided that the entrance tests coincide, by transferring the application (with the consent of the person) to another competitive offer.

Additional competitive selection is carried out until October 15, while orders for the enrollment of such persons are formed and submitted to the EDEBO by 18:00 on October 19.

Applications of entrants enrolled in state or regional studies by order to obtain a junior bachelor's degree, a bachelor's degree (master's degree in medicine, pharmacy or veterinary field) based on a complete general secondary education (full-time and part-time forms of education), an educational and professional degree of a professional junior bachelor's degree, an educational-

qualification level of a junior specialist, a junior bachelor's degree and applicants for higher education for a master's degree in specialties 081 "Law" and 293 "International Law" are excluded from competitions for other places at the expense of individuals or legal entities, except in cases where the entrant submits a separate application under the time of fulfilling the requirements for enrollment in the places of the state or regional order provided for in clause 1 of section X of this Procedure.

## XIV. Peculiarities of admission to higher education institutions of foreigners and stateless persons

1. Admission to study at the International Humanitarian University of foreigners and stateless persons is carried out in accordance with the Laws of Ukraine "On higher education", "On the legal status of foreigners and stateless persons",

"On Ukrainians Abroad", "On Refugees and Persons in Need of Additional or Temporary Protection", Decree of the President of Ukraine dated June 3, 1994 No. 271 "On Measures to Develop Economic Cooperation of the Regions of Ukraine with Adjacent Regions of the Republic of Belarus and Administrative Territorial Units of the Republic Moldova" (except for entrants from the Republic of Belarus), by resolution of the Cabinet of Ministers of Ukraine dated

September 12, 2018 No. 729 "Issues of obtaining higher education by certain categories of persons", by order of the Ministry of Education and Science of Ukraine dated November 1, 2013 No. 1541 "Some issues of organization of recruitment and training (internship) of foreigners and stateless persons", registered in the Ministry of Justice of Ukraine on November 25, 2013 according to No. 2004/24536, by order of the Ministry of Education and Science of Ukraine dated December 2, 2019 No. 1498 "On approval of the Procedure for setting quotas for obtaining higher education by foreigners and stateless persons within the scope of the state order in accordance with international treaties of Ukraine", registered with the Ministry of Justice of Ukraine on February 10, 2020 under No. 153/34436.

Citizens of the Russian Federation and the Republic of Belarus, who do not have a permanent (temporary) residence permit in Ukraine, are admitted to study with the individual permission of the Ministry of Education and Science of Ukraine.

2. Foreigners and stateless persons (hereinafter - foreigners) may obtain higher education at the expense of individuals and/or legal entities, unless otherwise provided by international treaties of Ukraine, the binding consent of which has been granted by the Verkhovna Rada of Ukraine, legislation or agreements between institutions of higher education on international academic mobility.

Foreigners are admitted to the accredited educational programs of the International Humanities University for junior bachelor's, bachelor's and master's and doctorate degrees.

The International Humanities University also accepts foreigners for postgraduate studies, preparatory faculty (subdivision) programs, for studying the state language and/or language of instruction, as well as for postgraduate education, advanced training and internships.

3. Admission of foreigners to study can be carried out face-to-face and/or remotely.

The validity period of an invitation to study is no more than 1 year from the date of its registration in the Automated System "Electronic Journal" of a state enterprise authorized by the Ministry of Education and Science of Ukraine.

Foreigners who have received an invitation to study registered in the Automated System can participate in remote admission

"Electronic magazine" of the state enterprise authorized by the Ministry of Education and Science of Ukraine, received a set of information and consulting support services, and also received a visa to enter Ukraine for the purpose of study.

In order to organize the remote recruitment of foreign citizens to study for higher education, the educational institution concludes an agreement with a partner organization that is a resident of the country of origin of the entrants. The subject of the agreement is the provision of services for personal identification, verification of original documents of entrants, organization of receiving entrants' applications in electronic form, provision of premises and technical means for conducting consultations and entrance tests by a higher education institution in a remote format.

The conclusion of agreements by educational institutions of Ukraine is possible with organizations that meet the following requirements:

compliance of the area of the premises for remote submission of documents, consultations and entrance tests to the established norms of quarantine restrictions in the country where recruitment is carried out;

provision of entrants with means of personal protection;

ensuring the procedure of identification of entrants using face recognition technologies, which includes checking personal data (surname, patronymic (if available)), biometric data and their verification with the official (state) database;

ensuring compliance with integrity requirements during the entrance exam for foreigners;

provision of a place to store telephones, tablet computers and other electronic devices of entrants seized during the entrance test;

provision of a suppression device for cellular and Internet networks; provision of video surveillance around the perimeter of the audience in which

there is an entrance exam for foreigners by installing at least two video cameras;

provision of technical equipment for video communication with the examination board of the educational institution in real time (computer, video camera, microphone, TV or projector with a screen);

the presence of at least two employees in the classroom to monitor compliance with the requirements of academic integrity and technical support during the entrance exam for foreigners;

provision of all entrants with individual computers with connection to the institution's online platform, through which the entrance exam for foreigners will take place;

provision of consultations and trainings before the entrance exam for foreigners in order to familiarize them with the rules of taking it remotely and using the online platform;

provision of video recording of the entrance test, transfer of video material to the educational institution through the online platform, storage of information and video materials after conducting the entrance exam for foreigners for five years in a partner organization.

4. Enrollment of foreign entrants for studies at the expense of individuals and/or legal entities may be carried out by institutions of higher education:

1) three times a year within the deadlines set by the Admission Rules for obtaining junior bachelor's, bachelor's, and master's degrees;

2) during the year for studies in graduate school, adjunct.

The institution of higher education calculates the points/grades of the entrant based on the document on the previously obtained level of education and establishes the minimum value of the number of points/grades required for admission in the general education subjects from which the entrance exam for foreigners is conducted.

Enrollment of foreigners to study at the appropriate level of higher education is carried out based on the results of entrance exams for foreigners in specified subjects and the language of study and on the basis of academic rights to continue studying, provided by a document on the level of education obtained in the country of origin, and taking into account the success scores that give the right to continue studying at the next level of higher education in accordance with the legislation of the country that issued the document on the obtained degree (level) of education.

5. All categories of foreigners enrolled in studies are enrolled in higher education institutions of Ukraine on the basis of enrollment orders. Confirmation of the fact of training can be a certificate issued at the EDEBO.

6. The requirements of the higher education institution regarding the compliance of applicants from the number of foreigners who have arrived in Ukraine for the purpose of study with these Procedures and Rules of Admission, as well as the deadlines for accepting applications and documents, conducting the admission

examination for foreigners and enrollment are specified in the Admission Rules and published on the official website of the higher education institution.

7. Foreigners who are granted state scholarships under international treaties, national programs, and other international obligations of Ukraine are admitted to study within the established quotas for foreigners on the basis of referrals from the Ministry of Education and Science of Ukraine.

8. Foreigners who arrive in Ukraine to participate in academic mobility programs or to obtain higher education according to educational programs agreed between Ukrainian and foreign institutions of higher education are admitted to study taking into account the contractual obligations of the relevant institutions of higher education.

9. Foreigners and stateless persons, in particular Ukrainians living abroad permanently in Ukraine, persons recognized as refugees, and persons in need of additional protection, have the right to obtain higher education on an equal basis with citizens of Ukraine, in particular at the expense of state or local budget funds, with exceptions established by the Constitution of Ukraine, laws of Ukraine or international treaties, consent to the bindingness of which has been given by the Verkhovna Rada of Ukraine.

Ukrainians abroad, whose status is certified by a certificate of a Ukrainian abroad (except for persons permanently residing in Ukraine), can enroll in studies under the state order within the limits of the established quotas for foreigners after an interview on the subjects provided for in the Admission Rules.

# XII. Ensuring openness and transparency in admission to the International Humanitarian University

1. Representatives of the mass media have the right to be present at the meeting of the admission commission (no more than two persons from one mass media). The admission rules determine the procedure for the accreditation of journalists in the admission commission.

2. Non-governmental organizations can apply to the Ministry of Education and Science of Ukraine for granting them the right to monitor the work of admission commissions. Non-governmental organizations granted such a right by the Ministry of Education and Science of Ukraine may send their observers to the meetings of the admission commissions. Admission commissions are obliged to create appropriate conditions for the presence of public observers at their meetings, as well as to provide them with the opportunity to familiarize themselves with the documents provided to the members of the admission commission before the meeting.

3. The university is obliged to create conditions for familiarizing entrants with a license to carry out educational activities, certificates of accreditation of the relevant specialty (field of training, educational program). The entrant's submission of unreliable personal data, about previously obtained education, unreliable information about the right to enroll according to quotas, the right to enroll according to an interview, about participation in student Olympiads and defense contests of the Small Academy of Sciences of Ukraine, about passing an external independent assessment is grounds for cancellation the order on his enrollment.

6. Informing the public about the licensed volume, the cost of training by specialty (directions of training, specializations, educational programs), the course of submitting applications for admission, recommendations for enrollment and enrollment in higher educational institutions is carried out by information systems, including the "Competition" system, on the basis of data A single base.

#### **Rules of admission**

#### to graduate school

#### **International Humanitarian University**

#### 1. Terms

**1.1.**Postgraduate studies The International Humanities University (hereinafter referred to as the University) is the main form of training of specialists for the educational and scientific degree of Doctor of Philosophy. Educational activities at the University's graduate school are carried out in accordance with the license of the Ministry of Education and Science of Ukraine (Order of the Ministry of Education and Culture dated 04.03.2021 No. 26-1) and admission rules approved by the University's academic council.

**1.2** The University's postgraduate admission rules are an integral part of the International Humanities University Admission Rules in 2022 (hereinafter - the Admission Rules), developed by the University's Admissions Committee (hereinafter - the Admissions Committee) in accordance with the Conditions of Admission to Higher Educational Institutions of Ukraine in 2021, hereinafter - Terms of admission), approved by the order of the Ministry of Education and Science of Ukraine dated 15.10.2020 No. 1274 and Registered with the Ministry of Justice of Ukraine on December 9, 2020 under

No. 1225/35508 and in cases not regulated by the Admission Rules postgraduate studies of the University (hereinafter – Rules of admission to postgraduate studies), necessarybe guided by the Admission Rules and Conditions of Admission.

**1.3** Persons who have obtained an educational and scientific degree (educational and qualification level) and a master (educational and qualification level of a specialist) are admitted to study for the degree of Doctor of Philosophy at the graduate school of the University on a competitive basis.

**1.4** It is forbidden to simultaneously study full-time at the graduate school of the University in several specialties.

**1.5** University carries out admissions to postgraduate studies in the specialties indicated in table 1.

**1.6** Deadlines for receiving documents, holding entrance exams,

admission to postgraduate and doctoral studies is established by order of the rector. Not no later than three months before the start of admission to the University, an announcement is made in the mass media and on the official website indicating scientific specialties, terms and conditions of admission, a list of documents required for admission to postgraduate studies.

**1.7.**Deadlines for receiving applications and documents, holding entrance tests, competitive selection and enrollment for study of entrants to postgraduate studies of the University are carried out annually within the terms set by the admissions committee of the university:

# The first stage:

- submission of applications for admission to the competition from August 14 to August 29, 2022;
- entrance tests from August 31 to September 10, 2022;
- ▶ the deadline for publishing the ranked list of entrants is September 11, 2022;
- ➤ the deadline for enrolling entrants is September 14, 2022.

### The second stage:

- submission of applications for admission to the competition from September 20 to October 1, 2022;
- entrance tests from October 4 to October 10, 2022;
- $\blacktriangleright$  the deadline for publishing the ranked list of entrants is October 12, 2022;
- $\blacktriangleright$  the deadline for enrolling entrants is October 15, 2022.

**1.8** In order to conduct entrance exams for postgraduate studies, a commission chaired by the president of the University, with the appointment of the deputy head of the rector of the university, is created by a corresponding order. Members of the commission are appointed from among the heads of institutes, faculties, departments and their deputies, as well as prospective academic supervisors of graduate students.

**1.9** Persons who have previously completed a full course of training at a postgraduate or doctorate program under a state order, as well as those who have been expelled from it early for committing illegal actions or failing to fulfill an individual plan, do not have the right to re-enter the postgraduate program.

# 2. The procedure for accepting documents for admission to postgraduate studies at the International Humanitarian University.

**2.1** Entrants to graduate school The university is submitted in person in paper form the following documents to the admissions committee:

1) application indicating specialty, form of education (full-time or part-time);

**2**) a document certifying identity and citizenship (in accordance with Article 5 of the Law of Ukraine "On Citizenship of Ukraine") and its copy(2);

3) a copy of a military ticket or registration certificate - for conscripts and its copy;

4) a document of the state standard (original) about the previously obtained educational and qualification level of a master (specialist), on the basis of which admission is carried out, and an appendix to it and their copies or a document with appendices (in the case when they are provided for) and their copies about the obtained abroad degree (level) of education. For these documents, the procedure for recognizing and establishing the equivalence of the document is mandatory, which is carried out in accordance with the Procedure for recognizing degrees of higher education obtained in foreign higher educational institutions, approved by the order of the Ministry of Education and Science of Ukraine dated May 5, 2015 No. 504, registered in the Ministry of Justice of Ukraine June 27, 2015 under No. 614/27059 (for persons who obtained the appropriate degree (level) of education abroad;

**5**)recommendation (if available) of the academic council of the relevant university (institute) regarding admission to postgraduate studies;

**6**) description-recommendation from the last place of work(for those who work, on a form);

7) protocol of the interview with the future scientific supervisor, who gives consent to conduct scientific supervision of the graduate student (on a form);

**8**)TOEFL test certificate, or InternationalEnglishLanguageNestingSystem or CambridgeEnglishLanguageAssessment certificate and their copies (if available);

**9**)a certificate issued by the preparatory department of the University based on the results of the course of preparation for taking the international exam, which corresponds to level B2 of the All-European recommendations on language education and its copy (if available);

**10**) a list of published scientific works and inventions;

11) entrants who do not have published scientific works and inventions, submit scientific abstracts (25 pages) from their chosen scientific specialty or a published article from the chosen specialty;

12) feedback on the essay or article of the future supervisor with an evaluation;

13) four color photos measuring 3x4 cm;

14) personnel record sheet;

**15**) a copy of the work book;

16) autobiography;

17) a medical certificate on the state of health in form No. 086U or another form with a similar content if the applicant is abroad at the time of submission of documents for admission to graduate school;

18) a copy of the identification number assignment certificate (2 copies).

**2.2** the admission committee verifies the authenticity of the data submitted by the entrant for participation in the competitive selection, using the Unified Database. Written confirmation by the Technical Administrator of the Unified Database that the information submitted by an applicant to a higher educational institution is untrue is grounds for refusal to participate in the competitive selection and enrollment (cancellation of the enrollment order).

# **3.** Peculiarities of the organization of admission to graduate school

**3.1** In order to carry out the competitive selection for admission to postgraduate studies, the admissions committee organizes the reception of applications and documents, entrance exams, performs the competitive selection of applicants for enrollment.

**3.2** Persons who have a higher education and a master's or specialist qualification are admitted to postgraduate studies.

**3.3.**The decision on admission to graduate school entrance exams is made by the admissions committee based on the results of the interview, review of the essay and submitted scientific works, taking into account the written opinion of the prospective supervisor, about which the applicant to the graduate school is notified within a week.

The Admissions Committee may refuse an applicant admission to take entrance exams to graduate school, due to failure to submit all or some of the documents specified in clause 3.1 of these Rules or their submission after the deadline.

**3.4** The order to hold entrance exams is issued by the rector based on the decision of the admissions committee, information about the date, place and time of entrance exams is communicated to graduate students personally.

**3.5**Entrance tests for studying for the degree of Doctor of Philosophy consist of:

- entrance oral exam in the specialty (within the scope of the standard of higher education for a master's degree in the relevant specialty);

- an entrance exam in one of the foreign languages chosen by the entrant (English, German) in the form of a comprehensive written test, which consists of three parts and contains a number of tasks of different levels of complexity, aimed at checking the level of formation of speech and language competence in an amount corresponding to level B2 Pan-European recommendations on language education. The exam in another foreign language is held according to the decision of the Academic Council of the University in the event that knowledge of this language is necessary for work on the dissertation;

- entrance oral exam in philosophy (in the scope of educational programs for higher educational institutions);

- written presentation of research results in scientific form<u>reports (abstract)</u>in the amount of 25 sheets from the chosen specialty, submitted together with the application for admission.

**3.6** An applicant who has confirmed his level of knowledge, in particular of the English language, with a valid TOEFL test certificate, or International English Language Nesting System, or a Cambridge English Language Assessment certificate, is exempt from taking the entrance exam in a foreign language. When the results of the competition are determined, the specified certificates are equated to the results of the entrance test in the foreign language with the highest score. Entrants who received in 2016 a certificate issued by the preparatory department of the University based on the results of a course of preparation for taking an international exam, in particular English language, which corresponds to level B2 of the All-European recommendations on language education, have the first right to enroll when entering postgraduate studies.

**3.7**Entrants entering postgraduate studies from a different field of knowledge (specialty) than the one specified in their master's degree (specialist) may be assigned additional entrance tests by decision of the Admissions Committee.

**3.8** The notice of admission to the entrance exams provided by the admissions committee certifies, in accordance with the current legislation of Ukraine, the right of the entrant to graduate school to take additional paid leave at the place of work at the rate of 10 days for each entrance exam.

Travel time in the direct and return direction from the entrant's place of work to the location of the higher educational institution is not included in the leave.

**3.9** Admission to graduate school entrance exams is conducted by subject commissions, as a rule, in the number of 3-4 people, appointed by the rector's order and consisting of doctors and candidates of sciences.

**3.10** Programs of professional tests for admission on the basis of the acquired educational and qualification level are developed and approved by the University no later than three months before the start of accepting documents. Programs of professional tests are published on the website of the University and in the admissions office

**3.11** The competitive score is calculated as the sum of the results of the entrance exams. Entrance tests are evaluated according to evaluation criteria on a scale of 100.

**3.12.** The results of entrance exams for postgraduate studies are valid during the calendar year.

**3.13** Persons who are without respectablereasons did not appear for the entrance exams at the time specified in the schedule, or their knowledge was evaluated unsatisfactory, they are not allowed to take the next entrance exams.

**3.14** The minimum level of assessment of the entrance test, in connection with receivingwhich person is not admitted to the next entrance exams - 3 points. Retaking entrance exams is not allowed.

3.15 Information on the results of entrance exams is generated in the EDEBO.

**3.16** Appeals on the results of entrance exams are submitted on the day of the exam or no later than the next business day after the announcement of the entrance exam grade and are considered by the appeal commission no later than the next business day after their submission. The composition and procedure of the appeal commission are approved by the order of the rector.

**3.17.**The Admissions Committee makes a decision on each graduate student based on the results of the entrance exams. In the case of receiving the same grades, applicants recommended for admission to postgraduate studies by the Academic Council have priority for admission to postgraduate studies

university, who have successfully completed a master's degree or have scientific works in the relevant scientific specialty.

3.18In case of receiving the same points in the listed sequence, entrants who:

**and**)in accordance with the current national regulatory framework, have been recommended for admission to postgraduate studies by the academic council of the relevant university (institute) and have successfully completed a master's degree;

**b**)have published articles in professional publications on the topic of the future dissertation;

**in**)are winners of the II stage of the All-Ukrainian contests of student scientific works in natural, technical and humanitarian sciences or All-Ukrainian student Olympiads in academic disciplines, areas of training and specialties, as noted in the relevant orders of the Ministry of Education and Culture of Ukraine;

**d**) the admissions committee may take into account other scientific achievements in the chosen scientific specialty, participation in Olympiads and competitions, receiving prizes and awards for scientific work, etc.

# 4. Financing of personnel training

**4.1** For citizens of Ukraine and persons equivalent to them, training in postgraduate and doctoral studies is carried out at the expense of:

– funds of legal entities and individuals - on the terms of the contract for the provision of educational services.

**4.2** For foreigners, training is carried out on the basis of:

- international treaties of Ukraine;
- national programs;
- contracts concluded by the university with legal entities and individuals.

**4.3**The contract with the entrant or the customer regarding training at the expense of individuals and legal entities is concluded after the issuance of the enrollment order. Tuition is paid in accordance with the contract concluded by the parties.

### 5. Admission to graduate school.

**5.1**The order for admission to postgraduate study is issued by the rector of the University based on the decision of the admissions committee. The order on enrollment for studies with their annexes is formed in the EDEBO in accordance with the lists of applicants recommended for enrollment, and is published on the information stand of the admissions committee and the University's website in the form of a list of enrollees.

**5.2** Admissions decisioncommission on enrolling an entrant may be canceled by the admissions commission in case of detection of violations of legislation on the part of the entrant, namely, the entrant's submission of unreliable personal data, unreliable information about previously acquired education.

**5.3**Entrants may be expelled from the postgraduate program of the University at their own request, as a result of which a corresponding order is issued, which is verified by the EDEBO, and the documents submitted by them are returned to such persons no later than the next day after submitting the application for expulsion.

**5.4** Each post-graduate student is assigned a scientific supervisor, as a rule, a doctor of science or a candidate of science by decision of the Academic Council, at the same time as he is enrolled by the relevant order of the rector. The scientific supervisor supervises the graduate student's work on the dissertation, monitors the implementation of the individual plan and is personally responsible for the high-quality preparation of the dissertation by the graduate student.

**5.5** The entrant is notified of admission to graduate school within five days from the date of the admissions committee's adoption of the relevant decision.

# 6. Peculiarities of admission and study to postgraduate studies at the University of Foreigners and Stateless Persons

**6.1** The training of foreigners and stateless persons is carried out in accordance with the Laws of Ukraine "On Higher Education", "On the Legal Status of Foreigners and Stateless Persons", "On Ukrainians Abroad", Decrees of the President of Ukraine of March 25, 1994 No. 112 "On Measures for the Development of Economic on cooperation of regions of Ukraine with adjacent border regions of the Russian Federation" and dated June 3, 1994 No. 271 "On measures to develop economic cooperation of regions of Ukraine with adjacent regions of the Republic of Belarus and administrative-territorial units of the Republic of Moldova", by resolutions of the Cabinet of Ministers of Ukraine dated February 26, 1993 No. 136 "On Education of Foreign Citizens in Ukraine", dated September 11, 2013 No. 684 "Some Issues of Recruitment for Education of Foreigners and Stateless Persons", Order of the Ministry of Education and Science of Ukraine dated November 1, 2013 No. 1541 "Some Issues of Organization of Recruitment and training (internship)

foreigners and stateless persons", registered with the Ministry of Justice of Ukraine on November 25, 2013 under No. 2004/24536.

**6.2** *Foreign citizens* and stateless persons to the graduate program of the University personally submit the following documents in paper form to the admissions committee: 1) an application indicating the specialty, form of study (full-time or part-time);

2)<u>document</u>, certifying identity and foreign citizenship and its copy;

3) <u>document</u> and its copy of the degree (level) of education obtained abroad, the procedure for recognizing and establishing the equivalence of the document is mandatory, which is carried out in accordance with the Procedure for recognizing degrees of higher education obtained in foreign higher educational institutions, approved by the order of the Ministry of Education and Science of Ukraine dated May 5 No. 504 of 2015, registered in the Ministry of Justice of Ukraine on June 27, 2015 under No. 614/27059;

4) scientific report (an abstract of 25 sheets) on the chosen specialty;

5) <u>interview protocol</u> with the future supervisor, who gives consent to supervise the graduate student (on a form);

6) four color photos measuring 3x4 cm; 7)

autobiography;

8) personnel record sheet;

9) medical certificate on health status in form No. 286U or another form with similar content, if the applicant is abroad at the time of submission of documents for admission to graduate school;

10) a description-recommendation from the last place of work (for employees, on a form).

6.3 Education of foreign citizens and stateless persons is carried out on the basis of:

- international treaties of Ukraine and/or international exchange or mobility programs;

- on the basis of contracts concluded between the University and higher educational institutions of other countries, regarding the exchange of scientists or academic mobility;

- at the expense of the funds of legal entities and individuals (on the terms of the contract).

#### **FEATURES**

## admission of foreigners and stateless persons to the International Humanitarian University

1. Admission to higher education institutions of foreigners and stateless persons is carried out in accordance with the Laws of Ukraine "On Higher Education",

"On the legal status of foreigners and stateless persons", "On Ukrainians abroad", "On refugees and persons in need of additional or temporary protection", by the Decree of the President of Ukraine dated June 3, 1994

No. 271 "On measures for the development of economic cooperation of the regions of Ukraine with adjacent regions of the Republic of Belarus and administrative-territorial units of the Republic of Moldova", Resolution of the Cabinet of Ministers of Ukraine dated September 11, 2013 No. 684 "Some issues of recruitment for training of foreigners and stateless persons", by order No. 1541 of the Ministry of Education and Science of Ukraine dated November 1, 2013 "Some issues of organizing the recruitment and training (internship) of foreigners and stateless persons", registered with the Ministry of Justice of Ukraine on November 25, 2013 under No. 2004/24536.

2. Foreigners and stateless persons (hereinafter referred to as foreigners) may obtain higher education at the expense of natural (legal) persons, unless otherwise provided by international treaties of Ukraine, the binding consent of which has been granted by the Verkhovna Rada of Ukraine, legislation or agreements between higher educational institutions on international academic mobility.

2. Foreigners who come to Ukraine for the purpose of studying enter the University under accredited educational programs (specialties).

Enrollment of foreign entrants for studies at the expense of natural (legal) persons may be carried out by the University:

1) twice a year, before and at the beginning of the academic semesters (but no later than November 1 and March 1, respectively) for obtaining bachelor's and master's degrees;

2) during the year for postgraduate studies, doctoral studies.

Enrollment of foreigners to study at the appropriate level of higher education is carried out based on the results of entrance exams and the language of study and on the basis of academic rights to continue studying, provided by a document on the level of education obtained in the country of origin, and taking into account the success scores that give the right to continue studying at the next level of higher education in accordance with the legislation of the country that issued the document on the level of education obtained:

- on the basis of complete general secondary education according to the results of the Ukrainian language or a foreign language (the first subject) in accordance with the language of instruction, mathematics (the second subject) and the history of Ukraine (the third subject);

- on the basis of the educational and qualification level of a junior specialist or the educational and professional level of a professional junior bachelor based on the results of the entrance test in the Ukrainian language or a foreign language (first subject) in accordance with the language of instruction, mathematics or history of Ukraine (second subject) and a motivation letter.

- on the basis of the previously obtained level of higher education (bachelor's, specialist's, master's) based on the results of the entrance exam in a foreign language, the entrance exam in a specialty (professional exam in law for specialties 081 Law, 293 International Law).

The minimum number of points from all entrance exams is not less than 100 points.

All categories of foreigners enrolled in studies are admitted to the University on the basis of enrollment orders generated in the Unified Database.

Applications and documents are accepted twice a year and in several stages before and at the beginning of the academic semesters for obtaining junior bachelor's, bachelor's, master's, master's degrees in medical and pharmaceutical fields:

#### The first stage:

submission of applications for admission to the competition from July 14 to July 30

year;

- entrance tests from July 31 to August 7, 2022;
- $\blacktriangleright$  the deadline for publishing the ranked list of entrants is August 9, 2022;
- $\blacktriangleright$  the deadline for enrolling entrants is August 12, 2022.

### The second stage:

- submission of applications for admission to the competition from August 23 to September 17, 2022;
- entrance tests from September 18 to September 24, 2022;

- $\blacktriangleright$  the deadline for publishing the ranked list of entrants is September 25, 2022;
- $\blacktriangleright$  the deadline for enrolling entrants is September 28, 2022.

#### The third stage:

- submission of applications for admission to the competition from October 1 to October 22, 2022;
- entrance tests from October 25 to October 29, 2022;
- ▶ the deadline for publishing the ranked list of entrants is October 30, 2022;
- $\blacktriangleright$  the deadline for enrolling entrants is November 1, 2022.

4. Foreigners who are granted state scholarships under international treaties, national programs, and other international obligations of Ukraine are admitted to study within the established quotas for foreigners on the basis of referrals from the Ministry of Education and Science of Ukraine.

5. Foreign Ukrainians who are legally in Ukraine, and whose status is certified by a certificate of a foreign Ukrainian, upon admission to the University enjoy the same rights to education as citizens of Ukraine, with exceptions established by the Constitution of Ukraine, laws of Ukraine or international treaties, consent which are binding on the Verkhovna Rada of Ukraine.
