## RULES ADMISSION TO THE INTERNATIONAL HUMANITARIAN UNIVERSITY IN 2023

#### I. General provisions

Educational activities at the International Humanitarian University are carried out in accordance with the license of the Ministry of Education and Science of Ukraine (Order of the Ministry of Education and Culture dated 03.04.2021 No. 26-1 VO).

The rules of admission to the International Humanitarian University (hereinafter - the Rules of Admission) were developed by the Admissions Committee of the International Humanitarian University (hereinafter - the Admissions Committee) in accordance with the Procedure for Admission to Higher Education Institutions in 2022 (hereinafter - the Procedure for Admission), approved by the Order of the Ministry of Education and Science of Ukraine 15 March 2023 No. 276.

Admission to study at the International Humanitarian University is carried out on a competitive basis.

Admission of applicants is organized by the Admissions Committee of the International Humanitarian University (hereinafter the Admissions Committee of Moscow State University). The admission committee of the International Humanitarian University operates in accordance with the regulations on the admission committee, approved by the order of the Ministry of Education and Science of Ukraine dated October 15, 2015 No. 1085, registered in the Ministry of Justice of Ukraine on November 4, 2015 under No. 1353/27798.

The Rector of the International Humanitarian University ensures compliance with the legislation of Ukraine, in particular the Procedure, Rules of Admission, as well as the openness and transparency of the work of the Admissions Committee.

The decision of the admissions committee, made within its powers, is the basis for the corresponding order and/or implementation of the admission campaign procedures.

All issues related to admission to study are resolved by the admission committee at its meetings. Decisions of the admissions committee are published on the official website of the International Humanitarian University (websitewww.mgu.edu.ua).

In these Admission Rules, the terms are used in the following meanings:

targeted placement of budget places - providing the entrant with a recommendation for enrollment in places of study at the expense of the state or local budget (according to the state or regional order) based on his competitive score;

open competitive offer - a competitive offer for which the number of places for training under the state order is determined during the address allocation of budget places within the limits between the qualification minimum and the maximum volume of the state order or is equal to zero in the event that the number of persons who can be recommended for enrollment under the time of address allocation of budget places is less than the qualification minimum of the state order;

admission on the basis (basis of admission) — previously obtained educational (educational and qualification) level or educational degree and the corresponding level of the National Framework of Qualifications (hereinafter - NRK), on the basis of which admission is carried out for obtaining a degree of higher education (full general secondary education (professional secondary of education) (hereinafter - PZSO), educational and qualification level of junior specialist, educational and professional degree of professional junior bachelor, educational degree of junior bachelor - 5th level of NRK (hereinafter - NRK5), educational bachelor's degree - 6th level of NRK (hereinafter - NRK6), master's degree (educational and qualification level of a specialist) - level 7 of the NRK (hereinafter - NRK7));

entrance test - assessment of the entrant's readiness, which, in accordance with these Admission Procedures, can be conducted in the form of a national multisubject test, a single entrance exam, a single professional entrance test, as well as face-to-face and/or remotely (for entrants who are registered and are in the temporarily occupied territory or are abroad - at the applicant's request) in the form of an entrance exam for foreigners, an interview, a competition of creative and/or physical abilities, a professional exam, as well as an entrance exam in a foreign language, specialty, presentation of research proposals or achievements for admission to study for a doctorate degree of philosophy/doctor of arts, based on the results of which one positive assessment is given on a scale of 100–200 (in increments of at least one point) or a decision is made on the applicant's negative assessment ("unsatisfactory");

entrance exam for foreigners – a form of entrance exam that involves assessing the knowledge, abilities and skills of the entrant in one or more subjects, academic disciplines or specialties (foreigners and stateless persons who take the entrance exam for foreigners do not take other entrance exams);

entrant - a person who has submitted an application(s) for admission to participate in the competitive selection for one (several) competitive offers;

application for participation in entrance tests - a record entered into the Unified State Electronic Database on Education (hereinafter - EDEB) in an electronic form filled out by the entrant online in a personal

the entrant's electronic account, or the educational institution based on the application submitted by the entrant in paper form;

application for participation in the competitive selection to an educational institution (hereinafter – the application) – a record submitted to EDEBO in electronic form, filled out by the applicant online in the applicant's personal electronic account, or by the University based on the application submitted by the applicant in paper form, and containing information about the educational institution chosen by him, the competitive offer and the priority of the application established by the applicant (if it is used);

the single professional entrance test (hereinafter referred to as the E $\Phi$ BB) is the form of an entrance test for admission to study for a master's degree based on NRK6 or NRK7, which provides for an assessment of the level of preparation of the applicant for obtaining a master's degree in the relevant specialty / relevant specialties, which is conducted by the Ukrainian Center for Quality Assessment education in accordance with legislation;

the single entrance exam (hereinafter - EVI) is a form of entrance test foradmission to study for a master's degree on the basis of NRK6 or NRK7, which combines a test of general academic competence and a test of a foreign language (English, German, French, Spanish at the choice of the entrant), which is conducted by the Ukrainian Center for the Evaluation of the Quality of Education in accordance with the legislation;

qualification minimum of a state order – the minimum number of entrants that can be recommended for admission to an open competitive offer during the targeted allocation of budget places;

quota for foreigners - a specified number of budget places, which is used to admit entrants from among:

foreigners who come to study in accordance with international treaties of Ukraine;

persons with a certificatea foreign Ukrainian who does not permanently reside in Ukraine;

quota-1 is a specified part of the maximum amount of budget places (for open tenders) or the total amount of budget places (for fixed tenders), which can be used to admit applicants on the basis of PZSO and NRK5 who have the right to special conditions of admission to specified In the order of cases (except for persons entitled to quota-2);

quota-2 – a specified part of the maximum amount of budget places (for open competitive offers) or the total amount of budget places (for fixed competitive offers), which can be used to admit applicants based on the PZSO and NRK5, whose place of residence is as of February 24, 2022 declared (registered) in the temporarily occupied territory, the territory of settlements on the contact line and the administrative border or who moved from it after January 1, 2023;

competition of creative and/or physical abilities (further - creative competition) - a form of entrance test for admission based on PZSO and NRK5, which involves the demonstration and evaluation of creative and/or physical abilities

of the entrant (including previously acquired specialized education), necessary for obtaining higher education in a specialty that is included in the List of specialties, admission to study for which is carried out taking into account the level of creative and/or physical abilities of entrants, given in Appendix 1 to this Procedure, and is conducted within one day (the evaluation result is made public no later than the next day);

competitive offer - an offer of the International Humanitarian University regarding the number of places for admission to a certain level of higher education, a certain educational program (several educational programs within the specialty), the form of obtaining an education, the basis of admission, the period of study, with an indication of the form of the entrance test (if provided) and requirements for the structure and content of entrants' motivational letters. There are open, fixed and non-budget tender offers. Open competitive offers are part of a broad competitive offer (hereinafter referred to as a broad competition). In the event that the competitive offer combines several educational programs, the procedure for the distribution of higher education applicants between educational programs and the terms of selection by applicants of such programs (no earlier than the end of the first year of study based on the PZSO, no earlier than five months after the start of studies in other cases). The International Humanities University forms competitive proposals and submits them to the EDEBO within the terms specified in these Rules.

competitive score – assessment of the entrant's achievements, which is calculated based on the results of entrance tests and other competitive indicators with an accuracy of 0.001 in accordance with these Admission Rules;

competitive selection – the procedure for selecting entrants to competitive offers based on competitive points, priorities, motivation letters in accordance with these Rules:

the maximum volume of the state order - the maximum number of entrants to the open competitive offer that can be recommended for admission to the places of the state order;

motivational letter — written by the entrant (in accordance with the Regulation on writing a motivational letter) information about his personal interest in entering a certain competitive offer (educational institution) and corresponding expectations, achievements in studies and other types of activities, own strengths and weaknesses, to which if necessary, the entrant may attach copies (photocopies) of materials confirming the information stated in the letter;

national multi-subject test (hereinafter - NMT) - a form of entrance test, which provides for the evaluation of learning results from two subjects of the main block (Ukrainian language, mathematics) and one subject of the additional block (history of Ukraine, or a foreign language (English, or German, or French, or Spanish), or biology, or physics, or chemistry at the entrant's choice), which is conducted by the Ukrainian Center for Evaluation of the Quality of Education in accordance with the legislation;

non-budgetary competitive offer – a competitive offer for which admission places are not provided with funds from the state or local budget (by state or regional order);

the entrant's personal electronic account is a web page through which the entrant submits an electronic application to the educational institution and monitors its status; the right to enroll according to quotas - the right of an entrant to enroll

to study at the University according to quota-1, quota-2, quota for foreigners, implemented in accordance with this Order;

presentation of research proposals or achievements - a form of entrance test that can be prescribed during admission to obtain the educational degree of Doctor of Philosophy, which consists in listening to and discussing the entrant's scientific report;

priority – the order of consideration determined by the entrant when submitting applications (where 1 is the highest priority) in the case of address allocation of budget places; the institution of higher education in the Admission Rules may provide for the establishment of local priorities for admission in other cases with mandatory publication of the procedure for their application;

ranked list of entrants – a list of entrants, ordered by the order of admission to study for a competitive offer, taking into account the source of funding, which is formed in accordance with this Procedure and Admission Rules;

interview - a form of entrance test, which involves assessing the knowledge, abilities and skills of the entrant in one, two or three subjects (components, disciplines) in the cases provided for in this Procedure;

the status of the application is a parameter of the application submitted in electronic or paper form, which is set by the educational institution in the EDEBO. The statuses of the application submitted in electronic form are also displayed in the entrant's personal electronic account. The "Application Status" parameter can have the following values:

"Registered in EDEB" - confirmation of the fact of submitting an application to the International Humanitarian University chosen by the applicant

"Requires clarification by the entrant" - the application has been accepted by the International Humanities University for consideration, but the data regarding the entrant needs clarification. At the same time as assigning this status to the application, the International Humanitarian University notes the list of data that needs to be clarified and the method of their submission;

"Registered at the educational institution" - the application has been accepted by the International Humanities University for consideration and, in accordance with the established procedure, a decision is made on the admission of the entrant to participate in the competitive selection or admission to the entrance exams;

"Refused by the educational institution" - the applicant's registered application was not allowed to participate in the competitive selection or in the entrance tests based on the decision of the Admissions Committee. If the application is granted this status, the International Humanities University shall indicate the reason for refusal;

"Cancelled by the entrant" - the submitted application is considered not to have been submitted. This status is assigned to the application if it is canceled by the entrant

to a personal electronic account before assigning a status application

"Registered at the educational institution" or "Requires clarification by the applicant." At the same time, the entrant has the right to submit a new application with the same priority;

"Cancelled by the entrant (without the right to submit a new application with the same priority)" - the submitted application, in which the priority is established, canceled by the entrant in the personal electronic account after assigning the status "Registered at the educational institution" or "Requires clarification by the entrant" to the application, but before the date application deadline. At the same time, the entrant loses the opportunity to submit a new application with the same priority;

"Cancelled by the educational institution" - the submitted application is considered not to have been submitted, if it was canceled by the International Humanities University based on the decision of the admissions committee, provided that the University detects a technical error made during the data entry into the EDEBO, which is confirmed by an act of a technical error;

"Deactivated (in connection with enrollment in studies by state (regional) order)" - the submitted application is considered as not submitted, if the entrant is included in the order for enrollment in studies by state or regional order;

"Admitted to the competition" - the owner of the registered application is allowed to participate in the competitive selection for places financed by a state or regional order, and for places financed with the funds of individuals and/or legal entities:

"Admitted to the competition (education at the expense of individuals and/or legalpersons)" - the owner of the registered application is allowed to participate in the competitive selection for places financed with the funds of individuals and/or legal entities. The status is assigned in the following cases:

the entrant submitted an application to participate in the competitive selection only for places financed by the funds of individuals and/or legal entities in accordance with the Admission Procedure;

the entrant within the established terms did not fulfill the requirements of the Admission Procedure for enrolling in studies under a state or regional order, but by the decision of the Admissions Committee was admitted to the competitive selection for places financed by the funds of individuals and/or legal entities;

the entrant has been enrolled based on another application for studies under a state or regional order, but he also has the right to be enrolled for studies at the expense of individuals and/or legal entities;

"Recommended for enrollment (study under state (regional) order)" - the entrant has passed the competitive selection and is recommended for enrollment in study under state or regional order. If the application is granted such a status for enrollment in studies, the entrant must fulfill the requirements for enrollment in studies by state or regional order;

"Excluded from the list of recommended (studies under the state (regional) order)" - the entrant lost the right to be enrolled at the International Humanitarian University for studies under the state or

regional order in connection with non-fulfillment of the requirements of the Admission Procedure or their violation. When assigning such a status to the application, the International Humanities University indicates the reason for the exclusion;

"Recommended for enrollment (training at the expense of individuals and/or legal entities)" - the entrant has passed the competitive selection and is recommended for enrollment at the training at the expense of individuals and/or legal entities. If the application is granted such status for enrollment in studies, the entrant must fulfill the requirements for enrollment;

"Excluded from the recommended list (studying at the expense of individuals and/or legal entities)" - the entrant lost the right to be enrolled at the International Humanitarian University to study at the expense of individuals and/or legal entities due to non-fulfillment of the requirements of the Admission Procedure or their violation. When assigning such a status to the application, the International Humanities University must indicate the reason for the exclusion;

"Included in the order (studies by state (regional) order)" - by the order on enrollment, the entrant was admitted to the International Humanitarian University for studies by state or regional order;

"Included in the order (studies at the expense of individuals and/or legal entities)" - by the order on enrollment for studies, the applicant was enrolled at the International Humanitarian University for studies at the expense of individuals and/or legal entities;

"Enrollment cancelled" - the enrollment of an entrant to the International Humanitarian University has been cancelled;

technical error - an error made by an authorized person of the Admissions Commission for the acceptance and consideration of applications during the entry of information about the entrant or application to the EDEBO, which is confirmed by the act on the technical error;

regular application registration session – the application and document registration period defined by the Admission Rules of the International Humanities University

professional exam - a form of entrance test for admission based on NRK6 or NRK7, which involves checking the ability to master an educational program of a certain level of higher education based on previously acquired competencies;

fixed competitive offer - a competitive offer with a predetermined number of places (the total volume of the state (regional) order) for training under a state or regional order;

broad competition - a set of open tenders, which is a joint offer by state and private institutions of higher education of the aggregate volume (super volume) of budgetary places from all state customers for the admission of entrants to study places under the state order in a certain field of knowledge (inter-branch, subbranch group), specialty (subject specialty, specialization) and form of education. An open competitive offer can be included in only one broad competitive offer.

The term "voucher" is used in the sense given in the Law of Ukraine "On Employment of the Population".

The term "Ukrainians abroad" is used in the meaning given in the Law of Ukraine "On Ukrainians Abroad".

The terms "territory of Ukraine temporarily occupied by the Russian Federation (temporarily occupied territory)", "administrative border", "contact line" are used in the meanings given in the Law of Ukraine "On ensuring the rights and freedoms of citizens and the legal regime in the temporarily occupied territory of Ukraine".

Other terms are used in the meanings given in the Laws of Ukraine "On Education", "On Higher Education".

### II. Admission to study for higher education at the International Humanitarian University

1. To obtain higher education, the following are accepted:

entrants on the basis of PZSO - to obtain a junior bachelor's degree, bachelor's degree, as well as master's degree in medical, pharmaceutical and veterinary fields;

entrants on the basis of NRK5 - to obtain a bachelor's degree, master's degree in medical, pharmaceutical and veterinary fields with a shortened period of study, taking into account the requirements of higher education standards for the level of education of persons who can start studying under educational programs of the corresponding specialty and the amount of ECTS credits necessary to obtain the corresponding degree of higher education;

entrants based on NRK6 - to obtain a bachelor's degree; entrants based on NRK6 or NRK7 - to obtain a master's degree; entrants on basis NRK7 - for acquisition degree doctor of philosophy/doctor of arts (in assistantship-internship).

The list of medical, pharmaceutical and veterinary specialties for which admission to study for a master's degree is carried out on the basis of PZSO or NRK5 in the relevant specialty is given in Appendix 2 to this Procedure. The International Humanities University will conduct admissions for studies in specialties 226 "Pharmacy, industrial pharmacy" for obtaining a master's degree also on the basis of NRK6, NRK7, in specialty 222 "Medicine" for obtaining a master's degree also on the basis of NRK6 obtained on the basis of specialty 223 "Nursing".

To obtain a master's degree in the specialty 081 "Law", persons who obtained a bachelor's degree in the specialty 081 are accepted "Law" or 082 "International Law", 293 "International Law", directions 6.030401 "Jurisprudence", 6.030202 "International law".

To obtain a master's degree in the specialty 223 "Nursing", admission to study is carried out on the basis of NRK6, NRK7 in the specialties of the field of knowledge 22 "Health care".

To obtain a master's degree in specialization 227.1"Physical therapy" specialty 227 "Therapy and rehabilitation" is accepted for training on the basis of NRK6 in the specialty 227 "Physical therapy, occupational therapy" or in the direction 6.010203 "Human health" (professional direction Physical rehabilitation).

Persons who have previously obtained the same or a higher degree (level) of higher education or have obtained it for at least one year and are fully completing an individual educational plan are also accepted for obtaining a degree of higher education in another specialty. A condition for enrolling a student of higher education for simultaneous study in another specialty at the university is the fulfillment of the requirements for entrants to the relevant educational programs. These requirements must be fulfilled before the beginning of the second year of study, but no later than the period of certification of applicants.

2. Entrants are admitted to study for the first year of study. To entrants based on NRK5, the International Humanities University can re-enroll ECTS credits, the maximum amount of which is determined by the standard of bachelor's higher education (master's degree in medicine, pharmacy, veterinary fields) (in the absence of a standard, no more than 120 ECTS credits). Such persons may be admitted to study with a shortened period of study. In order to obtain a junior bachelor's degree, a bachelor's degree (master's degree in medicine, pharmacy, or veterinary sciences) in another specialty, persons may be admitted to study with a shortened period of study.

Applicants of higher education at the educational and qualification level of a specialist based on PZSO or NRK5, who were expelled or interrupted their studies due to an academic leave, have the right to be renewed to continue their studies to obtain a master's degree based on PZSO or NRK5 in the same or related field within the field of knowledge as a specialty at the International Humanitarian University.

- 3. Admission to study is carried out on the basis of competitive offers for specialties (specializations, subject specialties) in accordance with the List of fields of knowledge and specialties for which higher education applicants are trained, approved by Resolution No. 266 of the Cabinet of Ministers of Ukraine dated April 29, 2015 (as amended by Resolution of the Cabinet of Ministers of Ukraine dated July 7, 2021 No. 762), and for interdisciplinary educational (educational and scientific) programs that meet the requirements for interdisciplinary educational (scientific) programs, approved by order of the Ministry of Education and Science of Ukraine dated February 1, 2021 No. 128, registered in the Ministry of Justice of Ukraine on April 6, 2021 for No. 454/36076.
- 4. Peculiarities of admission to training of persons whose place of residence is the temporarily occupied territory, the territory of settlements on the contact line and the administrative border or who moved from it after January 1, 2023,

in terms of passing the annual assessment and state final certification, obtaining a state-style document on basic secondary education or full general secondary education (if the person has not received a document on education in accordance with the legislation), is determined in accordance with the Admission Procedure for obtaining higher, professional pre-higher and professional (vocational and technical) education of persons temporarily residing the territory of Ukraine occupied by the Russian Federation, approved by the order of the Ministry of Education and Science of Ukraine dated March 1, 2021 No. 271, registered in the Ministry of Justice of Ukraine on April 15, 2021 under No. 505/36127 (as amended by the order of the Ministry of Education and Science of Ukraine dated August 10, 2022 No. 726) (hereinafter - order No. 271).

- 5. Admission to graduate studies is carried out in accordance with this Procedure and the Procedure for training higher education holders of the degree of Doctor of Philosophy and Doctor of Science in institutions of higher education (scientific institutions), approved by Resolution No. 261 of the Cabinet of Ministers of Ukraine dated March 23, 2016.
- 6. Admission to study at a creative graduate school and assistantship-internship is carried out in accordance with this Procedure and the Procedure for obtaining the educational and creative degree of Doctor of Arts and training in assistantship-internship, approved by the Resolution of the Cabinet of Ministers of Ukraine dated October 24, 2018 No. 865.

#### III. Sources of funding for higher education

1. Financingtraining of higher education applicants is carried out:

at the expense of state budget expenditures and at the expense of local budget expenditures (regional order);

for the funds of individuals and/or legal entities (on the terms of the contract, in particular, for the funds of grants received by the International Humanitarian University for conducting scientific research, which provides for the training of higher education applicants for the degree of Doctor of Philosophy);

by vouchers.

2. Citizens of Ukraine have the right to obtain higher education free of charge on a competitive basis in accordance with the standards of higher education, if a citizen obtains a certain degree of higher education for the first time at the expense of the state or local budget.

Individuals may obtain a master's degree based on the NRK7, which was obtained at the expense of the state or local budget, exclusively at the expense of individuals and/or legal entities, except for the cases provided for in clause 5 of this section.

3. A person can enter the International Humanities University to obtain a master's degree on the basis of NRK6 or NRK7 obtained under another

specialty (field of training) (taking into account the requirements of paragraphs six to ten of clause 1 of section II of this Procedure), subject to successful completion of the entrance exams. Financing of education under state or regional order is carried out within the term of education according to the curriculum of the relevant educational program.

4. Citizens of Ukraine who have not completed their studies at a state or regional order for a certain level of higher education have the right to re-enroll for free higher education at the International Humanitarian University for the same level of education, provided that the funds spent on services are reimbursed to the state or local budget for the training of specialists, in accordance with the Procedure for reimbursement of funds from the state or local budget spent on the payment of services for the training of specialists, approved by Resolution No. 658 of the Cabinet of Ministers of Ukraine dated August 26, 2015. This requirement does not apply to participants in hostilities.

Studying for obtaining a master's degree in medical, pharmaceutical or veterinary fields based on the PZSO or NRK5 is considered simultaneous study for obtaining bachelor's and master's degrees in accordance with paragraph 1 of section II of this Procedure.

5. Citizens of Ukraine have the right to obtain higher education free of chargesecond specialty:

if due to their health condition they have lost the ability to perform their official dutiesjob duties based on previously obtained qualification, which is confirmed by the conclusions of the medical and social expert commission, and in other cases provided for by law;

if they have a referral for training issued by the state (regional) customer in accordance with the legislation.

- 6. Foreigners and stateless persons, in particular Ukrainians living abroad permanently in Ukraine, citizens of the Republic of Poland, persons recognized as refugees, and persons in need of additional protection, have the right to obtain higher education on an equal basis with citizens of Ukraine, in particular at the expense of state funds or the local budget, subject to availability of places.
- 7. Persons obtaining higher education have the right to study simultaneously under several educational programs.

Simultaneous study of two or more educational programs by state or regional order is not allowed.

8. Entrants are admitted to competitive selection for state or regional order positions and may be recommended or transferred to such positions if they have a competitive score of at least 130,000. Restrictions on transfer to vacant state positions

(regional) order does not apply to persons specified in clause 10 of section VIII of this Procedure.

9. Admission to study of entrants in the specialty 293 "International Law" by state or regional order for obtaining a junior bachelor's degree in all forms of education, as well as for obtaining bachelor's, master's degrees 081 Law and 293 International law in the correspondence form of education is not carried out, enrollment (transfer) to study places by state (regional) order is not carried out.

## IV. Volumes of reception and volumes of state (regional) orders, placement of state (regional) orders

Admission to training is carried out within the licensed volume for a certain level of higher education or for a certain educational program, which provides for the assignment of professional qualifications for professions for which additional regulation has been introduced.

Admission to study under a state or regional order for interdisciplinary educational programs of the initial level (short cycle) of higher education in a field of knowledge or in a group of two specialties belonging to one or two fields of knowledge is carried out in one of these specialties at the choice of a higher education institution. Admission to study for non-budgetary competitive offers for other interdisciplinary educational programs of the initial level (short cycle) of higher education is carried out for one of their specialties (specialties of one of their fields of knowledge) at the choice of the University, for admission to which an entrance test is provided in the form of NMT or creative competition (for one of the specialties chosen by the higher education institution, if the NMT or creative competition is provided for both specialties or not provided for any of them). Admission to study in interdisciplinary educational and scientific programs of the second (master's) level of higher education is carried out at the one of them, for admission to which an entrance test is provided in the form of the EFFV (for one of the specialties chosen by the institution of higher education, if the EFFV is provided for both specialties or not provided for any of them).

Admission to state-ordered studies is carried out at the level, specialty (field of knowledge) and form of obtaining higher education, according to which it is formed by the Cabinet of Ministers of Ukraine.

The formation and placement of a state and regional order can be carried out by subject specialties and specializations in accordance with the List of orders of state customers, which define the subject specialties and specializations of individual specialties, according to which the formation and placement of a state order is carried out.

The International Humanities University carries out admissions for studies according to the state and regional order for the specialties provided for

assignment of professional qualifications for professions for which additional regulation has been introduced no later than December 31, 2022, at the expense of individuals and/or legal entities - no later than May 31, 2023.

Within the limits of the volumes of the state (regional) order formed in the prescribed manner, placement of places at the University is carried out on a competitive basis by: allocating budget places according to the decision of the competitive commission of the state (regional) customer; criterion distribution of budget places; wide competition.

Providing entrants with a recommendation for admission to study at the International Humanities University by state or regional order is based on the results of the address allocation of budget places, which are formed in the EDEB and displayed in the entrant's electronic cabinet.

The volume of acceptance for fixed and open tenders by individuals and/or legal entities is formed in accordance with the license volume of the International Humanities University and is noted in the EDEBO within the difference between the volume of acceptance for the tender offer and the total (maximum) volume of the state or regional order, if necessary provided for reserve for renewal in it or transfer to it from other institutions of higher education for obtaining higher education of the corresponding level or according to the corresponding educational program. This amount can be adjusted taking into account the actually received state (regional) order and in cases of allocation of additional places of state (regional) order, transfer to vacant places of state (regional) order and redistribution of places between forms of education, but cannot be reduced for a competitive offer in the period between the start of receiving documents and applications and the formation of the list of recommended under this proposal.

The scope of admission to a non-budget tender offer shall be determined by the University within the limits of the licensed scope for a certain level of higher education or for a certain educational program, which provides for the assignment of professional qualifications from professions for which additional regulation has been introduced.

### V. Deadlines for receiving applications and documents, competitive selection and enrollment

The day of interviews, professional entrance tests, creative contests, announcement of recommendations for enrollment is considered a working day according to the schedule of reception of citizens from 9:00 a.m. to 6:00 p.m.

2. For admission on the basis of a complete general secondary education at the expense of the state or local budget (by state or regional order) and at the expense of individuals and legal entities, the registration of entrants' electronic offices, uploading of the necessary documents begins on July 1. The document on previous education must be included in the registration of the first application of the entrant on the appropriate basis of admission. The entrant can enter several documents about previous education contained in the Register of documents about education into the electronic cabinet for registration of applications on various grounds of admission until the day preceding the day of completion of registration of applications. Personal electronic accounts of entrants are open until November 30.

Registration of entrants' applications, including for participation in entrance tests (interview, creative competition, interview instead of NMT, EVI, professional exam instead of EFVV, professional exam) in the cases provided for in the Admission Rules, is carried out through personal electronic accounts of entrants.

#### VI. The procedure for registering applications for participation in entrance tests and competitive selection for studies to obtain higher education in

#### **International humanities university**

1. To submit applications in electronic form, the entrant registers a personal electronic account in the EDEBO on the website at the address https://vstup.edbo.gov.ua/.

During registration, the entrant notes the following data:

an email address to which the entrant has access. The specified address will be the login for entering the entrant's personal electronic account;

password for entering the personal electronic account;

series and number of the document (one of the documents) about previously acquired education (the basis of admission);

number, PIN code and year of obtaining the certificate of external independent assessment (hereinafter referred to as the certificate of external independent assessment) / certificate of NMT / examination slip, which was received during registration at the EVI / EFVV. In the case of data from different years and exams, any of those provided for use on the appropriate basis of admission, determined by this Procedure, is indicated;

type and number (series and number) of the identity document or the registration number of the taxpayer's registration card (RNOKPP) (in the case of

absence certificates ZNO / certificate NMT / examination leaf EVI / EFVV);

details of documents certifying the grounds for special conditions for participation in the admissions campaign, information about which is available in state registers. A person who has grounds for special conditions for participation in the introductory campaign,

in case of unavailability of relevant documents for submission in state registers of the first application must apply to one of the institutions of higher education (in person or by e-mail, if the institution of higher education is capable of conducting a proper verification of documents remotely) and provide documents confirming the specified right, in order to create a physical person card in EDEB and upload scanned copies of these documents.

On the basis of the International Humanities University, there is a consultation center of the admissions committee (hereinafter - the consultation center) to provide assistance to applicants during the registration of a personal electronic account and submission of applications in electronic form. Entrants can contact the counseling center to resolve issues:

if there are discrepancies in the data of the entrant to EDEBO (surname, first name, patronymic (if available), date of birth, gender, citizenship, etc.), in the document on previously obtained education (basis of admission), in the data of participants of the external examination

/ NMT / EFVV / EVI.

in case of submission of a document on previously acquired education (the basis of admission), information about which is not available in the EDEBO, provided that the documents on education were issued before the introduction of photopolymer technologies for their production.

2. The data specified by the entrant, provided for in paragraph 1 of this section, are checked in the EDEBO. The data of the entrant in the document on education, contained in the Register of documents on education of EDEBO, is compared with the data of the ZNO certificate / NMT certificate / EVI / EFVV examination sheet, and in the absence of them - with the data of the identity document contained in the card of an individual in the EDEBO or specified in the order of a document about basic, complete general secondary education.

If these data match, a notification is sent to the e-mail address specified by the entrant to activate the entrant's personal electronic account. In the event that the EDEBO already has information about a person with the same data (surname, first name, patronymic (if available), date of birth), the entrant additionally notes the data of one of the documents contained in the EDEBO (series (if available)) and the number of the education document or identity document). In case of data discrepancy, the entrant receives an appropriate information message on the procedure for eliminating the discrepancy.

Activating the entrant's personal electronic account in EDEBO provides the entrant with the opportunity to access the entrant's personal electronic account on the website at the email address https://vstup.edbo.gov.ua/. Access to the entrant's personal electronic account is carried out using the login and password specified during registration. When unsuccessful

when trying to enter the entrant's personal electronic account, a corresponding message is sent to the e-mail address specified during registration.

In the personal electronic account, the entrant enters telephone numbers (mobile and/or home) with the indication of telephone codes in international format for the possibility of prompt communication between the representatives of the Admissions Committee and the entrant, and also uploads a color photo card measuring 3 x 4 cm (up to 1 MB in format jpg).

Before submitting the first application, the entrant can replace the entered phone numbers and uploaded copies of documents. If necessary, the entrant notes additional documents about previously acquired education, data of certificates of secondary education / certificate of NMT of different years in accordance with the Admission Procedure.

#### 3. Entrants to study for higher education submit applications:

in electronic form through the entrant's personal electronic account, except for the cases specified in this clause;

only in paper form (due to the impossibility of registering the entrant's personal electronic account):

in case of submission of documents by foreigners and stateless persons, exceptpersons with a certificate of permanent residence in Ukraine;

in case of submission of a foreign document on education;

in case of submission of a document on previously acquired education, issued before the introduction of photopolymer technologies for their production;

in the case of submitting an application for admission before or after the terms of operation of the electronic offices of entrants established by this Procedure;

if it is impossible to register the applicant's personal electronic account or submit an application electronically for other reasons, which is confirmed by a certificate from the admissions committee of the institution of higher education.

Entrants may submit a total of up to five applications for state or regional procurement and up to twenty applications for all sources of funding.

4. Statement in electronic form served entrant by heronline filling.

In the application, entrants indicate:

degree of higher

education; basis of

admission;

competitive proposal indicating the educational program (specialty, subject specialty, specialization, several educational programs within the specialty);

form of education; information about the entrant.

The priority is indicated in the applications for state or regional order places (at the same time, the priority indicator 1 (one) means the highest priority), the priority of the applications specified by the entrant cannot be changed.

When submitting applications for open and fixed competitive offers, entrants must specify one of the following options:

"I am applying for participation in the competition for a state or regional placeorder and to participate in the competition for places at the expense of individuals and/or legal entities in the event of not receiving a recommendation for this competitive proposal for a state or regional order";

"I apply to participate in the competition exclusively for places at the expense of individuals and/or legal entities, informed about the impossibility of transfer within the framework of the admission campaign to places of state or regional order."

When submitting applications for a non-budget tender proposal, entrants claim to participate in the competition exclusively for places at the expense of individuals and/or legal entities and are warned about the impossibility of transfer within the framework of the admission campaign to places of state or regional order, in the applications they indicate:

"I apply to participate in the competition exclusively for places at the expense of individuals and/or legal entities, informed about the impossibility of transfer within the framework of the admission campaign to places of state or regional order."

Information on familiarization of the entrant with the Admission Procedure, the existing license and certificate of accreditation of the relevant educational program (specialty) and its validity period, as well as information on the presence/absence of grounds for applying special conditions for participation in the competitive selection for studies for higher education and/or special conditions for admission to study under a state or regional order are fixed with each submitted application of the entrant.

In case of submission of documents for non-accredited educational programs (specialties), information about the entrant's familiarization with part six of Article 7 of the Law of Ukraine "On Higher Education" is recorded in the entrant's application.

The right to special conditions for participation in the competitive selection for training forobtaining a higher education and/or special conditions for admission to study according to the state or regional order, the entrant indicates in each submitted application. The text of the motivational letter is entered by the entrant to each application, if necessary, the entrant sends copies (photocopies) of materials confirming the information stated in the motivational letter to the e-mail address specified by the University. Taking into account the right to special conditions is confirmed by the International Humanities University, to which the relevant application was submitted, on the basis of the document available in the data of the natural person in the EDEBO.

Entrants who live in the temporarily occupied territory or moved from it after January 1, 2023, submit documents taking into account the features provided for by Order No. 271.

The application submitted by the entrant is displayed in the EDEBO section, to which the educational institution chosen by the entrant has access, with the status "Registered in EDEBO".

5. An application with the status of "Registered in EDEB" is considered by an authorized person of the Admissions Committee of the International Humanitarian University within three working days from the date of registration of the application in EDEB, but no later than the next day after the end of receiving documents, in the case of taking entrance exams - no later than the next day after the end of entrance exams tests Based on the results of the review, the authorized person of the Admissions Committee assigns one of the following statuses to the application, which are displayed in the applicant's personal electronic account:

"Registered at the educational institution" or "Requires clarification by the applicant."

When assigning the status "Requires clarification by the entrant" to the application, the authorized person notes the list of data that needs clarification, indicating the method and date by which they must be submitted. The entered data is displayed in the entrant's personal electronic account. After the entrant specifies the necessary data, the authorized person of the admissions committee changes the status of the entrant's application to "Registered at the educational institution".

- 6. The entrant submits the application in paper form in person to the admissions committee of the International Humanitarian University (in the case of the entrant's stay in the temporarily occupied territory or abroad remotely using electronic means of communication). The content of the application in paper form corresponds to the content of the application in electronic form. An authorized person of the University's Admissions Committee submits the information of each application in paper form to the EDEBO on the day of acceptance of the application (with a corresponding note in the case of remote application submission). The motivation letter is attached by the entrant to the application in paper form, in the EDEBO, the application data indicates the personal file number of the entrant in the educational institution where the motivation letter is contained. Electronic identification of an individual submitting such documents using an electronic signature based on a qualified electronic signature certificate is considered to be proper compliance with the requirement to establish a natural person who submits an application remotely in paper form.
- 7. The procedure for conducting the NMT, which defines the basic principles of its preparation and conduct, is developed and approved by the Ministry of Education and Science of Ukraine. The mechanism of registration of entrants to take the EFVV and EVI, their organization and conduct are determined by the Procedure for the organization and conduct of entrance tests, which are conducted using the organizational and technological processes of external independent assessment for admission to the second (master's) level of higher education, approved by the order of the Ministry of Education and Science of Ukraine dated April 5, 2019 No. 441, registered with the Ministry of Justice of Ukraine on April 26, 2019 under No. 446/33417 (as amended by the order of the Ministry of Education and Science of Ukraine dated April 12, 2021 No. 412).

Applications for participation in the entrance tests at the International Humanitarian University are submitted through the personal electronic offices of the applicants (in paper form or by e-mail to the admissions office

commission of the University in the absence of a personal electronic account of the entrant in accordance with this Procedure).

- 8. The admissions committee of the University makes a decision on admitting or not admitting an entrant to participate in the competitive selection for admission to study for higher education based on the results of consideration of the application submitted by the entrant, the documents attached to it, and the results of entrance tests. Based on the decision, the entrant's application is assigned one of the following statuses: "Admitted to the competition"; "Admitted to the competition (education at the expense of individuals and legal entities)"; "Refused by the educational institution" (indicating the reason for refusal).
- 9. The application submitted in electronic form can be canceled by the entrant in his personal electronic account before the deadline for submitting applications. In this case, one of the following statuses is assigned to the application:

"Cancelled by the entrant";

"Cancelled by the applicant (without the right to submit a new application with the same priority)."

The application in electronic form, registered in the EDEBO, may be canceled by the EDEBO technical administrator based on the decision of the EDEBO manager no later than one day before the end of the submission of applications, provided that a technical error is detected during the entry of relevant data into the EDEBO. The canceled application is considered not submitted, and the fact of such submission is canceled in the EDEBO.

The technical administrator by means of mobile communication or electronic communication informs the entrant about the cancellation of the application on the day of its cancellation, after which the entrant can submit a new application with the same priority.

An application in paper form, registered in EDEB, may be canceled by the University on the basis of the decision of the admissions committee before the end of the acceptance of study documents for applications in paper form, provided that a technical error was made during the entry of relevant data into EDEB, which is confirmed by the act of a technical error , formed in EDEBO. The canceled application is considered not submitted, and the fact of such submission is canceled in the EDEBO. With this application, the status "Cancelled by the educational institution" is assigned.

The technical administrator by means of mobile communication or electronic communication informs the entrant about the cancellation of the application on the day of its cancellation, after which the entrant can submit a new application with the same priority.

10. During the admission to study of persons who submit a document on the degree (level) of education obtained abroad, the procedure for recognizing and establishing the equivalence of this document is mandatory, which is carried out in accordance with the order of the Ministry of Education and Science of Ukraine dated May 5, 2015 No. 504 " Some issues of recognition of foreign educational documents in Ukraine", registered in the Ministry of Justice of Ukraine on May 27,

2015 under No. 614/27059.

- 11. Documents on higher spiritual education are accepted if they were obtained by persons before September 1, 2018 and on condition of submission of a certificate of state recognition of a document on higher spiritual education obtained by a person in accordance with the Procedure for State Recognition of Documents on Higher Spiritual Education, Scientific Degrees and Academic Titles issued institutions of higher spiritual education, approved by the resolution of the Cabinet of Ministers of Ukraine dated August 19, 2015 No. 652, or the decision of the academic council of the institution of higher education regarding the recognition of the corresponding document on higher spiritual education.
- 12. When submitting applications and documents for obtaining a junior bachelor's degree, a bachelor's (master's degree in veterinary field) based on NRK5 can be accepted as documents about the educational and qualification level of a junior specialist, prepared in accordance with the Resolution of the Cabinet of Ministers of Ukraine dated September 9, 2020 No. 811 "About documents on higher education (scientific degree)", as well as documents on the educational and qualification level of a junior specialist, prepared in accordance with the Resolution of the Cabinet of Ministers of Ukraine dated July 22, 2015 No. 645 "On documents on professional (vocational and technical) education of the state model and appendices to them".

## VII Competitive selection, its organization and implementation at the International Humanitarian University

1. Competitive selection for studies to obtain higher education degrees is carried out based on the results of entrance tests and/or review of motivation letters in the cases provided for in this Procedure:

for admission to study for a junior bachelor's degree, bachelor's degree (master's degree in medicine, pharmacy or veterinary fields) - in the form of NMT or ZNO, Egzamin maturalny (further - matriculation exam) for citizens of the Republic of Poland, creative competition, interview, entrance exam for foreigners, consideration of motivational letters in the cases stipulated by this Procedure;

for admission to study for a master's degree - in the form of EVI, EFVV, professional exam, interview, entrance exam for foreigners, review of motivation letters in the cases provided for in this Procedure.

In case of submission of documents for participation in entrance tests by individuals with special educational needs, the University provides suitable conditions for them to pass creative competitions, interviews, professional exams and entrance exams for foreigners.

- 2. Competitive selection is carried out on the basis of the competitive score (consideration of motivation letters) in accordance with this Admission Procedure.
- 3. For competitive selection for studies to obtain the degree of junior bachelor, bachelor (master of medicine, pharmaceutical or

veterinary field) based on the PZSO and NRK5 point(s) are counted(Appendix 4):

NMT of 2023 or

NMT of 2022,

or the 2020-2021 external examination of three competitive subjects (first, second, third subjects) for obtaining a bachelor's degree (master's degree in medicine, pharmacy or veterinary fields) based on the PZSO,

or 2020-2021 external examination in two competitive subjects (first, second subjects) to obtain a junior bachelor's degree based on the PZSO, a bachelor's (master's degree in medicine, pharmaceutical or veterinary fields) based on the NRK5;

or a creative competition in the specialties for which it is provided; matriculation exam in two main subjects (Polish language,

mathematics) and one additional subject (foreign language, or history, or biology, or physics and astronomy, or chemistry at the entrant's choice) for citizens of the Republic of Poland;

entrance exams in Ukrainian language/foreign language, mathematics - compulsory, history of Ukraine, biology, physics, chemistry, at the choice of the applicant - for foreigners.

The results of the 2020–2021 external examination in Ukrainian language and literature/Ukrainian language, mathematics, history of Ukraine, foreign language, biology, physics, chemistry, at the request of the applicant, may be counted instead of the results of the corresponding subjects of the NMT 2023 or NMT 2022, if the difference between the NMT and ZNO scores in the relevant subject does not exceed 15 points (without taking into account the difference in scores for admission to the junior bachelor's degree).

In the cases stipulated by this Procedure, the results of the interview on the same subjects are counted instead of the results of the NMT.

The transfer of NMT, EVI, matriculation exam results to the 100–200 scale is carried out in accordance with the tables given in Appendix 5. The transfer of the EFVV test scores to the 100–200 scale is carried out in accordance with the tables approved by the Ministry of Education and Science of Ukraine.

For the competitive selection of people for places exclusively at the expense of individuals and/or legal entities from specialties that are specified in the List of specialties that receive special support (Appendix 6), in accordance with the Admission Rules, only consideration of motivation letters can be used.

- 4. For competitive selection for studies to obtain a master's degree based on NRK6 and NRK7, the point(s) (Appendix 8) are counted:
  - 1) for introduction on specialty industries of knowledge 05 "Social andbehavioral sciences", 07 "Management and

administration", 08 "Law", 29

"International relations":

EVI of 2023 and EFVV of 2023;

entrance exam for foreigners in a professional exam and entrance exam in a foreign language and an additional professional exam, if entering on the basis of NRK6 or NRK7 in another specialty.

In the cases stipulated by this Procedure, instead of the results of the EVI (both components), the results of the foreign language interview are used, instead of the results of the EFFV, the result of the professional exam

2) for admission to other specialties:

EVI of 2023 and professional exam;

entrance exam for foreigners in a professional exam and entrance exam in a foreign language and an additional professional exam, if entering on the basis of NRK6 or NRK7 in another specialty.

In the cases stipulated by this Procedure, the results of the foreign language interview are used instead of the results of the EVI (both components).

For the competitive selection of people for places exclusively at the expense of individuals and/or legal entities from specialties that are specified in the List of specialties that receive special support, in accordance with the Procedure for admission based on consideration of motivation letters.

During admission to higher education exclusively for places at the expense of individuals and/or legal entities for competitive offers, which, according to this Procedure, require the completion of the EVI and/or EFVV (except for specialties 081 "Law" and 293 "International Law"), entrants on the basis of NRK7, they can, at their choice, either submit the result(s) of the EVI and/or EFVV, or take a professional exam (additional professional exam) and an entrance exam in a foreign language and a motivation letter;

4) for the competitive selection of persons who enroll in training for obtaining for the degree of Doctor of Philosophy/Doctor of Arts, the scores of the entrance exams in the specialty and the foreign language, as well as the results in philosophy and the entrance exam in the specialty in the form of exams, are counted. (Appendix 9)

An entrant who has confirmed his level of knowledge of the English language with a valid certificate of TOEFL tests, or the International English Language Testing System, or a Cambridge English Language Assessment certificate (not lower than level B2 of the All-European Recommendations on Language Education or a similar level); of the German language — a valid TestDaF certificate (not lower than level B2 of the All-European Recommendations on Language Education or a similar level); of French - with a valid DELF or DALF test certificate (not lower than level B2 of the All-European Recommendations on Language Education or a similar level), is exempt from taking the entrance exam in a foreign language. When determining the results of the competition, the specified certificates are equated to the results of the foreign language entrance exam with the highest score.

In accordance with the University's Admission Rules, those applying for the degree of Doctor of Philosophy/Doctor of Arts to postgraduate studies at

on the basis of NRK7 from a different field of knowledge (specialty) than the one specified in their diploma, additional entrance tests are established.

#### 5. The competitive score is calculated:

1) for competitive selection for studies to obtain a junior bachelor's degree, bachelor's degree (master's degree in medicine, pharmacy, or veterinary fields) based on PZSO and NRK5 based on the results of the NMT 2023, NMT 2022, matriculation exam or creative competition (in the cases provided for in this Procedure) according to the following formula:

Competition score (KB) = 
$$(K1 \times P1 + K2 \times P2 + K3 \times P3) / (K1 + K2 + K3) + OU \text{ or } KB = TC,$$

where

P1, P2, P3 – grades from the first, second and third subjects;

OU - a point for successfully completing the preparatory courses of a higher education institution in the year of admission for admission to it on a scale from 0 to 10 points in the case of admission to a specialty (specializations, subject specialties), specified in the List of specialties that receive special support. If the entrant's competitive score exceeds 200, it is set equal to 200;

TK - assessment of creative competition (in the cases provided for in this Procedure).

Weighting coefficients (K1, K2, K3) of subject evaluations for each specialty (specialization, subject specialty) are defined in Appendix 7 to this Procedure;

2) for competitive selection for studies to obtain a bachelor's degree (master's degree in medicine, pharmacy or veterinary fields) based on the PZSO based on the results of the 2020-2021 external examination in three subjects according to the following formula:

Competition score (KB) =  $(K1 \times P1 + K2 \times P2 + K3 \times P3) / (K1 + K2 + K3)$ , where

P1, P2, P3 – grades from the first, second and third subjects.

Weighting coefficients (K1, K2, K3) of subject evaluations for each specialty (specialization, subject specialty) in one of the combinations specified in the Admission Rules in 2020 for the relevant specialty (specialization, subject specialty, competitive proposal) and the source of funding upon admission on the basis of complete general secondary education;

3) for competitive selection for studies to obtain a junior bachelor's degree based on the PZSO, a bachelor's (master's degree in medicine, pharmaceutical or veterinary fields) based on the NRK5 based on the results of the 2020-2021 ZNO from two subjects according to the following formula:

Competition score (KB) =  $(K1 \times P1 + K2 \times P2) / (K1 + K2)$ ,

where

P1, P2 – grades from the first (Ukrainian language / Ukrainian language and literature) and second (mathematics, or history of Ukraine, or foreign language, or biology, or physics, or chemistry, or geography) subjects.

Weighting coefficients (K1, K2) of subject evaluations for each specialty (specialization, subject specialty) are defined in Appendix 7 to this Procedure. The weighting factor for the assessment in geography is equal to the weighting factor for the assessment in the history of Ukraine.

Individuals who are members of national teams of Ukraine and participated in international Olympiads (in accordance with the orders of the Ministry of Education and Science of Ukraine), Olympic, Paralympic and De-Olympic Games at the request of the Ministry of Youth and Sports of Ukraine, are credited with scores of 200 points in two competitive subjects of their choice entrant

Finally, the competitive score is multiplied by regional (RK) and industry(GC) coefficients by multiplying it by their product, and:

RK according to the actual location is equal to 1.00;

GC is equal to 1.02 for submitted applications with priority 1 and 2 in the specialty (subject specialties, specializations), provided for in the List of specialties that receive special support; 1.00 in other cases. If, after multiplying by coefficients, the competitive score exceeds 200,

it is set to 200.

The evaluation of the entrance exam for foreigners is the only component of the competitive examscore for this category of entrants;

4) for competitive selection for studies to obtain a master's degree based on NRK6 and NRK7:

Competition score (KB) =  $0.2 \times P1 + 0.2 \times P2 + 0.6 \times P1 + 0.0 \times P2 + 0.0 \times P1 + 0.0 \times P2 + 0.0 \times P1 + 0.0 \times$ 

P3, where

P1 – evaluation of the test of general educational competence of the EVI; P2 – evaluation of the EVI foreign language test;

P3 – evaluation of the EFVV or the evaluation of a professional exam in the cases provided for in this Procedure.

The evaluation of the entrance exam for foreigners is the only component of the competitive examscore for this category of entrants;

5) in other cases, the competitive score is calculated as the sum of points for entrance tests and other competitive selection indicators in accordance with the Admission Rules.

The principle of equality of rights of entrants must be observed for the different number of components in the competitive ball.

8. The minimum value of the number of points from the entrance tests (competition score) with which the entrant is allowed to participate in the competitive selection for non-budgetary competitive proposals based on the PZSO and NRK5 is 100 points, for places ordered by the state from 130.00 points, except for specialties:

The competitive score for admission on the basis of PZSO and NRK5 cannot be less than 150 points for specialties 221 "Dentistry", 222 "Medicine", 228 "Pediatrics" of the field of knowledge 22 "Health care".

The competitive score for admission on the basis of PZSO and NRK5 cannot be less than 140 points (120 points for admission to places at the expense of individuals and/or legal entities) for specialties in fields of knowledge 08 "Law", 28 "Public management and administration", 29 "International relations", specialties 226 "Pharmacy, industrial pharmacy".

9. The test tasks of the main unit of the NMT are compiled in accordance with the programs of external independent evaluation of the results of knowledge in the relevant subjects on the basis of complete general secondary education (according to the program of external independent evaluation of the results of studies in the Ukrainian language and literature (part "Ukrainian language"), to the program of external independent evaluation learning results in mathematics, obtained on the basis of complete general secondary education, approved by the order of the Ministry of Education and Science of Ukraine dated December 4, 2019 No. 1513).

The test tasks of the additional block of NMT on the history of Ukraine, a foreign language, physics, chemistry and biology are completed in accordance with the programs of external independent evaluation of the results of knowledge in the relevant subjects based on complete general secondary education (according to the program of external independent evaluation of the results of studies in the history of Ukraine (chapters 1, 6–32), to the program of external independent evaluation of foreign languages, to the program of external independent evaluation of chemistry, to the program of external independent evaluation of learning results in physics, approved by order of the Ministry of Education and Science of Ukraine dated June 26, 2018 No. 696, to the program external independent evaluation of the results of studies in biology, approved by the order of the Ministry of Education and Science of Ukraine dated December 20, 2018 No. 1426).

The test tasks of the general educational competence test of EVI are concluded in accordance with the Program of the general educational competence test of the single professional entrance test for admission to study for the master's degree, approved by the order of the Ministry of Education and Science of Ukraine dated February 11, 2022 No. 158.

The test tasks of the EVI foreign language test are compiled in accordance with the Program of the single entrance exam in foreign languages for admission to study for a master's degree based on the obtained degree of higher education (educational and qualification level of a specialist), approved by the order of the Ministry of Education and Science of Ukraine on March 28, 2019 No. 411.

List of EFVV subject tests for specialties of fields of knowledge 05 "Social and behavioral sciences", 07 "Management and administration", 08 "Law", 29 "International relations" is given in appendix 8. Test tasks EFVV are concluded in accordance with the Program of the subject test of the unified professional entrance test for admission to specialties 081 "Law" and 293 "International Law", approved by order of the Ministry of Education and Science

of Ukraine dated February 3, 2022 No. 107, Programs of the subject test in economics and international economics of the single professional entrance test for admission to study for a master's degree, approved by the order of the Ministry of Education and Science of Ukraine dated February 11, 2022 No. 153, Programs of the subject test in accounting and finances of the single professional entrance test for admission to study for a master's degree, approved by the order of the Ministry of Education and Science of Ukraine dated February 11, 2022 No. 154, Program of the subject test in political science and international relations of the single professional entrance test for admission to study for the master's degree, approved by the order of the Ministry of Education and Science of Ukraine dated February 11, 2022 No. 155, the program of the subject test in psychology and sociology of the unified professional entrance test for admission to study for a master's degree, approved by the order of the Ministry of Education and Science of Ukraine dated February 11, 2022 No. 156, Programs of the subject test for the management and administration of the single professional entrance test for admission to study for a master's degree, approved by the order of the Ministry of Education and Science of Ukraine dated February 11, 2022 No. 157.

10. Interviews for subjects for entrants on the basis of PZSO and NRK5, which they pass instead of NMT, are held according to the programs of vocational training. Interviews in a foreign language for applicants for a master's degree based on NKR6 and NRK7 are conducted according to the EVI program in foreign languages. The head of the admissions committee approves the evaluation procedure based on the results of the interview, which includes the structure of the final score.

Programs of interviews, creative competitions, professional exams, programs of other entrance tests approved by the head of the admissions committee are posted on the university's website. It is not allowed to include in creative contests tasks that go beyond the limits of the specified programs.

The criteria for evaluating motivational letters are placed in the Regulation on writing a motivational letter.

In conducting a competitive selection using motivational letters, the University checks the motivational letters for the originality of the text and provides access to the results of such verification to the Commissioner for Prevention and Detection of Corruption (hereinafter - the Commissioner).

11. Persons who, without valid reasons (recognized as such by the decision of the Admissions Committee), did not appear for entrance tests at the time specified in the schedule, persons whose knowledge was assessed with scores below the minimum value established by the Admission Rules, to participate in subsequent entrance tests and competitive selection are not allowed. Retaking entrance exams is not allowed.

- 12. Appeals on the results of entrance tests conducted by the University are considered by the University's appeals commission.
- 13. Information about the results of entrance examinations and other competitive indicators is entered into the record of the entrant at the University of Ukraine, information about the results of entrance examinations at the University may be additionally published on the official website.
- 14. By the decision of the admissions committee, the results of entrance tests at the university for a certain competitive offer may be counted upon the applicant's application to participate in the competitive selection for another competitive offer at the University.

## VIII Special conditions for the participation of entrants in admission campaigns during admission to the International Humanitarian University

1. Special conditions for participation in the introductory campaign are: special conditions for participation in the competitive selection for training for obtaininghigher education;

special conditions for admission to studies by state or regional order.

Special conditions for admission to studies under a state or regional order apply to the levels, specialties and forms of obtaining higher education, according to which it was formed in accordance with the procedure established by law.

2. A necessary condition for the application of special conditions for participation in the entrance examination of the campaign is the presence of an individual's card in the EDEBO with an indication of the preferential category and the entry of supporting data (details of documents certifying the right to special conditions for participation in the admission campaign, or uploaded scanned copies of such documents in the event of the absence (inaccessibility) of information about them in state registers), as well as indicating in the entrant's application the need to apply special conditions.

Special conditions for admission to studies by state or regional order apply: only to applications for open and fixed tenders;

if the entrants did not receive a recommendation for places of state or regional order;

with the exception of cases where the application states: "I am applying for participation in the competition exclusively for places at the expense of individuals and/or legal entities, notified of the impossibility of transfer within the scope of the admission campaign to places of state or regional order."

3. The special conditions for participation in the competitive selection for higher education based on PZSO or NRK5 are:

participation in the competitive selection based on the results of only the creative competition (for the specialties specified in Appendix 1) or only the interview (for other specialties) with the possibility of enrolling in studies based on the received positive evaluation;

participation in the competitive selection for training based on the results of the interview instead of the results of the NMT or creative competition (for specialties specified in Appendix 1).

Special conditions for participation in the competitive selection for studies to obtain a master's degree based on NRK6 or NRK7 are participation in the competitive selection for studies based on the results of a foreign language interview instead of the EVI and/or a professional exam instead of the EFVV.

4. The special conditions for admission to study under a state or regional order on the basis of PZSO or NRK5 are:

admission to places of state or regional order based on the results of a positive assessment of entrance tests, participation in the competition for quota-1, quota-2;

transfer to vacant positions of the state or regional orderpersons who are enrolled in studies based on other sources of funding for an open or fixed competitive offer, in the cases provided for in this Procedure.

The special conditions for admission to study for a master's degree under state or regional order based on NRK6 or NRK7 are the transfer to vacant places of state or regional order of persons who are enrolled in studies under other sources of funding for an open or fixed competitive offer, in the cases provided for in this Procedure .

5. Special conditions for participation in the competitive selection for higher education based on the PZSO or NRK5 in the form of participation in the competitive selection based on the results of only the creative competition (for the specialties specified in the appendix1 or only the interview (for other specialties) with the possibility of enrolling in studies on the basis of received a positive assessment

and/or

special conditions for admission to study under a state or regional order on the basis of PZSO or NRK5 in the form of enrollment on the basis of a positive evaluation of only a creative competition (for the specialties specified in Appendix 1) or only an interview (for other specialties) are used by:

persons with disabilities due to war in accordance with Article 7 of the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social Protection";

persons, as defined by the Law of Ukraine "On the status and social protection of citizens, who suffered as a result of the Chernobyl disaster" is granted the right to

admission without exams to state institutions of higher education based on the results of an interview;

persons with disabilities who are unable to attend an educational institution (on the recommendation of public health and social protection authorities).

6. Special conditions for participation in the competitive selection for studies for higher education based on PZSO or NRK5 in the form of participation in the competitive selection for studies based on the results of an interview instead of the results of the NMT or creative competition (for specialties specified in Appendix 1), special conditions for participation in the competitive selection to study for a master's degree on the basis of NRK6 or NRK7 in the form of participation in a competitive selection for studies based on the results of an interview in a foreign language instead of the EVI and/or a professional exam instead of the EFVV are used:

persons recognized as injured participants of the Revolution of Dignity, participants in hostilities in accordance with the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social Protection", in particular those of them who are undergoing military service (except conscripts) in the manner determined by the relevant provisions on the passage military service by citizens of Ukraine;

persons who, according to the decision of the regulatory commission at the regional center for the assessment of the quality of education, were refused registration for participation in the 2023 NMT examination of the entrant's documents, carried out at the request of the admissions committee, which registers) due to the impossibility of creating special (special) conditions (on the condition that a copy of the medical opinion is entered into the physical person's card in the form of primary accounting documentation No. 086-3/o "Medical opinion on the creation of special ( special) conditions for passing an external independent assessment", approved by the order of the Ministry of Education and Science of Ukraine, the Ministry of Health of Ukraine dated August 29, 2016 No. 1027/900, registered in the Ministry of Justice of Ukraine on December 27, 2016 under No. 1707/29837 (hereinafter - orderNo. 1027/900), which is certified by the signature of the secretary of the regulatory commission at the regional center for the assessment of the quality of education and the seal of the regional center for the assessment of the quality of education, and the corresponding extract from the minutes of the meeting of the regulatory commission at the regional center for the assessment of the quality of education);

persons who, upon request regarding the possibility of creating special conditions for passing NMT, EVI, EFVV by the regulatory commission at the regional center for evaluating the quality of education, were refused to create them due to the lack of organizational and technological capabilities (provided that the corresponding extract from the protocol of the meeting of the regulatory commission is entered in the physical person's card at the regional center for evaluating the quality of education and medical opinion, which states the need to create certain

conditions for passing the NMT, a medical opinion, which states the need to create certain conditions for completing the EVI, EVVV);

persons with disabilities or children with disabilities who in 2023 did not participate in the main and additional sessions of NMT, EVI, EFVV due to the presence of a disease or pathological condition specified in the List of diseases and pathological conditions, which may be an obstacle to passing an external independent assessment, approved by order No. 1027/900, (provided that a document (its copy) certifying the status of a person with a disability or a child with a disability and one of the documents specified in subparagraph 1 of paragraph 2 of the order is submitted to the admissions committee of the institution of higher education

No. 1027/900, or copies of such a document);

7. Special conditions for participation in the competitive selection for higher education based on PZSO or NRK5 in the form of participation in the competitive selection for training based on the results of an interview instead of the results of the NMT or creative competition (for specialties defined in Appendix 1),

and/or

special conditions for admission to studies under state or regional order on the basis of PZSO or NRK5 in the form of participation in a competition for places under state or regional order under quota-2 are used by:

persons whose place of residence is registered (declared) in the temporarily occupied territory, the territory of settlements on the contact line and the administrative border or who moved from it after January 1, 2023.

8. Special conditions for admission to studies under state or regional order on the basis of PZSO or NRK5 in the form of participation in a competition for places under state or regional order under quota-1 are used by:

the persons specified in paragraphs two to five of item 6 of this section; persons with disabilities or children with disabilities who participated in 2023

in the main and additional sessions of the NMT, in which there is a disease or a pathological condition, specified in the List of diseases and pathological conditions that may be an obstacle to passing an external independent assessment, approved by No. 1027/900, (provided that a document is submitted to the admissions committee of the institution of higher education (its copies) certifying the status of a person with a disability or a child with a disability and one of the documents specified in subparagraph 1 of paragraph 2 of Order No. 1027/900);

orphans, children deprived of parental care, persons from among them.

9. Persons who use the special conditions of admission to study under a state or regional order based on PZSO or NRK5, to obtain a master's degree based on NRK6 or NRK7 in the form of enrollment on the basis of a positive assessment of entrance tests, participation in the competition for places

state orof a regional order under quota-1 or quota-2, and were not recommended for a place in a state (regional) order under the relevant special conditions, have the right to participate in the competition on general terms in accordance with the competition score.

10. Special conditions for admission to study under a state or regional order based on PZSO or NRK5, for obtaining a master's degree based on NRK6 or NRK7 in the form of mandatory transfer to vacant places of state or regional order of persons who are enrolled in studies based on other sources of funding for an open or fixed competitive offer, use:

children of dead (deceased) persons, defined in the first part of Article 101 of the Law of Ukraine "On the Status of War Veterans, Guarantees of Their Social Protection", persons from among them;

persons, one of whose parents died or died as a result of wounds, mutilation, contusion or other health damage received during participation in the Revolution of Dignity;

persons, one of whose parents is a participant in hostilities on the territory of other states, who was killed (missing) or died as a result of injury, contusion or mutilation received during hostilities and conflicts on the territory of other states, as well as as a result of a disease related to with a stay on the territory of other states during these actions and conflicts;

persons in whom one of the parents (adoptive parents) was a military serviceman who died or was recognized by the court as a missing person while performing his military service duties;

persons in whom one of the parents (adoptive parents) was a police officer who died or was recognized by the court as an unaccountably missing person during the performance of his official duties, within three years after obtaining the appropriate general secondary education (for admission on the basis of PZSO or NRK5).

11. Special conditions for admission to study under a state or regional order based on PZSO or NRK5, for obtaining a master's degree based on NRK6 or NRK7 in the form of transfer (if there are places) to vacant places of state or regional order of persons who are enrolled in studies based on other sources of funding for an open or fixed competitive offer, use:

persons with disabilities of I, II groups and children with disabilities under the age of 18, who are not contraindicated to study in the chosen specialty;

persons with disabilities from among participants in the liquidation of the consequences of the accident at the Chernobyl NPP and victims of the Chernobyl disaster, for whom a causal connection of disability with the Chernobyl disaster has been established, patients suffering from radiation sickness as a result of the Chernobyl disaster (category 1) and persons who permanently lived in the zone of unconditional (mandatory) resettlement from the moment of the accident to the adoption of the decision on resettlement (category 2);

children of persons, persons from among them who in the year of admission obtained the educational level on the basis of which admission takes place, recognized as injured participants of the Revolution of Dignity, participants in hostilities, persons with disabilities as a result of the war, in accordance with the Law of Ukraine "On the Status of War Veterans, Guarantees of Their social protection";

miners who have at least three years of underground work experience, as well as within three years of completing general secondary education, persons whose parents are miners and have at least 15 years of underground work experience, or who died as a result of an industrial accident or became persons with group I or II disability;

the persons specified in paragraphs three to four of item 8 of this section; persons specified in the second paragraph of clause 6, clause 7 of this section; persons who are internally displaced persons according to the Law of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons"; children from large families (five or more children).

12. Special conditions for participation in the competitive selection for studies for obtaining the degree of Doctor of Philosophy for participation in the competitive selection for studies based on the results of an interview instead of entrance exams and a research proposal are used by:

persons who are participants in hostilities in accordance with the Law of Ukraine "On the status of war veterans, guarantees of their social protection".

## IX Ranking lists of entrants and recommendations for admission to the International Humanities University

1. The ranking list of entrants is formed by categories and funding sources in the following sequence:

entrants, who use the special conditions for admission to study under a state or regional order based on PZSO or NRK5 in the form of enrollment on the basis of a positive assessment of entrance tests;

entrants who usespecial conditions for admission to studies under state or regional order on the basis of PZSO or NRK5 in the form of participation in a competition for places under state or regional order under quota-2;

entrants who use the special conditions for admission to studies under a state or regional order based on the PZSO or NRK5 in the form of participation in a competition for places under a state or regional order under quota-1;

entrants who participate in the competitive selection for studies on general terms.

2. List of entrants who use the special conditions for admission to study by state or regional order based on the PZSO or NRK5 in the form of enrollment based on the received positive evaluation based on the results of only the creative competition (for the specialties specified in Appendix 1) or only the interview (for other specialties), arranged alphabetically.

Within the limits of other categories specified in clause 1 of this section, the ranked list of entrants is ordered:

according to the competitive score (if available) - from higher to lower;

according to the priority of the application from the first to the last (for places according to the state and regional order);

according to the grade from the subject that is taken into account with the largest weighting coefficient, in the case of two or more subjects with the same largest weighting coefficients - from the subject with a lower number (for entrants based on PZSO and NRK5) (if available) - from larger to smaller;

according to the result of the EFFV or the interview instead of the EFFV in the cases stipulated by this Procedure (for entrants based on NRK6 and NRK7, for which it is used in the competitive score) - from higher to lower;

based on the result of the EVI general educational competence test or a foreign language interview instead of the EVI in the cases provided for in this Procedure (for entrants based on NRK6 and NRK7, for which the EFFV is not used in the competitive score) - from higher to lower;

according to the results of consideration of motivation letters (when forming a rating list of a wide competition, entrants to whom higher education institutions have determined the same ranking places based on the results of consideration of motivation letters have the same rights - first, second, third, etc., provided that they have the same ranking indicators of the highest order).

If the competition scores are the same, the priority of the applications from the first to the last (for places of state and regional order) is used to organize the ranking list of entrants, if the priorities are the same - higher grades in the cases provided for in this paragraph, then - the results of the review of motivation letters.

When conducting a competitive selection for training at the expense of individuals and legal entities based only on the results of consideration of motivation letters, the construction of a rating list based on the results of evaluation of motivation letters is carried out only in the case when the number of entrants exceeds the number of places of the licensed volume allocated for the corresponding category of entrants in the current year. In the event that the number of entrants does not exceed the number of allocated seats of the licensed volume, the ranking list is formed in alphabetical order.

#### 3. The ranked list of entrants includes:

degree of higher education, specialty, name of the competitive proposal, formeducation, sources of funding, basis of admission;

surname, first name, patronymic (if available) of the entrant;

competitive score of the entrant (except for those enrolled on the basis of a positive evaluation based on the results of only the creative competition (for the specialties specified in Appendix 1) or only the interview (for other specialties)) in case of its use;

application priority (for places under state and regional order);

a sign of the application of special conditions for participation in the admission campaign, quotas for foreigners.

Surnames of entrants whose place of residence is the temporarily occupied territory, the territory of settlements on the contact line and the administrative border (who are not registered as internally displaced persons) or who moved from it after January 1, 2023, are subject to encryption in all information systems.

- 4. Address allocation of budgetary places for admission to study for higher education is formed in the EDEBO on the basis of competitive scores, priorities and arrangement of the ranked list of entrants taking into account the total, maximum volumes, qualification minimum of the state order. An entrant may be recommended for enrollment according to the highest priority from among those indicated by him in the applications, according to which the entrant is among those who can be recommended for enrollment in places by state (regional) order, in accordance with his competitive score. The technical task for the implementation of the targeted allocation of budget places is formed in accordance with the Materials for the development of the technical task for the algorithm of the targeted allocation of budget places in 2023.
- 5. Lists of entrants recommended for enrollment by state or regional order for each competitive offer are received by the admissions commission according to the data of EDEB, are checked for the authenticity of the information submitted by the applicants and compliance with the requirements for the formation of lists provided for in this Procedure, are approved by the decision of the admissions commission and are made public by placing them on the website of the University in accordance with the terms specified in section V of this Procedure. Information on providing a recommendation for enrollment is displayed in the applicant's personal electronic account. Entrants recommended for enrollment may be notified by electronic and mobile communications in accordance with the Admission Procedure.

The application status of an entrant recommended for enrollment by state (regional) order changes from the status "Admitted to the competition" to the status "Recommended for enrollment (education by state (regional) order)".

In the list of entrants, recommended to enrollment, are noted the same data as in the ranking list of entrants in accordance with paragraph 3 hereof section

#### H. Implementation of the right of entrants to choose a place of study

1. Persons who received a notification in the entrant's personal electronic account about receiving a recommendation for enrollment in state or regional order places (who received information from the official website) within the time limit specified for fulfilling the requirements for enrollment in state or regional order places in section V of this Procedure, must confirm the choice of place of study in the electronic office with the imposition of a qualified electronic signature or in person at the International Humanitarian University.

The basis for enrolling a person for study is confirmation of the choice of the place of study, fulfillment of the requirements for enrollment and the conclusion of an agreement (contract) on study at the International Humanitarian University between the educational institution and the student (with the participation of parents or legal representatives

- for minor entrants), in which the rights and obligations of the parties may be detailed. An agreement (contract) on training can be concluded remotely with qualified electronic signatures.

Persons whose place of residence is registered (declared) in the temporarily occupied territory and are located there may conclude a study contract at the International Humanitarian University within three months after the start of studies, and its absence does not prevent the inclusion of such persons in the enrollment order. Otherwise, the enrollment order is canceled in terms of the enrollment of such a person.

2. Persons who have received a recommendation for a place of state or regional order and have fulfilled the requirements for enrollment in a place of state or regional order within the established terms specified in section V of this Procedure or in accordance with it, are subject to enrollment.

After the entrant fulfills the requirements of this Procedure, the authorized person changes the status of the entrant's electronic application to "Included in the order (training under the state (regional) order)", the status of his other applications submitted for open and/or fixed competitive offers for admission to training under the state or by regional order, automatically changes to

"Deactivated (in connection with enrollment in studies by state (regional) order)".

Deactivated applications can be activated (if necessary) by the EDEBO user, in particular a representative of the Admissions Committee, at the request of the entrant to establish the status of applications "Admitted to the competition (education at the expense of individuals and/or legal entities)"

Persons who have received a recommendation for places of state or regional order and have not confirmed the choice of a place of study within the period specified for fulfilling the requirements for enrollment in places of state or regional order in section V of this Procedure, lose the opportunity

enrollment in the current year for studies to obtain higher education by state or regional order or transfer to such places.

In this case, the status of the application is set to "Excluded from the list of recommended (education by state (regional) order)". According to the decision of the admissions committee, this status of the application can be changed to status "Admitted to the competition (education at the expense of individuals and/or legal entities)".

3. Persons who have received a recommendation for enrollment in studies at the expense of individuals and legal entities and have met the requirements for enrollment are subject to enrollment.

The application status of an entrant recommended for enrollment at the expense of individuals and/or legal entities changes from the status "Admitted to the competition" or the status "Admitted to the competition (education at the expense of individuals and/or legal entities)" to the status "Recommended for enrollment (education at the expense of individuals and/or legal entities)".

After the entrant fulfills the requirements of this Procedure, the authorized person changes the status of the entrant's application to "Included in the order (education at the expense of individuals and/or legal entities)".

In case of non-compliance by the entrant whose application has been assigned status

"Recommended for enrollment (education at the expense of individuals and/or legal entities)", the requirements of this Procedure, the status of the application is changed to

"Excluded from the recommended list (education at the expense of individuals and/or legal entities)".

4. In the case of enrollment for studies at the expense of individuals and/or legal entities, a contract is additionally concluded between the International Humanities University and a natural (legal) person who orders a paid educational service for himself or another person, assuming financial obligations for its payment.

If agreements (contracts) are not concluded within ten calendar days (three months for entrants whose place of residence is registered (declared) in the temporarily occupied territory and who are located there) from the date of issuance of the enrollment order, then this order is canceled in terms of the enrollment of such persons

Tuition is paid in accordance with the agreement (contract) between the University and a natural (legal) person who orders a paid educational service for himself or another person, assuming financial obligations for its payment.

- 1. The Admissions Committee cancels the previously provided recommendations to entrants who did not confirm the choice of a place of study within the period specified for the fulfillment of the requirements for admission to places of state or regional order in section V of this Procedure, or did not fully provide the grounds for enrolling a person for study, provided for in clause 1 of section X of this Procedure.
- 2. Lists recommended for admission to the places of the state (regional) order are updated after the fulfillment/failure of the entrants for the degree of Doctor of Philosophy/Doctor of Arts for admission to study in accordance with Section X of this Procedure, taking into account their priority in the ranked list of entrants.
- 3. The procedure for adjusting the list of recommended for admission to places at the expense of individuals and/or legal entities is updated after the entrants fulfill/fail to fulfill the conditions for enrollment.

### XII Transfer to vacant places of state (regional) order of persons who are enrolled in studies at the expense of individuals and/or legal entities

- 1. The International Humanities University independently provides recommendations for the targeted allocation of budget places to entrants within the limits of the places for which recommendations were given before admission to the University according to the relevant competitive proposal in the manner provided for in clause 4 of section IX of this Procedure, and subsequently canceled in accordance with clause 1 of section XI of this In order.
- 2. Persons who did not receive recommendations for admission to state (regional) order positions in accordance with this Procedure may be transferred to vacant state (regional) order positions.
- 3. The transfer to vacant positions of the state (regional) order of persons who are enrolled for training at the expense of individuals and/or legal entities is carried out taking into account the requirements of clause 8 of section III of the Procedure in the following sequence (except for non-budgetary tenders):

persons specified in Clause 10 of Section VIII of this Procedure, regardless of the competitive score;

the persons specified in the sixth paragraph of clause 11 of section VIII of this Procedure; persons specified in the second to fifth paragraphs of Clause 11 of Chapter VIII of this Procedure, if their competitive score is lower than the passing score (the minimum score that made it possible to receive a recommendation for enrollment on places state orderlenience by this one competitiveby a general tender offer in accordance with the procedure provided for in clause 5 of section IX of this Procedure) by no more than 15 points (by 25 points for

specialties specified in the List of specialties that receive special support);

persons specified in the seventh to ninth paragraphs of Clause 11 of Section VIII of this Procedure, if their competitive score is less than the passing score by no more than 15 points (only for specialties specified in the List of specialties that receive special support);

persons who did not receive a recommendation for admission to a state (regional) order in accordance with the procedure provided for in clause 5 of Section IX of this Procedure (only for specialties specified in the List of specialties that receive special support), if their competitive score is not less than a special passing grade the competitive score established by the admissions committee the day after the announcement of the address placement of budget places.

The transfer to vacant positions of the state (regional) order of the persons specified in paragraphs three to six of this clause is carried out in the absence of non-transferred persons of the previous category or in case of their officially recorded refusal to transfer and in the sequence from the highest to the lowest place in the rating list within each from the specified categories.

- 4. In the absence of a sufficient number of places for transfer to vacant places of the state (regional) order, the University uses for this purpose the vacant places of the state (regional) order from other specialties of this field (only for the persons specified in paragraphs two to five of clause 3 of this section), and in their absence other fields of knowledge (only for the persons specified in the second and third paragraphs of point 3 of this section) of this or another form of education (after transfer to vacant positions of the state order of the persons specified in point 3 of this section according to the relevant specialty and form obtaining an education), which is immediately reported to the relevant state (regional) customer.
- 5. Persons who have entered based on the results of consideration of motivation letters only, may be transferred to places of state or regional order only in the event of having the competitive score necessary for participation in the competition for places under state (regional) order, which can be determined in accordance with this Procedure.

#### XIII. Enrollment order

1. Enrollment orders are issued by the head of the International Humanitarian University based on the decision of the admissions committee. Enrollment orders with their annexes are formed in the EDEBO and published on the university's website in the form of a list of those enrolled within the terms established in section V of this Procedure or in accordance with it.

2. The admission commission's decision to enroll an entrant may be revoked by the admission commission in case of detection of violations by the entrant, provided for in Clause 5 of Chapter XVI of this Procedure. The enrollment order is canceled in the part that concerns this entrant.

Enrolled persons may be removed from the order of admission to the University at their own request (the order of enrollment is canceled in the part that concerns this person).

3. If a person, without valid reasons, does not start classes within 10 calendar days from the date of their start, the enrollment order is canceled in the part that concerns this person.

If a person who has not completed studies under a state or regional order for a certain degree of higher education and received a recommendation for admission to state (regional) order places in accordance with the procedure provided for in clause 5 of Section IX of this Procedure, however, has not started studies in connection with the impossibility of reimbursement to the state or local budget of funds spent on the payment of specialist training services, in accordance with the Procedure for reimbursement of state or local budget funds spent on the payment of specialist training services, approved by Resolution No. 658 of the Cabinet of Ministers of Ukraine dated August 26, 2015, order on enrollment is canceled in the part that concerns this person.

In case of cancellation of the enrollment order in the part concerning the entrant, the status of the application changes from the status "Included in the order (by state (regional) order)" or "Included in the order (education at the expense of individuals and/or legal entities)" to the status "Enrollment canceled."

4. The place(s) vacated in accordance with the procedure provided for in clauses 2 and 3 of this section will be used by the University to transfer to vacant places of the state (regional) order persons enrolled in studies at the expense of individuals and/or legal entities, in accordance with clauses 3, 4 of Chapter XII of this Order.

#### Rules of admission to graduate school International Humanitarian University 1. Terms

- **1.1.**The postgraduate course of the International Humanitarian University (hereinafter the University) is the main form of training for specialists with the educational and scientific degree of Doctor of Philosophy. Educational activities at the University's graduate school are carried out in accordance with the license of the Ministry of Education and Science of Ukraine (Order of the Ministry of Education and Science of Ukraine dated 04.03.2021 No. 26-l), (Order of the Ministry of Education and Culture dated March 28, 2023 No. 102-l) and admission rules approved by the academic council of the University.
- 1.2 The Rules of Admission to Postgraduate Studies of the International Humanities University (hereinafter the Rules of Admission to Postgraduate Studies) are an integral part of the Rules of Admission to International Humanitarian Universities in 2023 (hereinafter the Rules of Admission) developed by the Admissions Committee of the International University of Humanities (hereinafter the Admissions Committee) in accordance with the Admission Procedure to institutions of higher education in 2023 (further
- Admission procedure), approved by Order No. 276 of the Ministry of Education and Science of Ukraine on March 15, 2023.

Admission to postgraduate study is carried out in accordance with the Procedure for the training of higher education holders of the degree of Doctor of Philosophy and Doctor of Sciences in institutions of higher education (scientific institutions), approved by Resolution No. 261 of the Cabinet of Ministers of Ukraine dated March 23, 2016.

**1.3** Persons who have obtained a higher education with a master's degree are admitted to postgraduate studies on a competitive basis. Persons who have timely submitted all the necessary documents for admission in accordance with the University's admission rules are admitted to the entrance exams. The Admissions Committee may deny admission to a person to pass entrance exams to graduate school solely in connection with failure to submit documents specified in the admissions rules within the prescribed period.

- **1.4**It is prohibited simultaneous teaching on daytime form teaching inpostgraduate studies of the University in several specialties.
- **1.5**University carries out reception in graduate school by specialties, specified in table 1.

**1.6.** The deadlines for accepting applications and documents, conducting entrance tests, competitive selection and enrollment for study of entrants to postgraduate studies of the University are carried out within the terms established by the Admissions Committee of the University in accordance with the Admission Rules:

#### The first stage:

- ➤ submission of applications for admission to the competition from April 10, 2023 to May 5, 2023;
- > entrance tests from May 8 to May 15, 2023

- the deadline for publishing the ranked list of entrants is May 16, 2023;
- the deadline for enrolling entrants is May 18, 2023.

#### The second stage:

- ➤ submission of applications for admission to the competition from May 19, 2023 June 2, 2023
- > entrance tests from June 5 to June 12, 2023;
- the deadline for publishing the ranked list of entrants is June 13, 2023;
- the deadline for enrolling entrants is June 15, 2023.

#### The third stage:

- ➤ submission of applications for admission to the competition from July 3, 2023 July 28, 2023
- right entrance tests from July 31, 2023 to August 9, 2023;
- > the deadline for publishing the ranked list of entrants is August 10, 2023;
- > the deadline for enrolling entrants is August 14, 2023.

#### The fourth stage:

- > submission of applications for admission to the competition from August 14, 2023 to August 29, 2023
- > entrance tests from September 1, 2023 to September 11, 2023;
- the deadline for publishing the ranked list of entrants is September 12, 2023;
- > the deadline for enrolling entrants is September 15, 2023.

#### The fifth stage:

- ➤ submission of applications for admission to the competition from September 25, 2023 to October 20, 2023
- right entrance tests from October 23 to October 31, 2023;
- ➤ the deadline for publishing the ranked list of entrants is November 1, 2023;
- ➤ Enrollment deadline is November 3, 2023.

#### Sixth stage:

- ➤ submission of applications for admission to the competition from November 1, 2023 to November 17, 2023
- > entrance tests with November 20, 2023 until November 27, 2023;
- ➤ the deadline for publishing the ranked list of entrants is November 28, 2023;
- > the deadline for enrolling entrants is November 30, 2023.

- **1.7.** Commissions are created by a corresponding order to conduct entrance exams for postgraduate studies.
- **1.8.** Persons who have previously completed a full course of training at a postgraduate or doctorate program under a state order, as well as those who have been expelled from it early for committing illegal actions or failing to fulfill an individual plan, do not have the right to re-enter the postgraduate program.
- **1.9.** Entrance tests for persons with special educational needs are conducted taking into account the special educational needs indicated in the applicant's application and the recommendations of the medical and social examination.

## 2. The procedure for accepting applications and documents for admission to postgraduate studies at the International Humanitarian University.

- **2.1** Entrants to the postgraduate program of the University personally submit the following documents in paper form to the admissions committee (with the consent of the University or in the case of the entrant staying in the temporarily occupied territory remotely using electronic means of communication):
- 1) an application addressed to the rector indicating the specialty, form of study (full-time, non-postgraduate or part-time);
- 2) statement about admission to drafting introductory exams in graduate school;3)a document certifying identity and citizenship (in accordance with Article 5 of the Law of Ukraine "On Citizenship of Ukraine") and its copy;
- **5**)a copy military accountant document (for troops obliged a military ticket or a temporary certificate of a conscript, and for conscripts a certificate of registration at conscription stations); 6) a state document (original or notarized) about the previously acquired master's (specialist) educational and qualification level, on the basis of which admission is made, and an appendix to it and their copies or a document with appendices (in the case when they are provided for) and their copies of the degree (level) of education obtained abroad.

A person who submits a diploma issued by a foreign institution of higher education for admission to postgraduate studies is admitted to the entrance exams on an equal basis with other persons. Enrollment of such an applicant is carried out if he successfully passes the entrance exams and the academic council of the University makes a decision to recognize his diploma.

For admission to postgraduate studies in the field of medicine, the entrant submits a master's degree indicating the relevant specialty in the field of medicine.

- 7) the recommendation of the Academic Council of the relevant university regarding admission to postgraduate studies (if available);
- 8) a description-recommendation from the last place of work (for those who work, on a form);
- 9) protocol of the interview with the future scientific supervisor, who gives consent to conduct scientific supervision of the graduate student (on a form);
- **10**) TOEFL test certificate, or International English Language Testing System, or Cambridge English Language Assessment certificate(in the presence)
- 11) a certificate issued by the preparatory department of the University based on the results of the course of preparation for taking the international exam, which corresponds to level B2 of the All-European recommendations on language education and its copy;
- 12) a list of published scientific works and inventions (if available);
- **13**) a research proposal of an entrant to graduate school on the topic of a future dissertation study;
- 14) response to the research proposal of the plannedresearch supervisor;
- 15) four color photos measuring 3x4 cm;
- 16) personnel record sheet;
- 17) a copy of the work book (if available);
- 16) autobiography;
- 17) a copy of the registration number of the taxpayer's account card (if absent, a copy of the passport page with a note on the right to make payments by series and passport number is submitted)
- 18) a copy of the extract from the register of the territorial community with the indicated place of registration;
- **19)** if necessary, a document on recognition of the person by medical authorities social examination by a person with a disability;
- 20) application form for admission to postgraduate studies at the University.
- 2.2 the admission committee verifies the authenticity of the data submitted by the entrant for participation in the competitive selection, using the Unified Database. Written confirmation by the Technical Administrator of the Unified Database that the information submitted by an applicant to a higher educational institution is untrue is grounds for refusal to participate in the competitive selection and enrollment (cancellation of the enrollment order).

## 3. Peculiarities of the organization of admission to postgraduate studies at the International Humanitarian University

- **3.1** In order to carry out the competitive selection for admission to postgraduate studies, the admissions committee organizes the reception of applications and documents, entrance exams, performs the competitive selection of applicants for enrollment.
- **3.2** Persons who have a higher education and a master's or specialist qualification are admitted to postgraduate studies.
- **3.3.**The decision on admission to graduate school entrance exams is made by the admissions committee based on the results of the interview, review of the essay and submitted scientific papers, taking into account the written opinion of the prospective supervisor, about which the applicant to the graduate school is notified within a week.
- **3.4** The schedule of entrance exams is posted on the university's website and at the Admissions Committee's stands, post-graduate students are notified of the date, place and time of entrance exams.
- **3.5**Entrance tests for studying for the degree of Doctor of Philosophy consist of:
- entrance oral exam in the specialty (within the scope of the standard of higher education for a master's degree in the relevant specialty);
- an entrance exam in one of the foreign languages chosen by the entrant (English, German or French) in the form of a comprehensive written test, which consists of three parts and contains a number of tasks of different levels of difficulty, aimed at checking the level of formation of speech and language competence to the extent that corresponds to level B2 of the All-European recommendations on language education. The exam in another foreign language is held according to the decision of the Academic Council of the University in the event that knowledge of this language is necessary for work on the dissertation;
- entrance oral exam in philosophy (in the scope of educational programs forhigher educational institutions);
- a written presentation of research results in the form of a research paper on the chosen specialty, submitted together with the application for admission.
- 3.6 An applicant who has confirmed his level of knowledge, in particular of the English language, with a valid TOEFL test certificate, or International English Language Nesting System, or a Cambridge English Language Assessment certificate, is exempt from taking the entrance exam in a foreign language. When the results of the competition are determined, the specified certificates are equated to the results of the entrance test in the foreign language with the highest score. Entrants who have received a certificate issued by the preparatory department of the University based on the results of a course of preparation for taking an international exam, in particular English language, corresponding to level B2

- All-European recommendations on language education, when enrolling in postgraduate studies, have the first priority for enrollment.
- **3.7.** In accordance with the Admission Rules, additional entrance tests will be assigned to persons entering postgraduate studies from a different field of knowledge (specialty) than that specified in their master's (specialist) diploma.
- **3.8.** Special conditions for participation in the competitive selection for studies for obtaining the degree of Doctor of Philosophy for participation in the competitive selection for studies based on the results of an interview instead of entrance exams and a research proposal are used by:

persons who are participants in hostilities in accordance with the Law of Ukraine "On the status of war veterans, guarantees of their social protection".

**3.9.** The notice of admission to the entrance exams provided by the admissions committee certifies, in accordance with the current legislation of Ukraine, the right of the entrant to graduate school to take additional paid leave at the place of work at the rate of 10 days for each entrance exam.

Travel time in the direct and return direction from the entrant's place of work to the location of the higher educational institution is not included in the leave.

- **3.10** Acceptance of applications and entrance exams for postgraduate studies is carried out by subject commissions, and can be carried out remotely if the applicant is in a dangerous or temporarily occupied territory or abroad.
- **3.11** Programs of entrance tests for admission based on the obtained educational and qualification level are developed and approved by the University before the start of accepting documents. Admission test programs are published on the University's website
- **3.12** The competitive score is calculated as the sum of the results of the entrance exams. Entrance tests are evaluated according to evaluation criteria on a 100-point scale.
- **3.12.**The results of entrance exams for postgraduate studies are valid during the calendar year.
- **3.13** Persons who, without valid reasons, did not appear for the entrance exams at the time specified in the schedule, or their knowledge was assessed as unsatisfactory, are not allowed to take the next entrance exams.

- **3.14** Minimum competitive score with each entrance test is 60 points.
- **3.15** Information on the results of entrance exams is generated in the EDEBO.
- 3.16 Appeals on the results of entrance exams are submitted on the day of the exam or no later than the next business day after the announcement of the entrance exam grade and are considered by the appeal commission no later than the next business day after their submission.
- **3.17** The decision of the admissions committee on admission to postgraduate studies is approved by the order of the head of the University, which is issued in accordance with the established procedure.

#### 4. Financingpersonnel training

- **4.1** For citizens of Ukraine and persons equivalent to them, training in postgraduate studies is carried out at the expense of:
- funds of individuals or legal entities on the terms of the contract for the provision of educational services.
- **4.2** For foreigners, training is carried out on the basis of:
- international treaties of Ukraine;
- national programs;
- contracts concluded by the university with individuals or legal entities, at the expense of individuals or legal entities - on the terms of the contract for the provision of educational services.
- **4.3** The contract with the entrant or the customer regarding training at the expense of individuals and legal entities is concluded after the issuance of the enrollment order. Tuition is paid in accordance with the contract concluded by the parties.

#### 5. Enrollment to postgraduate studies

**5.1.** The order for admission to postgraduate study is issued by the rector of the University based on the decision of the admissions committee. The order on enrollment for studies with their annexes is formed in the EDEBO in accordance with the lists of applicants recommended for enrollment, and is published on the information stand of the admissions committee and the University's website in the form of a list of enrollees.

- **5.2.** The right to priority admission to graduate school:
- In the case of receiving the same number of points, applicants will have priority for admission to graduate school:
- which have scientific publications, participated in Olympiads, competitions, conferences
- who have successfully completed their master's degree with a master's degree with honors
- recommended for admission to postgraduate studies by the Academic Council of ZVO, a scientific institution
- have an international foreign language certificate confirming levels B2 C2.
- **5.3.** The admission commission's decision to enroll an entrant may be revoked by the admission commission in the event of violations of legislation on the part of the entrant, namely the entrant's submission of unreliable personal data, unreliable information about previously acquired education.
- **5.4.** Entrants may be expelled from the postgraduate program of the University at their own request, as a result of which a corresponding order is issued, which is verified by the EDEBO, and the documents submitted by them are returned to such persons no later than the next day after submitting the application for expulsion.
- **5.5**Each post-graduate student is assigned a scientific supervisor, as a rule, a doctor of science or a candidate of science by decision of the Academic Council, at the same time as he is enrolled by the relevant order of the rector. The scientific supervisor supervises the graduate student's work on the dissertation, monitors the implementation of the individual plan and is personally responsible for the high-quality preparation of the dissertation by the graduate student.
- **5.6.** The entrant is notified of admission to postgraduate studies from the day the admissions committee makes the relevant decision.

#### 6. Peculiarities of admission and study to postgraduate studies at the University of Foreigners and Stateless Persons

foreigners and stateless persons", registered with the Ministry of Justice of Ukraine on November 25, 2013 under No. 2004/24536, by order of the Ministry of Education and Science of Ukraine dated December 02, 2019 No. 1498 "On approval of the Procedure for establishing quotas for obtaining higher education by foreigners and stateless persons in within the scope of the state order in accordance with the international treaties of Ukraine", registered with the Ministry of Justice of Ukraine on February 10, 2020 under No. 153/34436.

Citizens of RussiaFederations and the Republic of Belarus, who do not have a permanent (temporary) residence permit in Ukraine, are admitted to study with the individual permission of the Ministry of Education and Science of Ukraine.

- 1) an application addressed to the rector indicating the specialty, form of study (full-time, non-postgraduate or part-time) and appointment of the supervisor;
- 2) statement about admission to drafting introductory exams in graduate school;3)a document certifying identity and citizenship (in accordance with Article 5 of the Law of Ukraine "On Citizenship of Ukraine") and its copy;
- 5)a copy military accountant document (for troops obliged a military ticket or a temporary certificate of a conscript, and for conscripts a certificate of registration at conscription stations) 6) a document (original or notarized) about the previously obtained educational and qualification level of a master (specialist), on the basis of which admission is carried out, and an appendix to it and their copies or a document with attachments (if they are provided) and their copies about the degree (level) of education obtained abroad.

1. Admission to study at the International Humanitarian University of foreigners and stateless persons is carried out in accordance with the Laws of Ukraine

"On higher education", "On the legal status of foreigners and stateless persons", "On Ukrainians abroad", "On refugees and persons in need of additional or temporary protection", "On establishing additional legal and social guarantees for citizens of the Republic of Poland, who are on the territory of Ukraine", by the resolution of the Cabinet of Ministers of Ukraine dated September 12, 2018 No. 729 "Issues of obtaining higher education by certain categories of persons", by order of the Ministry of Education and Science of Ukraine dated November 1, 2013 No. 1541 "Some issues of organizing recruitment and training (internships) foreigners and stateless persons", registered with the Ministry of Justice of Ukraine on November 25, 2013 under

No. 2004/24536, by order of the Ministry of Education and Science of Ukraine dated December 2, 2019 No. 1498 "On approval of the Procedure for establishing quotas for obtaining higher education by foreigners and stateless persons within the scope of the state order in accordance with international treaties of Ukraine", registered with the Ministry of Justice of Ukraine February 10, 2020 under No. 153/34436.

Foreigners and stateless persons (hereinafter referred to as foreigners) may obtain higher education at the expense of individuals and/or legal entities, unless otherwise provided by international treaties of Ukraine, the binding consent of which has been granted by the Verkhovna Rada of Ukraine, legislation or agreements between the International Humanitarian University on international academic mobility.
- 3. Foreigners are admitted to higher education for accredited educational programs. International humanitarian

the university can accept foreigners to study in the programs of the preparatory faculty (subdivision), to study the state language and/or the language of instruction, as well as to obtain postgraduate education, advanced training and internship.

- 4. For the competitive selection for foreigners to study for the degree of junior bachelor, bachelor (master of medical, pharmaceutical or veterinary fields) on the basis of Π3CO and HPK5, the score(s) of entrance exams in Ukrainian language/foreign language, mathematics, mandatory and connected history of Ukraine, biology, physics, chemistry, at the choice of the entrant.
- 5. For the competitive selection of foreigners to study for a degreemaster's degree on the basis of NRK6 and NRK7, the score(s) of: the entrance exam in the professional exam and the entrance exam in a foreign language and the additional professional exam, if entering on the basis of NRK6 or NRK7 in another specialty, are counted.
- 6. Admission of foreigners to study can be carried out face-to-face and/or remotely. Procedures of the admissions committeeMonday through Friday from 9:00 a.m. to 6:00 p.m.; online consultations are possibleget by email-international\_department@ukr.net
- 7. The validity period of an invitation to study is no more than one year from the date of its registration in the Automated System "Electronic Journal" of a state enterprise authorized by the Ministry of Education and Science of Ukraine.

Foreigners who have received can participate in remote reception an invitation to study registered in the Automated System

"Electronic journal" of the state enterprise authorized by the Ministry of Education and Science of Ukraine, received a set of information and consulting support services, and also received a visa for entry into Ukraine (except for citizens of visa-free entry countries) for the purpose of study or carried out the procedure of legalization of documents on education in the country of their issuance: (legalization was carried out in the Ministry of Foreign Affairs (MFA) of the country that issued the education document; legalization was carried out in the consular department of a diplomatic institution of Ukraine abroad (consular legalization or apostille)).

For the organization of remote recruitment of foreign citizens to study for higher education, the International Humanities University operates on the basis of an agreement with a partner organization that is a resident of the country of origin of the entrants. The subject of the agreement is the provision of services for personal identification, verification of original documents of entrants, organization of receiving entrants' applications in electronic form, provision of premises and technical means for conducting consultations and entrance tests by a higher education institution in a remote format.

In the case of remote admission, the foreigner sends legalized and notarized copies of documents on previous education to the International Humanitarian University by mail. When crossing the state border of Ukraine for the first time and after arriving at the University, the foreigner hands over the original documents in person.

- 8. Procedure for accepting applications and documents:
- The University upon the foreigner's prior application with the provision of the following documents:
- a scanned copy/image of the first page of the foreigner's passport, which contains his personal data, as well as the page indicating the receipt of a visa with a Ukrainian translation;
- a scanned copy/image of a document on complete general secondary education with a translation into English/Ukrainian languages; a scanned copy of the appendix to the document on previous education with grades (points) with English/Ukrainian translation or an academic certificate (indicating the number and name of the document) with English/Ukrainian translation;
- power of attorney for receiving the invitation if the entrant does not pick it up in person, legalized or apostilled depending on the country where the power of attorney was issued, the citizenship of the entrant with a translation into English/Russian/Ukrainian languages;
- arrival notification (in case of arrival);
- questionnaire

Receiving an invitation to come to study is also necessary for entrants from countries with a visa-free entry system, and entrants from countries with a visa-free entry systemzdu (unless otherwise provided by the current legislation of Ukraine).

- 9. For admission to the Preparatory Department for Foreign Citizens and for admission to study for a bachelor's degree (master's degree in medicine), foreign citizens and stateless persons submit and complete the following documents:
- admission application;
- questionnaire;

- national passport of a foreigner or other document certifying a stateless person with a D-13 type visa for countries with a visa entry procedure, issued by consular institutions of Ukraine underborder on the basis of invitations to study, unless otherwise stipulated by international treaties of Ukraine (original or copies of translations in Ukrainian with notarization in Ukraine).
- If the entrance exams and enrollment will be conducted remotely, there will be no visa typeD-13, it is necessary to go through the procedurelegalization of documents about education in the country their issues: (done legalization in the Ministry of Foreign Affairs (MFA) of the country that issued the education document; performed legalization in the consular department of a diplomatic institution of Ukraine abroad (consular legalization or apostille)).
- ddocumentabout the obtained educational (educational and qualification) level, on the basis of which the original and 2 copies with a translation into Ukrainian and a notarized certificate in Ukraine are used for admission);
- an addendum to the document on the obtained educational (educational and qualification) level, on the basis of which admission is made (list of subjects studied) (original and 2 copies with translation into Ukrainian and notarized in Ukraine);
- 24 photo cards measuring 3x4 cm;

<u>In the presence</u>the entrant presents the originals and submits copies of the following documents:

- permanent permitresidencein Ukraine, a permit to immigrate to Ukraine, a diplomatic card of the Ministry of Foreign Affairs of Ukraine or another document on the right to stay in Ukraine;
- certificate tax services about appropriation registration numberstaxpayer's registration card.

In the case of remote admission, the foreigner sends legalized and notarized copies of documents on previous education by mail to the university within 1 (one) month.

At the first crossing of the state border of Ukraine and after arrival touniversity, the foreigner submits the originals of documents in person, as well as provides documents for issuing a temporary residence permit in Ukraine.

All documents issued in other countries must be translated into Ukrainian with a notarized translation in Ukraine.

The originals of the passport, residence document and tax service certificate are checked during the submission of documents, upon the student's arrival in Ukraine.

Education documents drawn up abroad must be certified andlegalized in the established manner, unless otherwise stipulated by international treaties of Ukraine.

Other copies of documents are submitted by the entrant in person or provided electronically, if this is caused by special conditions of enrollment in the relevant specialties (educational programs), established by law, within the time limits set for the acceptance of documents, but no later than the time limits established in the Admission Procedure, for the Admissions Committee to make a decision on recommending entrants to enrollment.

For categories of foreign citizens who enter the University based on the results of an external independent assessment (national multi-subject test), when submitting documents, it is necessary to provide a document confirming the status of the person for visa purposes.

10. At the time of admission to training, persons who submit a document on the acquireddegree (level) of education abroad (hereinafter referred to as the Document), the procedure for recognizing and establishing the equivalence of the Document is mandatory, which is carried out in accordance with the order of the Ministry of Education and Science of Ukraine dated May 5, 2015 No. 504 "Some issues of recognition in Ukraine of foreign documents on education", registered in the Ministry of Justice of Ukraine on May 27, 2015 under No. 614/27059. The procedure for preparing a package of documents for conducting recognition of the educational level of the Document for the purpose of continuation training is carried out by the University before the start of the owner's training or during the first month of training. Also, the entrant can independently start the process of recognition of his educational documents and submit a certificate of completion of the recognition procedure to the selection committee of the Preparatory Department for Foreign Citizens.

If available, the entrant provides a copy of the certificate of recognition or a copy of the certificate of application for recognition to the Ministry of Education and Science of Ukraine when submitting documents for study.

The University ensures control over the deadlines for submission of documents by a foreigner for the recognition procedure.

Those who do not pass the procedure of recognition of documents on previous educationforeign citizens and stateless persons who received documents aboutprevious level of education in educational institutions of Ukraine.

11. Acceptance of applications and documents in several stages before and at the beginning of the academic semesters for obtaining the degrees of junior bachelor, bachelor, master, master of medical, pharmaceutical direction with

April 10, 2023 to November 20, 2023, the enrollment period for entrants is from May 18 to November 30, 2023.

Enrollment in the composition of students of the Preparatory Department, for studies to obtain the bachelor's, master's level of higher education in the medical or pharmaceutical field for foreign citizens at the expense of natural (legal) persons andduring the year for study at a graduate school (creative graduate school), at a preparatory department (faculty).

The university calculates the points/grades of the entrant based on the document on the previous level of education and establishes the minimum value of the number of points/grades required for admission in the general education subjects from which the entrance exam for foreigners is held.

Enrollment of foreigners to study at the appropriate level of higher education is carried out on the basis of a document on the previously obtained level of education based on the results of entrance exams for foreigners in specified subjects and the language of study and on the basis of academic rights to continue studying, provided by a document on the obtained level of education in the country of origin, and taking into account the success scores that give the right to continue studying at the next level of higher education in accordance with the legislation of the country that issued the document on the obtained degree (level) of education.

- 12. All categories of foreigners enrolling in studies, are admitted to the International Humanitarian University on the basis of orders for enrollment at the expense of individuals or legal entities. Confirmation of the fact of training can be a certificate issued at the EDEBO.
- 13. Foreigners who are granted state scholarships under international treaties, national programs, and other international obligations of Ukraine are admitted to study within the established quotas for foreigners on the basis of referrals from the Ministry of Education and Science of Ukraine.
- 14. Foreigners who come to Ukraine to participate in academic mobility programs or to obtain higher education according to educational programs agreed between Ukrainian and foreign institutions of higher education,

are accepted on teaching with taking into account contractual obligations relevant institutions of higher education.

15. Foreigners and stateless persons, in particular Ukrainians living abroad permanently in Ukraine, citizens of the Republic of Poland, persons recognized as refugees, and persons in need of additional protection, have the right to obtain higher education on an equal basis with citizens of Ukraine, in particular at the expense of physical funds or legal entities.

Ukrainians living abroad, whose status is certified by a certificate of a Ukrainian living abroad (except for persons permanently residing in Ukraine), may enroll in studies at the expense of individuals or legal entities within the limits of the established quotas for foreigners by taking an entrance exam for foreigners in the subjects provided for in the Admission Rules.
